

## **Federal Contracts/Agreements/Special Use Permits 2019, 2020, 2021, 2022**

### **Coconino County**

#### US Army Corps of Engineers

Cooperation Agreement between United States of America and Coconino County for Emergency Assistance (Flood or Coastal Storm) – July 29, 2021 with Department of the ARMY through the Army Corps of Engineers, Army shall provide feet of “barriers” for pickup from Camp Navajo at a total reimbursement rate of \$2,415.

#### US Dept. of Agriculture

Forest Service- Special Use Permit to operate the Willard Springs Transfer Station – for solid waste transfer site the county operates, approved 5/7/2013 and for a ten-year period (5/19/2023) (Public Works Department)

Forest Service- Special Use Permit to operate for Mormon Lake solid waste transfer site and equipment storage, approved 5/7/13 and for a ten-year period (5/19/2023) (Public Works Department)

Forest Service (Kaibab)- application for transportation and utility systems and facilities on federal lands for secondary access to the Williams Public Works facility site for heavy equipment to accommodate safe and separate traffic flows- access easement and construction of separate entrance. Approved by BOS on 9/24/2019 – no clear termination date (Public Works Dept.)

Forest Service (Kaibab)- Category 6 Major Cost Recovery Agreement regarding Williams PW Maintenance Yard for use and occupancy of forest lands, effective 2019- no term (Public Works)

Forest Service- special use permit for three roadway segments to access the County Williams Recreation Area and the Williams Maintenance Yard, effective 1/7/2020-12/31/2039 (Public Works)

Forest Service- forest development road cooperative agreement for road maintenance on forest roads, effective 1994- (Public Works)

Forest Service (Kaibab)- grant agreement to use remaining RAC funds for another cleanup event spring/summer of 2019, effective until 2019 (Public Works)

Forest Service (Coconino, Apache-Sitgreaves, Kaibab)- cooperative law enforcement operating Plan and Financial Plan, executed June 7, 2017 also for 2020, 2021, 2022. (Sheriff’s Office)

Forest Service (Apache-Sitgreaves, Coconino & Kaibab)- cooperative law enforcement agreement regarding activities on NFS lands and providing reimbursement. Effective 2017 – Dec. 31, 2021 & Jan. 2022- Dec. 31, 2026 (Sheriff’s Office)

Forest Service (Coconino)- Memorandum of Understanding regarding law enforcement officers’ cross-certification by the Sheriff’s Office, effective Dec 2018 – Dec 2023. (Sheriff’s Office)

Forest Service (Apache-Sitgreaves, Coconino, Kaibab, Prescott)- MOU with Sheriff's Office in relation to search and rescue operations and law enforcement operations involving serious crime or fugitive pursuit. Executed June 21, 2010 through Jan 31, 2020 (Sheriff's Office)

Forest Service (Apache-Sitgreaves, Coconino, Kaibab and Tonto)- MOU between 4 Forest Restoration Initiative (4FRI) Collaborative Stakeholder Group Representatives, working together for landscape scale forest restoration, effective in 2011- no expiration but reviewed every 5 years

Forest Service (Coconino)- Good Neighbor Agreement with **County Flood Control District** regarding the Museum Fire Sediment Reduction Project – forest, rangeland and watershed restoration services -Forest Service funding of \$3.5 million – Jan 2022-in effect until terminated

Forest Service- special use permit with the **County Flood Control District** for flood control structures in the Museum Fire area, effective through 12/31/2025

Natural Resources Conservation Service- FCD Resolution 2021-02 authorizing the application for and acceptance of financial assistance in the amount of \$606,328 of which 75% funded by NRCS and 25% funded by **Coconino County Flood Control District** for emergency flood mitigation measures in the Mt. Elden Estates area

Natural Resources Conservation Service- **Flood Control District** Resolution 2020-02 authorizing submission of an application to NRCS for funding for flood mitigation project in the Mount Elden Estates area, effective

USDA Rural Development- Rural Business Cooperative Service Financial Assistance Agreement (\$80,000) - from federal funds for Railway Access Plan for industry at Camp Navajo, 7/26/21-9/30/2022

Encroachment Protection Agreement with County Arizona Board of Regents (NAU), Trust for Public Lands- concerns identification and purchase of long-term interests in multiple parcels of land to prevent encroachment and stop incompatible development in the vicinity of the Naval Observatory Flagstaff Station, effective 2015-2020, Resolution 2020-56 (Community Development)

Agreement for the Management of Natural Resources on the Miller Property between the United States of America and Coconino County, Navy paying \$516,842 for cost of natural resource management, Resolution 2020-61, effective Aug. 2020

US Geological Survey- joint funding agreement for Water Resource Investigations, for operating, maintaining and producing stage/discharge data for Cataract Creek at Redlands Crossing by the USGS, USGS COOP funds pay \$8,700 and County pays \$8,700, effective 2018-2019 (Public Works)

US Geological Survey- IGA for the operation and maintenance of a streamflow gage on Cataract Creek which provides early flood warning to the village of Supai, which total **County Flood Control District** contribution of \$47,795, FCD Resolution 2020-03. (Public Works)

National Park Service - MOU with Sheriff's Office for law enforcement mutual assistance, effective 1/1/2021-12/31/2022. (Sheriff's Office)

Nation Park Service- special use permit for operation of a public library, effective 12/11/2013-12/11/2018 and automatically renewed for an additional 5 year term

Bureau of Indian Affairs, Navajo Region- provide road maintenance service on the BIA road system, effective May 7, 2019 – Sept. 30, 2024?, including grant and cooperative agreement 2019, 2020 (Public Works Dept)

Glen Canyon National Recreation Area- MOU for proprietary criminal jurisdiction with Sheriff to enforce laws within the Glen Canyon National Recreation Area, effective 6/4/19-6/4/2024.

#### Federal Highway Administration

Federal Highway Administration- Federal Lands Highway Funds Transfer Agreement, County providing \$10,000 for Perkinsville Road to meet matching requirements & MOA with the U.S. Forest Service to conduct a scoping trip and prepare project development plan through the federal lands access program funds for Perkinsville Road Pavement Rehabilitation and Widening, Resolution 2020-19, effective 2020

#### US Immigration and Customs

MOU regarding Homeland Security Investigations with Sheriff's Office – designating Sheriff's Office employees as customs officers, effective 4/26/2021 – terminated upon notice
