**Steve Ellis** is Chair of the *National Association of Forest Service Retirees*. He began his 38-year federal career in the 1970s on the Shawnee National Forest in southern Illinois, where he also worked with the North Central Forest Experiment Station on fine hardwoods genetics projects. Steve worked for both the Forest Service and the Bureau of Land Management during his almost four decades of federal service. His natural resources career has taken him to duty stations in Illinois, Idaho, Nevada, Oregon, and Alaska, as well as two tours in Washington DC. During his first DC tour, he served 14 months as a Legislative Fellow in the US Senate. Steve retired in December 2016 from the top career position in BLM (Deputy Director, Operations).

Steve has extensive field line officer, as well as wildfire experience (once carded as Incident Commander Type 3). He was part of contingent that spent time in both Australia and South Africa examining and discussing bushfire management challenges. He presented papers at two international wildfire symposiums during his career.

Steve holds a B.S. in Forestry from Southern Illinois University at Carbondale as a well as a M.S. in Geographic and Atmospheric Science from Northern Illinois University where he taught undergraduate atmospheric science for two years. Since retirement, Steve also served as president of the Pacific Northwest Forest Service Association. He is a member of the Society of American Foresters.

Steve and his wife Linda, a retired family nurse practitioner, were high school sweethearts. They raised three children and are "Gold Star" parents. Their daughter Jessica, a highly decorated combat medic with the 101<sup>st</sup> Airborne Division and former wildland firefighter with the US Forest Service, was killed in action in the Iraq war. They have five grandchildren and make their home on wooded acreage in rural Clackamas County, Oregon.
