## A BILL

To authorize the National Medal of Honor Museum Foundation to establish a commemorative work on the National Mall to honor the extraordinary acts of valor, selfless service, and sacrifice displayed by Medal of Honor recipients.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Hershel ‘Woody’ Wil-  
5       liams National Medal of Honor Monument Location Act”.

1   **SEC. 2. FINDINGS.**

2       Congress finds the following:

3               (1) Congress in 2021 unanimously passed, and  
4       the President signed, Public Law 117–80 (40 U.S.C.  
5       8903 note), which authorized the National Medal of  
6       Honor Museum Foundation to establish on Federal  
7       land in the District of Columbia a commemorative  
8       work to honor the acts of valor, selfless service, and  
9       sacrifice displayed by Medal of Honor recipients.

10              (2) The Medal of Honor was established by  
11       President Abraham Lincoln and first awarded 160  
12       years ago on March 25, 1863, and is part of Lin-  
13       coln's lasting and living legacy.

14              (3) In 1991, during the administration of Presi-  
15       dent George H.W. Bush, this legacy was extended  
16       further when National Medal of Honor Day was es-  
17       tablished as March 25th of each year.

18              (4) The Medal of Honor is awarded to all  
19       branches of the United States Armed Forces as our  
20       nation's highest recognition for valor in combat.

21              (5) The number of living Medal of Honor re-  
22       cipients has been steadily declining, making it even  
23       more crucial to honor and recognize their heroic sac-  
24       rifices and inspire future generations.

1                         (6) Hershel “Woody” Williams, the last World  
2                         War II Medal of Honor recipient, passed away in  
3                         2022 and laid in honor at the United States Capitol.

4                         (7) The Medal of Honor represents the very  
5                         best of our Nation—ordinary citizens, who took ex-  
6                         traordinary action above and beyond the call of duty  
7                         and became heroes of our Republic.

8                         (8) These examples inspire all citizens and ig-  
9                         nite within us the very spirit of America.

10                         (9) The Medal of Honor rises to the level of su-  
11                         preme national and historical importance necessary  
12                         to warrant representation on the National Mall.

13 **SEC. 3. NATIONAL MEDAL OF HONOR MONUMENT LOCA-**  
14 **TION.**

15                         Section 1 of Public Law 117–80 (40 U.S.C. 8903  
16 note) is amended—

17                         (1) in subsection (b), by striking “The estab-  
18                         lishment” and inserting “Except as provided in sub-  
19                         section (e), the establishment”; and

20                         (2) by adding at the end the following:

21                         “(e) LOCATION.—Notwithstanding section 8908(e) of  
22 title 40, United States Code, the commemorative work es-  
23 tablished under this section shall be located—

24                         “(1) within the Reserve (as defined in section  
25 8902 of title 40, United States Code); and

1           “(2) attached to, or not more than 1,000 feet  
2         from, the Lincoln Memorial, as a respectful exten-  
3         sion of his enduring legacy and recognition of what  
4         ordinary people can accomplish when working for  
5         the greater good.”.
