### **Opening Statement**

Good Afternoon Chairman (Bruce) Westerman, Ranking Member (Raul) M. Grijalva and the Honorable members of this subcommittee. On behalf the citizens of Cochise County and the State of Arizona, and my fellow Sheriffs, Thank You for having me.

I have served our border communities for 40 years and prior to that, as a member of our military serving in the U.S. Army stationed at Fort Huachuca located within Cochise County. I have always been a genuine believer in my Oath of Office to protect my Country, and now my County as the duly elected Sheriff for the past 12 years. I am the past-President of the Arizona Sheriffs Association, Chair of the National Sheriffs Association Border Security, the Executive Board for Western States Sheriffs and past leadership positions with the Southwest Border Sheriffs.

All these associations share 3-Objectives:

### Public Safety, National Security and Humanitarian.

In my submitted brief, I have shared with you all an overview of Cochise County and the history of our border. I have personally experienced the good, the bad and the ugly of being a border county. My office has always addressed border-related crimes, smuggling of both illicit drugs, humans, weapons and cash by our Transnational Organizations i.e. Criminal Cartels.

I am proud of our relationships with all our law enforcement partners that serve our communities.

To begin, I want to "Thank" our Customs & Border Patrol Officers and Agents who have worked tirelessly and diligently to protect this great nation. I want to "Thank" our Governors; Ducey and Hobbs and our State Congressional Members for all their support. The men and women of the Cochise County Sheriff's Office for their dedication and commitment in keeping our communities safe. To all my fellow Sheriffs that stand united for the Rule of Law in the protection of their communities. And, finally, I want to "Thank" my citizens for their patience and support in a time of crisis and disarray.

To best understand my presentation is to understand where we were over 3 years ago. My county was one on the safest border counties based on our collective governmental efforts, prioritization, messaging and yes, enforcement efforts supported by the Rule of Law.

### The direct impact to my county/office:

My citizens and law enforcement address mostly Got-Aways "Fight & Flight" in my County versus those giving up.

100% Camouflaged migrants being illegally smuggled by the Cartels, price tag per UDA begins at \$7000 and up.

These smugglers include juveniles being recruited via social media by the Criminal Cartels.

Border Related Booking (Detention) Costs over the last 24 months is \$9.4 million, absorbed by my local and state taxpayers.

### Border-related Crime at an all-time high:

Death/Murder investigations, Illicit Drug Poisonings, Aggravated acts against my citizens, Failure to Yields, Search and Rescue/Recovery and yes, assaults against law enforcement officials.

My deputies/law enforcement continue to be placed in life-threatening scenarios as the Cartels shows no regard for my citizens and/or those that wear a badge.

Agents, Troopers, Deputies and Officers are addressing dangerous scenarios/criminals as a direct result of an "Open Border" exploited by these criminal cartels for Violence, Fear and Greed.

Cochise County Sheriff's Office Detention Bookings related to Border:

In calendar years 2022/2023: 2884 Suspects booked into my jail for border-related crimes.

566 Smugglers (state law violation)

414 Failure to Yields 154 Non-Citizens

\$9.4 Million Cost to local/state

Fentanyl continues to poison/kill Americans at an alarming rate leaving families and communities devasted. Arizona efforts by law enforcement are remarkable, but the War on Drugs must be a priority topic and not deserted by political rhetoric. Arizona fentanyl seizures accounts for 51% of all the fentanyl seized in the country. In federal fiscal year 2022 Arizona seized over 60 million Fentanyl pills. The 4-Arizona border counties seized 35 million Fentanyl pills with an anticipated increase for 2023 Federal fiscal year.

In closing, my fellow Sheriffs and I have tried to partner with this administration to include the President of the United States with high hopes to share a Collective Message, Collective Action Plan, Support the Rule of Law, Prioritize our southern border and provide updates reference Community Impacts and Concerns with little to no success.

By allowing our border security mission and immigration laws to be discretionary, these Criminal Cartels continue to be the true winners, their exploitation of mankind is simply "Modern Day Slavery"; allowing thousands of pounds of illicit drugs into our country that continue to erode the core-values of families, schools and subsequently killing Americans on an average of 290 every day is completely unacceptable at any level. Experiencing migrant deaths without a reasonable process while members of our U.S. Congress and this Administration intentionally avoids reality is gross negligence.

Our voice of reason has been buried during what I call an "Intellectual Avoidance" by this Administration and yes, members of U.S. Congress. Communities have been neglected and abandoned relying on our own local and state resources to address a border that is in crisis mode.

Our southern border, against all public well-designed statements out of Washington D.C. is in the worst shape I have ever seen it. When one looks at Public Safety, National Security, and Humanitarian, our southern border is the largest crime scene in the country.

The morale of agents is extremely low, and the collective frustration is very high amongst law enforcement at all levels and most important, our citizens.

I am a true believer that Customs and Border Patrol are the experts of Border Security while Sheriffs and Police Chiefs are the experts of community, together, this is a Recipe of Success for all communities!

I will leave you with this final statement, we all serve the priorities of Americans based on our shared Oaths of Office to keep them Safe, enhance their Quality of Life and Support the Rule of Law absent political affiliation or the concern of reelection; I ask each one of you to reflect on this statement as you make your next decision to vote.

### Introduction

Testimony of Mr. Mark J. Dannels, Cochise County Sheriff, Arizona before the United States House of Representatives Subcommittee on Federal Lands reference a scheduled hearing on "Biden's Border Crisis: The Consequences of Failing to Secure Federal Border Lands." The hearing will be held on Thursday, February 8<sup>th</sup>, 2024, at 1:30 p.m. at the Cochise College, 901 Colombo Avenue, Sierra Vista, Arizona 85635.

Chairman Bruce Westerman, Ranking Member Raul M. Grijalva and Distinguished Members of this Committee, thank you for the invitation to speak to you today on this very important subject reference: Public Safety, National Security, and Humanitarian and the impact to our Federal Lands.

### **History of Cochise County**

With eighty-three miles of international border within its jurisdiction, Cochise County plays a significant role in combating drug and human trafficking organizations and the associated violent crime which adversely affects Arizona residents and other areas throughout the United States. In 1990 the Office of National Drug Control Policy (ONDCP) designated Cochise County as a High Intensity Drug Trafficking area within southern Arizona. This designation is a direct result of overwhelming and sustained levels of illicit drug and human trafficking within Cochise County.

With 6,219 square miles, Cochise County is as large as the states of Rhode Island and Connecticut combined. The estimated population of the county in 2022 is approximately 125,000. The geography of the county consists of seven incorporated cities to include the historical town of Tombstone. Surrounded by vast areas of desolate uninhabited desert and mountainous terrain, the seven cities only represent a combined area of 215 square miles, leaving 6004 square miles of unincorporated area. These desolate areas are routinely exploited for smuggling routes by the drug/human traffickers and pose one of the greatest challenges to local law enforcements effort in establishing border security and interdiction efforts. Cochise County is the 38<sup>th</sup> largest land mass county in the United States, and is home to the United States Army base, Fort Huachuca. Throughout the history of the county ranching and farming has played a significant part in its legacy.

Unlike other border counties in Arizona, Cochise County is unique in that there are two cities in the Republic of Mexico situated on the international border within the county. The cities of Agua Prieta and Naco, with an estimated population of 80,000 and 10,000 respectively, are well

know to U.S. Law Enforcement officials as staging and operational centers for one of Mexico's largest and most notorious drug cartels. The Sinaloa Cartel has long employed the use of local Mexican Drug and Human Trafficking Organizations (DTOs) to carry out the Cartel's illegal distribution and transportation of illicit drugs and humans into and throughout the United States.

These international DTOs also utilize their established smuggling routes in Cochise County to transport the Cartels illicit profits such as U.S. currency, firearms, and ammunition into Mexico. A large portion of the profit is used to sustain control over the corridor through the use of violence against law enforcement, rival trafficking organizations, and bribes of government officials.

The Mexican drug trafficking organizations operating in Cochise County are highly sophisticated and innovative in their transportation methods. Aside from the normal use of human backpackers (mules), clandestine tunnels, and vehicles, the trafficking organizations have resorted to the use of ultra light aircraft which cannot be detected by normal radar, cloned vehicles appearing to be law enforcement or other legitimate companies and the use of catapults which hurl bundles of marijuana into the U.S. to awaiting co-conspirators. The organizations utilize sophisticated and technical communications and counter surveillance equipment to counter law enforcements interdiction tactics and strategies. Scouts or observers are strategically placed along smuggling routes to perform counter surveillance on law enforcement and report their observations to those controlling the drug/human smuggling operation so they may avoid and elude law enforcement. The use of cell phones and sophisticated two-way radio encryptions for communications are standard equipment, as are night vision and forward looking infra-red devices.

Violence against innocent citizens, public officials, law enforcement, and rival drug/human trafficking groups in Mexico continues to escalate. Cochise County's law enforcement and private citizen fears of it spilling into the county were realized in 2010 when a longtime Cochise County resident rancher was senselessly murdered while inspecting fences on his ranch. Further complicating the concerns is the potential for foreign terrorist to employ drug/human trafficking organizations to smuggle individuals and or weapons of mass destruction into the United States through Cochise County.

The adverse affects of the drug and human trafficking organizations operating in Cochise County not only have significantly diminished the quality of life of county residents, but also placed unbearable strain upon the budgets and resources of private and government agencies in the county.

Historically speaking, illegal border crossings into the United States are well known in southern Arizona and recognized as a part of everyday life within Cochise County and throughout the southwest border. Many years ago, Cochise County citizens were not overly alarmed when they observed a handful of undocumented aliens travelling through private or public lands in search of jobs. Unfortunately, over time these groups dramatically increased in size and became more reckless, aggressive, and violent, bringing unrest and fear to the citizens living on the border. Examples of this include reckless high-speed pursuits, assaults on citizens, rapes, kidnappings, murders, and home invasions to steal one's private and personal possessions. It was apparent the search for the American dream was being over-shadowed by these smugglers, mules, coyotes, bandits, and transnational criminals preying upon our citizens and country.

Having the true-life experience to live and work as a law enforcement officer/deputy and now Sheriff in Cochise County since 1984, it has been an educational lesson for me reference border security. I have witnessed the escalation of violence by these careless assailants on our citizens raising the question, who actually controls our borders? Cochise County has become known as the gateway to illegal activity for those unlawfully entering the United States.

### History: Federal Government's Border Security Plan of the 90s

In the early 1990s, the federal government prepared a plan to address the unsecure, unsafe border. At a press conference in Tucson, Arizona, a Border Patrol spokesman announced their intent to secure the populated areas of the border, specifically San Diego, Yuma and El Paso and the International Ports of Entry. These targeted areas, which I call the "Ps = Ports and Population", would be the federal government's focus points. The second half of their plan was to reroute the illegal activity/disturbances into the rural parts of the southwest border with the thought that these cartel organizations and smuggling groups would be deterred by the rugged and mountainous regions along the border.

Since the release of the plan, many changes have taken place. Specifically, Cochise County initially increased their staffing of Border Patrol agents to a sufficient number for the threat at that time. Over the last few years, it has again decreased from a significant force to a scant number within Cochise County to secure and protect the 83 miles of international border. Infrastructure, such as metal fencing, lightning, cameras, sensors, radars, etc. have been installed between both ports and some distance beyond bringing some needed relief to this area and those that live within. Unfortunately, upgrades were halted by President Biden's executive order on his first day of office leaving our border's infrastructure in disarray. Secondary immigration checkpoints were established on routes (roadways) 20 – 40 miles north of the border but due to staffing shortages, remains closed most of the time.

Over the last several years, our southern border has drastically changed for the worse. I have personally experienced our once manageable border become a crisis over the last 36 months supported by the attached statistics and increased criminal activity. The Covid health pandemic placed many restrictions on foreign travel, but the conversation regarding illegal entry at our southern border was neglected by our federal leaders. The health exposure and risk experienced by law enforcement officers, deputies and agents became secondary in public restrictions and concerns. In fact, the intellectual avoidance by this administration to actively engage and support our efforts has been absent. Certain members of U.S. Congress continue to ignore our immigration laws/crisis abandoning communities as they struggle to address these challenges. I would remind my fellow elected leaders, we share the same Oath of Office to protect this great country, not to be driven by personal ideologies, but by and for the People.

Sheriffs throughout the country have worked tirelessly to engage and provide solutions, (i.e. a 16-point action plan prepared by America's Sheriffs) with Homeland Security Secretary Mayorkas with no success. As a result, the membership of Western States Sheriffs Association issued a Position statement of NO Confidence against Secretary Mayorkas and Vice President Harris.

The existing border plan has been in place for approximately 30 years and the following are some thoughts regarding the plan in current time:

- An increase in illegal smuggling/activity/illicit drugs between the protected areas (ports)
- Increase in larger groups of undocumented aliens between the protected areas (ports)
- Increase in illegal activity outside the protected areas (ports)
- Fear/Frustration increased in rural Cochise County/Southwest Border
- · Ranch and Farmlands damaged due to increased illegal activity
- Property (fencing, livestock, waterlines, etc.) damaged
- Burglaries/Thefts increased in rural Cochise County/Southwest Border
- Social Media has become a venue for smuggling recruitment mainly focused on juveniles
- Violent Crimes increased i.e., Homicides, Assaults, Rapes, Drug and Human Smuggling, etc. in rural Cochise County/Southwest Border
- Transnational Cartels/Smuggling Organizations controlled and set up smuggling routes in rural Cochise County/Southwest Border
- Lack of Border Patrol Agents directly on border due to administrative processing assignments
- Secondary checkpoints were established as a secondary deterrent but remain closed the majority of the time due to staff shortages
- Lack of Re-Definition to the plan of the 90s (time erased history)
- Loss of recreational land use due to fear of criminal activity
- · Economic decline
- Legacy Ranches being sold
- Lack of Federally elected leaders to address unsecure border/fears creating a lack of trust and anger by citizens
- Questionable/Absent consequences by our federal government by those committing border crimes
- Undue pressure on local law enforcement/Sheriffs/Community Leaders to address issues, fear, and consequences for those committing crimes
- Lack of funding for local law enforcement/criminal justice system/corrections in order to address border crimes at the local level due to federal government lack of intervention
- Border Security shall be a Mandate, not a Discretionary program
- Border Security v. Immigration Reform (two different programs not to be blended)
- Lack of Trust and Confidence in our Federal Government

### Action-Based Solutions Local-State Government

Local Solutions and Programs are no longer a thought, but a reality for bringing relief to our citizens who consciously choose to live near our borders. No better example of the importance of local law enforcement during a national crisis was the terrorist attack on September 11, 2001. First responders from local police and fire were the first on scene to address this horrific threat. Local law enforcement is best suited to best understand community needs and solutions based on the expectations of their citizens. Community policing begins and succeeds at the local level first.

As the Sheriff of Cochise County, I embrace my elected and statutory duty (oath of office to support the United States Constitution and the Arizona Constitution) to protect and secure the Freedoms and Liberties of my citizens, with or without the help of our federal law enforcement partners/policy makers. No longer a debate by those that live in the rural parts of the southwest border, the rural parts of the Southwest Border are NOT secure and are vulnerable for ALL types of transnational criminal activity.

Working with limited budgets and staffing, Sheriffs along the southwest border struggle each and every day to find ways to enhance the quality of life/safety for those they serve and bring a general sense of deterrence for those choosing our border as a venue to promote their criminal enterprises. The following bullet points are action-driven solutions implemented in hopes of bringing some relief and sense of security for those living in Cochise County:

- Balanced Community Policing (Education, Prevention, Enforcement)
- Transparency + Time = Community Trust
- Collaborated Efforts by all 3-levels of Government
- Creation of a Southwest Border Security Facility in Cochise County
- Law and Order Partnership between Sheriff and County Attorney
- Safe Street Enforcement Programs
- Private and Public Funding donations/grants to purchase upgraded equipment/communications
- Installation of New Radios/Towers/Consoles/Microwave
- Portable Radios to Citizens/Ranchers/Farmers/Schools
- Interoperability/Intelligence Sharing at all 3-levels
- Regional Application for Law Enforcement
- · Financial Interdiction Unit
- Regional Border Team by Sheriff supported by Border Patrol, ICE, U.S. Forest
- Ranch Advisory Team
- Ranch Patrol
- Financial Crime Unit
- Consequence Driven Prosecution (all 3-levels)
- Virtual Cameras, Sensors, ATVs, Thermal Vehicle, Off-Road Vehicle, etc..
- Factual Situational Awareness for Media, Elected Officials, America
- Quarterly Law Enforcement Leadership Meetings
- Community Outreach Unit
- Community Meet & Greets within Communities
- Aviation Program (Helicopter & Drone)
- Positive-Interactive Use of Media and Social Medial

### **Recommendations Federal Government**

The Federal Government (elected and policy makers) has been slow to react to the voices and concerns of those living on the southwest border. Cochise County and other counties along the border have become VIP attractions, venues for those seeking to make a difference or promising change only to become another community-public safety disappointment.

The following comprehensive recommendations are directly linked to our federal leaders:

- Collective Message between Local, State and Federal
- Shared Action Plans by Local, State and Federal Law Enforcement
- Remove "Politics" and Enforce the "Rule of Law"
- Hire more Immigration and Asylum Hearing Officers for all POEs.
- Re-evaluate the plan of the 90s and build upon successes
- Political-Will required to make Border Security a Mandated Program
- Immediate need to address the Criminal Cartels (Transnational Organizations)
- Border Security First, Immigration Reform Second
- Maximize Allocated Resources such as Staffing
- Adequately Fund CBP
- Support and Embrace First-line Agents that work the border regions, they have a
  dangerous job and it's no secret that their frustration is high based on the
  unknown complexities reference their assignments, they have great ideas to share
- Secondary Checkpoints only after Primary border interdiction is satisfied by stakeholders
- Quality in Life/Citizens living on border supported by Sheriffs and State Governors regarding improved security/safety
- Funding supplement for Local Law Enforcement/Prosecution/Detention/Criminal Justice in support of border crimes
- Continued Funding and Support for Stone Garden Program
- Empowerment with action to Border Patrol Leadership/PAICs (currently Cochise County has dedicated and solution-driven leaders that work well with local law enforcement)
- Enhanced Funding for Regional Communication and Interoperability with local law enforcement
- Bring Local Law Enforcement to Border Security and Immigration discussions

### Summary

Our local efforts have proven to be very beneficial in bringing over-due solutions to an unsecure border that has become a discretionary program by those federally elected leaders and policy makers that have been entrusted to protect our freedoms and liberties. As a Sheriff elected by the good people of my county, my biggest fear is another loss of life to one of my citizens and/or law enforcement officers/agents contributed to a border that is NOT secure. One would hope the priority of securing our border doesn't become just about a price tag and/or political posturing, but rather the legal and moral requirement to safeguard all of America, which so many heroic Americans have already paid the ultimate price for.

Today's opportunity to address this group instills fresh hope that our voice does matter and on behalf of the citizens of Cochise County, Arizona, our nation's Sheriffs and beyond, we hope you won't forget us and will do your Constitutional mandate to bring positive change to an over-due vulnerable situation.

I will leave each one of you with an open invitation to visit Cochise County along with a personal-guided tour and visit with our citizens to hear/see first-hand America's true rural border.

### 2024 Annual Message

As I enter my 40<sup>th</sup> year in law enforcement, I continue to ask, where did the time go. I reflect back to 1984 when I entered the law enforcement profession. I distinctly recall how excited I was to wear the badge and serve my community. That emotional feeling continues today. Many ask me what my future holds. This year's annual message will highlight my 4-decade blessed career invested with passion, dedication, and my future plans.

The career passage of endless opportunities is a figure of speech many have heard, but how many have practiced. ### SITUATION REPORT FOR BORDER RELATED ISSUES IN COCHISE COUNTY. Calendar Year 2022

### Border Related Criminal Activity investigated by SABRE and CIT in 2022:

- 1) 66,620 Undocumented Aliens detected on SABRE Cameras.
- 2) Approximately 25,500 Undocumented Aliens physically apprehended (SABRE joint apprehensions).
- 3) 109.74 pounds of methamphetamine.
- 4) Over 1500 smugglers arrive in Cochise County every month to smuggle migrants from the border at a price of over \$2,500 per person.
- 5) Investigated 1,306 human smuggling events.
- 6) Investigated 882 human smugglers.
- 7) Detained 89 juvenile smugglers.
- 8) Arrested 232 smugglers for failure to yield incidents.
- 9) Seized 40 weapons.
- 10) Investigated incidents in which 601 people were feloniously victimized.
- 11) Detained 3049 undocumented aliens (Safe Streets/CIT direct apprehensions).

### Detention related statistics.

 1) 1578 inmates were booked into CCSO Detention in 2022 for a border related crime. Of those, 1500 were United States Citizens.

### SABRE Overview:

AZDEMA Grant Award: \$18 million dollars.

The Southern Arizona Border Region Enforcement Team is comprised of CCSO Deputies, United States Border Patrol Agents, and the Arizona National Guard. Nearly 900 cameras have been placed onto smuggling corridors across southern Arizona and New Mexico. 50 of which have been turned over to Fort Huachuca for use.

To ensure the future of the SABRE program, CCSO has been awarded an agreement from AZDEMA for over \$18 million dollars. This funding will fully fund SABRE for a period of five (5) years. This includes six (6) Sworn LEO positions, a (1) Public Information Officer, an (1) Intel Analyst, two (2) IT specialists, four (4) camera maintenance personnel, twenty (20) camera monitors, and (2) camera monitor supervisors.

### Criminal Interdiction Team;

AZDEMA Grant Award: 3.7 million dollars.

A six-person team responsible for smuggling and trafficking interdiction throughout the County. This team will be fully funded for a period of four years. This will be done by conducting close patrol of smuggling corridors through a high volume of traffic stops in these areas. They respond to calls for service from USBP and patrol units dealing with illegal trafficking or smuggling whether human or drug related. The unit may also work with United States Customs Enforcement at the Ports of Entry in Cochise County to help support northbound and southbound operations.

### Cochise County Aviation Program.

AZDEMA Grant Award: \$9,069,000

This program is funded for a period of five (5) years and will cover all associated costs to fund a helicopter program. This helicopter will be stationed at the Sierra Vista Airport, be available twenty-four (24) hours a day, seven (7) days a week. The helicopter will be outfitted with the most technologically advanced cameras and night vision equipment available.

### **Pursuit Termination Vehicles.**

AZDEMA Grant Award: \$1,947,500.00

This program funds the purchase of fifteen (15) Pursuit Termination Vehicles with all associated training and equipment. These vehicles will be customized with special bumpers to help immobilize fleeing vehicles and bring deadly pursuits to a conclusion.

### **Next Generation Radios.**

AZDEMA Grant Award: \$6 million dollars.

This agreement funds the purchase of five hundred (500) next generation radios. These radios will be issued to every first responder (Law Enforcement, Fire, and EMS) in Cochise County. This allows for reliable communication between all governmental entities.

### SABRE Equipment.

AZDEMA Grant Award: \$1,775,000.

In 2021 (before the above SABRE grant), we received \$1,775,000 to fund the purchase of buckeye game trail cameras, artificial intelligence software, and four drones.

### Incarceration and Prosecution Costs.

AZDEMA Grant Award: \$7,305,000

In 2021, CCSO acquired funding to cover the incarceration and prosecution costs for persons charged with a border related crime. Roughly 40% of inmates incarcerated are in-custody due to border related offense.

### Dispatch Equipment.

AZDEMA Grant Award: \$250,000

This award will fund the purchase of two (2) reserve ORNI dispatch consoles to be used as backup dispatch services should something occur to the primary system.

### Cochise County Mental Health Support Team.

Grant from the Legacy Foundation of Southeastern Arizona: \$1.3 million dollars.

This grant funds the Mental Health Support Team for a period of three (3) years. The team is comprised of three (3) licensed behavioral health professionals and one (1) Behavioral Health Technician who respond to members of the community who are experiencing a mental health crisis. Additionally, they take a proactive approach in connecting mentally ill persons with available programs and services.

### **Opioid Settlement.**

Arizona Attorney General's Office grant: \$250,000.

This grant funds the purchase of a community outreach vehicle, overtime for issues dealing with opioids, and money for educating the community about opioids.

### Southeast AZ Combined Intelligence and Border Operations Center.

Arizona DPS/Border Strike Force Funds: \$5 million dollars.

Funds the purchase and renovation of a building to enhance law enforcement services concerning the activities of criminal syndicates, drug and human smuggling organizations and transnational threats related to the US/Mexico border with Cochise County.

### Cochise County Sheriff's Office Multi-Tier Border Operational Plan

Of the 15 counties in the State of Arizona, four (4) of those counties are on the international border with Mexico. Cochise County is responsible for 83 miles of that border with federal, state, and local partners. Cochise County Sheriff's Office has developed special units to combat border related crimes/activities emphasizing on local level participation and enforcement.

### Southern Arizona Combined Intelligence and Border Operations Center

The center serves as a local hub for intelligence capabilities, enforcement operations, and information sharing of border related activities among local, state, and federal law enforcement agencies. The Operation Center is a place for Deputies, Police Officers, State Troopers and Federal Agents to interact and prepare border operations to combat unlawful border crossers and criminal elements. The Operations Center will host the Southern Arizona Region Enforcement Virtual Camera System, Intelligence Gathering for State, Local and Federal Agencies, Criminal Interdiction Safe Street Enforcement Activities, License Plate Readers (LPR) Intelligence, and Human Trafficking Investigations.

The Border Operation Center will allow future expansions with National Sheriff's Association, Western State Sheriff's Association, Southwest Border Sheriff's Association, Major Counties Sheriff's Association, and International Association of Chiefs of Police.

### Southern Arizona Region Enforcement (SABRE)

The Southeast Arizona Border Region Enforcement (SABRE) is a multi-agency task force targeting narcotics and human smuggling operations. SABRE has been very successful using approximately 900 surveillance/camera systems strategically placed along the US/Mexico Border to detect illegal crossing, narcotic smuggling, and identifying open areas which allow illegal activity to come into United States via the southern border. SABRE works closely with other state and federal law enforcement agencies to successfully prepare and investigate cases for appropriate legal action and resolution. Due to changes in border policies, Cochise County is seeing an uncontrollable influx of unlawful border crossers. Calls for service reference Border Patrol assists have increased in the last several months regarding trespassers and suspicious activity.

Current SABRE statistical data for US/Mexico Border Operations is: Undocumented Aliens – 139,917 Drug Smuggling Mules – 442 Marijuana Seized – 12,040.77 LBS Meth Seized – 199.02 LBS Fentanyl – 24.14 LBS Cocaine – 8.70 LBS

### Criminal Interdiction Team (CIT)

CIT is responsible for trafficking interdiction in Cochise County Arizona. This is done by conducting close patrol of known areas (corridors) of trafficking, through interstate and state highway interdiction, and through a high volume of traffic stops in these areas. CIT utilizes social meeting to interdict human and narcotic load drivers and pick up locations. The unit also responds to calls for service where assistance is needed from USBP and or patrol units dealing with illegal trafficking whether human or drug related. The unit also is responsible for assisting with calls, such as burglaries or suspicious activities where suspected Undocumented Aliens may be responsible. The unit also works with United States Customs Enforcement at the Ports of Entry in Cochise County to help support northbound and southbound screenings for any illegal activity.

### Street and Financial Crimes (SCU and FCU)

In Cochise County, the 83 miles of the international border shared by the U.S. and Mexico has been described as a "smuggling heaven" because it is "one of the most remote areas of the border." The infamous Sinaloa Cartel has historically dominated drug and human smuggling routes from Mexico. These facts have presented unique problems for Cochise County Sheriff's Office and local law enforcement. Transnational criminal organizations have an endless supply of local low-level criminal networks to facilitate their day-to-day criminal operations in our community. Now through social media

they have extended the recruitment to the rest of the country, and illegal operations have exploded.

The Cochise County Sherriff's Office responded to this unique problem by combining several high-functioning units and creating the Street Crimes Unit. The Street Crimes Unit conducts unified investigations targeting organized crime. The unit consists of deputies trained in specialized disciplines, such as drug investigations, anti-money laundering investigations, digital forensics, and canines. Through independent investigations and collaborative efforts with Federal, State, and local partners and drug enforcement initiatives, they investigate organized and street-level criminal activity within Cochise County. They are primarily focused on the detection and arrest of couriers and other felony criminal offenders involved in the smuggling or trafficking of humans, illegal drugs, weapons, and currency.

These organized criminal organizations exploit those vulnerable individuals based on "non-consensual" human trafficking. These victims are criminally exploited via sex trade, drugs, labor and gangs all for financial greed to enhance these transnational criminal organizations. We have established a network unit of intelligence and enforcement sharing to identify, protect and secure those held captive by these criminal organizations.

### Major Crimes Unit (MCU)

The Cochise County Sheriff's Office Major Crimes Unit (MCU) is tasked with the investigation of felony crimes committed within the county. MCU unit prepares cases for appropriate legal action. MCU is routinely tasked with investigating border-related crimes such as Border Patrol agent-involved shootings, and physical assaults on agents. MCU investigates UDI's claiming allegations of sexual assault by other members of their crossing group or smugglers. They are also commonly tasked with the recovery and investigation of border crossers found deceased in the Arizona desert.

MCU consists of a sergeant, 6 detectives, and a crime scene investigator.

### Community Outreach Public Services (COPS)

The Community Outreach and Public Services Unit is committed to fostering and building a partnership between the Sheriff's Office and the community by providing essential programs and services that promote an environment in which members of the community individually and collectively can help prevent crime, build safer communities, and advance the quality of life here in Cochise County.

The Sheriff's Office is committed to forming positive relationships with all organizations within the communities of Cochise County. To help in this effort, one of the first changes made within a month of taking office was the appointment of a Community Services Deputy, which was shortly followed by the development of the Community Outreach and Public Services Unit. This unit is responsible for serving as a liaison between the Sheriff's Office and community organizations.

COPS services include, receive and coordinate requests for activities from area organizations and schools; communicate with district supervisory personnel on the requirement and need for additional equipment/personnel; maintain active communication with schools and organizations to assess needs and services the Sheriff's Office can provide; provide information on upcoming activities to the Public Information Officer(s) so that local news organizations can be notified; obtain or create educational materials to fulfill the needs of the requesting public; attend public meetings to assess needs of the citizens and educate them on Sheriff's Office organization and procedures; attend Community and School Events; and School Safety and Crime Prevention (Threat Assessments and Active Shooter Presentations).

### Cochise County Sheriff's Office Patrol Division

The Patrol Division is the most visible to the public, and has more deputies assigned to it than any other division.

To effectively provide service to the 6,215 square miles that comprise Cochise County, the Sheriff's Office has six dedicated substations and one satellite substation with three regional patrol districts. The six dedicated substations are located as follows:

- o Region 1: Sierra Vista, Bisbee
- o Region 2: Benson, Willcox, with the one satellite substation located in Bowie
- o Region 3: Douglas, Elfrida

Each area, or region, is supervised by a lieutenant and one or more sergeants. The number of personnel assigned to each area is dependent upon such factors as the number of calls for service that originate from the area and the size of the service population. Region 1 has the most deputies assigned to it as that area contains a population approximately equal to half the total population of the county. Region 1 is also the only region that has a dedicated 24 hours a day, seven days a week operation. The other regions often go to an "on call" status during the early morning hours. Due to the "on call" requirement, deputies are required to reside within a 30-minute drive of their station of assignment.

### Conclusion

The collective law enforcement efforts and measures to secure our southern border and protect our Cochise County citizens and the State of Arizona has proven to be both efficient and effective. This operational model based on **Public Safety, National Security and Humanitarian** continues to be a deterrent and consequence driven imitative to hold those accountable for violating our laws and most important, the Rule of Law.

The expansion of this model partnered with our nation's Sheriffs and fellow law enforcement agencies and associations and those elected to protect Americans serves to illustrate by action highlighting the importance of our Oath of Office.

These programs have been made possible through government and private grants/donations allowing this office to fund; equipment, vehicles, overtime, personnel to include employee related expenses, aircraft, detention costs, technology and miscellaneous expenses that would prevent most organizations from pursuing these innovative measures.






- An estimated 136,724,650 fentanyl pills were seized in the United States in 2022.





- Migrants then use cellular telephones to communicate with facilitators using social media platforms to arrange transport.



Dear President Joe Biden,

As the mayors of Cochise County, located along the US-Mexico border in Arizona, we are writing to urgently highlight the crisis happening at the southern border of our country.

Over the past few years, we have seen a dramatic increase in illegal border crossings, load car chases and criminal activity associated with it. Our communities and law enforcement agencies are being overwhelmed by the sheer volume of migrants illegally entering our country. As those charged with ensuring public safety, we can no longer sit by as this crisis escalates.

Human and drug smugglers are exploiting the porous border to transport people and narcotics. This has led to more crime, violence, and tragic deaths in our communities. Our hospitals are strained with having to provide care for sick migrants. Local nonprofits and faith-based organizations are overwhelmed trying to provide food, shelter, and other services to the influx of migrants.

Our law enforcement officers are burning out responding to speeding load cars in our county around the clock. We do not have the resources or personnel to handle this sustained surge in illegal immigration. We need help from the federal government immediately.

We desperately need more funding from the federal government to hire additional officers, support staff, and resources to aid local enforcement at the border. We cannot continue operating at this pace with our limited budgets. Our officers are doing the critical work of securing our nation's border, often putting their lives at risk. They deserve the proper staffing, equipment, and resources to perform their duties safely and effectively.

In addition to more personnel, we also need advanced technology like sensors, cameras, drones, and other surveillance tools to help monitor remote areas of the border. Federal grants for proper training are also critical as our officers regularly encounter dangerous criminals and cartel activity.

We urge you to make securing the US border and supporting local law enforcement a top priority. Our communities depend on it. We are happy to work with you on legislation and funding allocations to address these needs. However, action must be taken quickly before the situation deteriorates further. We urge you to take meaningful action to secure our southern border, enforce our nation's immigration laws, and provide more support to border communities like ours that are disproportionately impacted by this crisis. We stand ready to work with you to find solutions. But we can no longer wait as the situation worsens daily.

Dear President Biden,

As leaders of the state of Arizona, our top priority is and has always been the safety and welfare of our citizens. We have repeatedly denounced the crisis at our southern border and stated what should be obvious: the smuggling of illegal drugs, weapons, and human beings poses a direct threat to our communities and innocent Americans.

Yet your administration has reacted to this humanitarian crisis—largely one of your administration's own making—with complete inaction, neglect, and ineffective immigration policies. Border wall materials that could have been used to keep our communities safe have instead sat in the southwest desert for years. Encounters at the Southwest border in FY2023 increased over 40% since FY2021.

As the President of our nation, you should be as alarmed as we are that in the past year, 169 migrants on the terrorist watch list tried to cross the southern border into our country. But imagine how many have crossed and not been caught by law enforcement. And, in the same time period, more than 24,000 Chinese nationals were apprehended crossing into the United States from Mexico, as the world's tensions with communist China intensify. Looking at those crossing the border in droves, they are largely military-aged men, not families in search of a better life as Democrats continually claim. Your open-border approach to immigration is a national threat that will have disastrous impacts on the entire country.

Border states in particular are significantly harmed by your administration's failed policies every day. Our law enforcement agencies at the border are overextended. Healthcare providers in border communities are overworked to such an extent that they are struggling to provide essential services to the residents of their community in need of care.

Your decision to close the Lukeville Port of Entry is just the latest in a long stream of irresponsible policies from your administration that fail to keep Arizona citizens, and all Americans, safe from criminal activity at the border. The closure has caused an immediate

collapse of economic activity and legal movement through that critical port of entry. Arizonans along the way to Lukeville will needlessly suffer as businesses shutter in communities such as Gila Bend, Ajo, and Why. Additionally, your proposed alternative routes to cross the border force Arizonans and Mexican nationals to travel through known cartel corridors, putting the lives of Americans at risk.

The decision to close the Lukeville Port of Entry as a solution to the crisis you created is unacceptable and must be reversed immediately. It is no secret why the border is overwhelmed, Your anti-American open-border policy sent a message to the world: that there will be no consequences for illegal immigration. The real solution is simple. Reverse your policy and put a halt to the wide-open door for so-called "asylum-seekers."

After years of being on the front lines of the border disaster, the State of Arizona has picked up the slack of an impotent federal government to protect our citizens. We have funded initiatives to combat human trafficking and illegal entry into the United States as well as border infrastructure. local prosecution efforts, and other necessary activities to safeguard citizens. We have demanded that the Arizona Governor and the Arizona Attorney General take executive action and hold you accountable in court to protect Arizona's citizens and its sovereignty. Please make no mistake. Republican leaders in this state will continue to fight for the safety of our citizens and a humane and orderly border. We will hold you accountable for your refusal to protect this nation and its people.

### Nation's Sheriffs Call for Action at the Border Due to Heightened Threat Picture The American Sheriff Alliance continues to call out cartel activity and lack of reinforcements at the border

San Diego, California – The American Sheriff Alliance met in San Diego this week to discuss the continued pressure and strain on resources due to the lack of border enforcement throughout the United States, including the alarming statistics of encounters with individuals found to be on the Terrorist Watch List, also known as the Terrorist Screening Dataset (TSDS). Further, the diversity of the countries of origin for migrant encounters is also concerning, particularly with those who have strained diplomatic relations with the U.S. The driving forces can be traced back to the lack of border security as well as the Sinaloa Cartel run by Ismael Zambada Garcia ("El Mayo") and Jalisco New Generation Cartel run by Nemesio Ruben Oseguera Cervantes ("El Mencho").

Along the southwest border, U.S. Customs and Border Protection (CBP) TSDS encounters between ports of entry of non-U.S. citizens have continually risen over the past six years. The following are the number of TSDS encounters according to CBP: 2017 – 2 encounters, 2018 – 6 encounters, 2019 – 0 encounters, 2020 – 3 encounters, 2021 – 15 encounters, 2022 – 98 encounters, and 2023 YTD – 151 encounters. Since 2021, this represents a 906% increase in TSDS encounters; there are still three months left in 2023.

In addition to these alarming rates of TSDS encounters, other criminal statistics continue to rise. The number of arrests of individuals with criminal convictions or those wanted by law enforcement by noncitizens has increased exponentially from 6,562 encounters in 2021 to 16,992 in 2022, and year to date in 2023, there have been 18,586 encounters, which marks a 183% increase since 2021 with again three months left this year.

The statistics for TSDS encounters and those with criminal convictions or who are wanted by law enforcement reflect only those who have encountered authorities. It is unknown how many concerning individuals have entered the United States who have yet to be accounted for. CBP reported that they have estimated a total of 600,000 got-a-ways this year, but there is no way of knowing the exact numbers. These alarming statistics are extremely concerning to the Alliance, and there are major homeland security concerns with these individuals especially, with the lack of information and vetting as to their intentions, criminal histories, or connections to our adversaries worldwide.

Further, the strain on local resources both for border sheriffs and law enforcement across the country who do not have the adequate staffing or funding to respond to this influx of migrants is troubling. The continued effect on communities across the country who are left to deal with violent criminals, illicit narcotics and the increase in overall criminal activity is straining public safety resources. To say nothing of the pressure felt on community services including housing, medical services, and the judicial system.

"When the number of people dying from drug poisonings is equivalent to a 737-airplane crashing each day, and the number of migrants that we are aware of coming across the border could fill the

Caesars Superdome in New Orleans weekly, we have to sound the alarm," said Sheriff Greg Champagne of St. Charles Parish, Louisiana, and President of the National Sheriffs' Association (NSA). "If a plane crashed daily, there would be immediate action taken, and yet instead of seeing numbers decrease, we continue to set records for those who are dying from illicit narcotics mostly originating from the drug cartels in Mexico."

"Communities across the United States, whether or not they are located near a southern, northern, or maritime border, are being affected by the lack of resources available to address the overwhelming challenges in stopping the volume of violent criminals and illicit narcotics flowing into our country at the hands of the cartels," stated Major County Sheriffs of America Executive Director Megan Noland. "The implications to the nation's homeland security threat picture continues to expand as migrant flows and cartel activity continue to increase with no relief in sight. Terrorists and foreign bad actors are monitoring the current weak border policies, and they will absolutely exploit these failings given the opportunity."

Sheriff Leon Wilmot of Yuma County, Arizona and a Western States Sheriffs' Association member stated, "The pressure on law enforcement at the local level is unsustainable with the continued daily increases at the southern ports of entry. With the sustained unrelenting flow of migrants coming from all over the world and the limited background checks and vetting process, it is concerning who is being released into the interior. The cartels are actively promoting the weak border policies through social media networks, and it is clear they have been, sadly, very successful in their mission."

"While we know that these pressures are affecting U.S. borders from all sides, the southern border is clearly the center of concern when we see migrants from countries across the world enter our country into the Southwest Border," said Sheriff Eddie Guerra of Hidalgo County, Texas, and President of the Southwestern Border Sheriffs' Coalition. "CBP has reported that migrant encounters at the southwest border cover 180 international countries – many who are adversaries with the United States, which should be concerning to every American citizen."

Sheriff Tom Schmerber of Maverick County, Texas, and President of the Texas Border Sheriff's Coalition noted, "While federal, state, and local law enforcement are doing everything they can to keep their local communities secure and ensure humane conditions for migrants who are truly seeking asylum, there is no doubt that the asylum system is being abused and the traditional avenues are overwhelmed to keep up requests forcing the release of these individuals without any accountability. El Mencho, El Mayo, and other troubling cartel criminals will continue to exploit these easy loopholes without action from our elected officials.

The American Sheriff Alliance encourages elected officials at every level of government to speak out and draw attention to the need of making proper reforms to these extreme challenges. This includes actions needed to be taken by the White House Administration as well as Congress to ensure our borders are secure. With hundreds of violent criminals entering communities every day around the country as well as the flow of illicit narcotics poisoning our citizens, the Alliance is demanding the rule of law in this country be followed and that all available sanctions and statutes be used to help alleviate the pressure the men and women of law enforcement are facing during this unprecedented period in our nation's history. With a potential government shutdown on the horizon where staff will deal with this crisis unpaid, the environment is ripe for the perfect storm with American citizens suffering the consequences. Further, the Alliance is asking for the public's support to demand the necessary reforms.

### Addressing the Border Crisis: A Two-Fold Challenge

During the last two years, every month, an estimated 1,500 smugglers come to Cochise County to transport migrants who have illegally entered the United States from Cochise County to Phoenix, Arizona. This has resulted in hundreds of pursuits, car crashes, people being criminally victimized, and many citizens and migrants being killed.

On September 13, 2023, the United States Border Patrol advised the Cochise County Sheriff's Office they were directed to release migrants who had been processed into the streets of Douglas and Bisbee. Understandably, Cochise County Residents expressed heightened concern. It has come to the attention of community leaders that misinformation is being circulated, and certain facts require clarification. This border crisis consists of two very distinct, yet interconnected crises, a humanitarian crisis and a crisis of drug and human smuggling.

### **Humanitarian Crisis**

In May of 2023, community leaders were informed that with the lifting of Title 42, Border Patrol Stations within Cochise County would be receiving asylum-seeking migrants from other Border Patrol Stations. Due to various factors, Cochise County had historically not seen many asylum-seeking migrants self-admit at the Douglas and Naco port of entries. However, other Ports of Entry across the Southwest Border have been overwhelmed with hundreds of migrants legally seeking asylum. Those Border Patrol Stations were unable to house or process those migrants and the Department of Homeland Security began shipping those migrants from other Border Patrol Stations to the Naco and Douglas Border Patrol Stations to be processed.

From May 2023, until September 12, 2023, asylum-seeking migrants were released from Cochise County Border Patrol Stations at predetermined times allowing coordination for immediate transport out of Cochise County. Migrants received no further assistance from the federal government. To address this issue, local community leaders coordinated with partners from the State of Arizona, Pima County, and various non-profit and non-governmental entities to transport those migrants from Cochise County to shelters in Tucson, Phoenix, and beyond. It is important to note once these migrants were "Processed," they were given a hearing date and are expected to appear to asses their asylum status. Despite prompt scheduling, the actual hearing date may be years away. Therefore, migrants have lawful status in the United States while their asylum claim is pending.

On September 13, 2023, Border Patrol Leadership advised the number of asylum-seeking migrants being transferred into their facilities had exceeded capacity and they could no longer schedule the drop-offs at the bus sites at predetermined times. Migrants must be released sporadically throughout the day depending on migrant population. A total of 72 migrants were released into Douglas and Bisbee on September 13th. While awaiting for prearranged transport out of Cochise County, migrants released in Douglas were graciously provided shelter from the elements, by a local church. The Migrants released in Bisbee waited in a parking lot for transportation. On September 14, 116 migrants were released into Bisbee and Douglas; most were transported from the area to humanitarian shelters outside of Cochise County.





A majority of this migrant group, speak languages other than English or Spanish and have no shelter or resources. This makes it more difficult for law enforcement and community partners to provide assistance. They are lawfully in the United States, after arriving at the border, and making immediate contact with Customs and Border Patrol Officials. They have adhered to the guidelines outlined by the federal government for seeking asylum. These asylum-seeking migrants are **not** the migrants who have illegally entered the United States; they have committed no crimes. The Federal government is releasing these asylum-seeking migrants, many of which are families, accompanied with children. Unfortunately they are being released by the federal government into a rural



community with no resources to help them.

Simultaneously, Arizona leads the nation in both drug and human smuggling. 23.37% of all fentanyl seized in the entire United States in 2022, was seized in either Cochise or Santa Cruz Counties. In 2022, 44.87% of all migrants who illegally entered the United States between ports of entry, were apprehended in the Tucson Sector of the United States Border Patrol. As Border Patrol Agents are pulled from the Tucson Sector to address the humanitarian crisis of thousands of asylum-seeking migrants who self-admit at ports of entry across the Southwest Border, community leaders expect the number of migrants who illegally enter the country between ports of entry to continue rising. This means, criminal organizations will continue to recruit people from across the United States (ages 12-72) to smuggle drugs and humans from Cochise County to Phoenix.

It is worth noting those who are apprehended while illegally entering the United States (or being smuggled in a vehicle after not checking in at a port of entry) are **not** the migrants being released into our communities. Most, if not all of the migrants who enter our country illegally are expelled. For more information about the processing of migrants, reach out to your local Border Patrol Station.

### Nation's Sheriffs Call for the Eradication of Drug Cartels, Starting with the Sinaloa and Jalisco New Generation Cartels

The American Sheriff Alliance implores for action to stop the flow of illicit narcotics into the United States by Mexican Cartels

(Washington, DC) - The American Sheriff Alliance met in Washington, DC, last week to discuss the continued rise in overdose deaths and violence plaguing their jurisdictions in all areas of the country. These troubling patterns can all be traced to two main drivers of illicit narcotics into the United States - the Mexican Sinaloa and the Jalisco New Generation Cartels, both Transnational Criminal Organizations (TCOs) which are headquartered south of the United States border with Mexico.

On September 11, 2001, terrorists killed 2,977 innocent people and our nation was outraged. America's response included declaring a war on terrorism and bringing justice to the victims of this unthinkable tragedy by holding terrorists and terrorist countries accountable.

Last year, on December 14, 2022, the White House issued a statement regarding the Center for Disease Control and Prevention's (CDC) release of provisional drug overdose death data for the 12-month period ending in August 2022. Over 107,000 overdose deaths were recorded in this one-year period, with most attributed to illicit synthetic drugs like fentanyl and methamphetamine, often in combination with other drugs, including cocaine and heroin. Despite the incredible number of deaths, which can be directly attributed to the trafficking of illegal narcotics into the United States by the Mexican Cartels there has been little call to action or change in foreign policy to address this alarming issue. This crisis has caused 35 more times the amount of death to American citizens in a one-year period than was inflicted upon the U.S. on September 11th by Al-Qaeda and Osama Bin Laden.

The Mexican drug cartels, as well-documented in the successful prosecution of Joaquín Archivaldo Guzmán Loera, also known as El Chapo, operate sophisticated crime operations fueled by fear, terror, intimidation, extortion, and murder. These criminal organizations are directly responsible for the increases in deaths, human trafficking, sex trafficking, and unprecedented violence occurring in cities and counties across our nation. These cartels and their operatives are operating with disastrous effects not just on our southern border, but their influence can also be felt across our northern border and maritime borders as they seek to exploit all avenues to deliver lethal narcotics and violent criminals into our communities.

Sheriff Greg Champagne, of St. Charles Parish, Louisiana, and President of the National Sheriffs' Association (NSA) stated, "We can no longer allow these murderers to terrorize our communities. We need every American to join us in demanding our government focus on this crisis and take whatever actions are necessary to eliminate these criminal networks and operations."

"This is not a partisan issue. This is a life-and-death issue," said Sheriff Bill Brown, of Santa Barbara County, California, and Vice President of the Major County Sheriffs of America (MCSA). "Two criminal organizations, the Sinaloa and Jalisco New Generation cartels, operate in Mexico with near impunity, producing and trafficking fentanyl and other deadly drugs that are killing more than 100,000 Americans every year. America's sheriffs are calling for meaningful change in our nation's

foreign policy. The federal government must put greater pressure on the Mexican government to take aggressive action to disrupt and destroy these unlawful cartels. The current situation is intolerable and cannot stand."

Sheriff Brett Schroetlin, of Grand County, Colorado, and President of the Western States Sheriffs' Association (WSSA) said, "These cartels are operating in every part of our nation. It's not an urban, suburban, or rural issue. These massive, well-financed criminal enterprises kill, enslave, and destroy families and communities. We need the people of the United States to demand, that our government commit the necessary resources to eliminate these organizations here and abroad as they did following the horrific events of 9/11.

"This is not an immigration issue; this is a public safety and public health issue. It's not just the violence and drugs, it's the sexual assaults, human trafficking, enslavement, and fear and terror that are destroying neighborhoods here in the United States," stated Sheriff Eddie Guerra, of Hidalgo County, Texas, and Chairman of the Southwestern Border Sheriffs' Coalition (SWBSC). "We are asking every person who knows someone who has died or family who has suffered at the hands of these criminal organizations, to make their voices heard with their federal, state, and local elected officials who have the power to create the necessary change."

Sheriff Eusevio Salinas, of Zavala County, Texas, and Chairman of the Texas Border Sheriffs' Coalition (TBSC) said, "Americans can save lives by calling upon the President of the United States, U.S. Senators, and representatives in Congress and demanding immediate, comprehensive action to identify and destroy these criminal operations, wherever they may exist. Until our elected officials stand up to fight this epidemic sweeping the nation, we will continue to set records related to the number of our loved ones we continue to lose each year at the hand of these violent cartels."

The American Sheriff Alliance is imploring the public to demand their elected officials use every available sanction and accountability tools at their disposal in combating the atrocities committed against our country and its citizens by the Sinaloa and Jalisco New Generation Cartels. Without such action, these dangerous cartels will continue to destroy the very fabric of our families and communities.

### DENOUNCING THE CURRENT CRISIS WITH RESPECT TO THE SOUTHERN BORDER

Whereas, the United States-Mexico border consists of 1,954 miles of varied terrain, including deserts, rugged mountainous areas, forests and coastal areas; and

Whereas, officially established in 1924 by an act of Congress in response to increasing illegal immigration, the United States Border Patrol has primary responsibility for securing the border between ports of entry; and Whereas, Border Patrol agents patrol international land borders and waterways to detect and prevent the illegal trafficking of people, narcotics, and contraband into the United States; and

Whereas, on March 7, 2022, the Western States Sheriffs' Association unanimously passed Resolution 22-1, which outlines the alarming issues facing our nation due to the unchecked illegal immigration crises at our southern border; and

Whereas, the southern border of the United States is currently experiencing an unprecedented number of people attempting to enter the country illegally, with the past fiscal year seeing a 379% increase of border encounters as compared to the previous fiscal year. These 1.7 million individuals represent 164 countries, including countries with suspected terrorist ties, and 63% of them are from countries other than Mexico; and

Whereas, there has likewise been a major increase in apprehensions, expulsions and "gotaways" on the southwest border, with one million encounters and 300,000 getaways between October 1, 2021, and April 11, 2022; and

Whereas, in the past fiscal year, the number of illegal drugs seized has skyrocketed, including 10,000 pounds of fentanyl, 180,000 pounds of methamphetamine, 86,000 pounds of cocaine, 5,000 pounds of heroin and 311,000 pounds of marijuana. Likewise, criminal activity has soared, with law enforcement documenting 60 homicides, 1,178 assaults, 2,138 drug-related or drug trafficking arrests, 825 burglaries, 1,629 DUIs, 336 weapons arrests and 488 sexual assaults; and

Whereas, in a new effort to boost their operations, criminal cartels are using social media platforms as a recruiting tool for human smuggling. Drivers are lured by social media posts promising payment of \$1,500 to \$2,000 for every migrant a person can transport by vehicle to Tucson or Phoenix. Known as "load-car drivers," these individuals are mainly young people, some as young as fourteen years old, who are enticed to pick up undocumented migrants at the border and ferry them to their destinations in exchange for money. Arizona Governor Doug Ducey has called on four social media giants to better monitor their platforms and ban these recruitment posts on their sites; and

Whereas, for individuals who are smuggled into the United States by Mexican and South American cartels, their arrival marks the beginning of years of drug distribution, modern-day slavery, and sex trafficking to pay back the criminal cartels to which they are indebted; and

Whereas, an estimated 8% of the 1.7 million encounters last fiscal year were unaccompanied minors; and

Whereas, tragically, the prior year saw 162 migrant deaths in Southern Arizona; and

Whereas, an uncontrolled border is a security and humanitarian crisis, and the increased violence and the smuggling of illegal drugs, weapons and human beings poses a direct threat to our communities and innocent Americans; and Whereas, the current administration has halted construction of a southern border wall, and there are numerous unfinished sections in Arizona; and

Whereas, this administration is not working collaboratively or in good faith with local law enforcement agencies and other state leaders to address the serious issues related to the border; and

Whereas, in April 2021, Arizona Governor Doug Ducey declared a state of emergency at Arizona's southern border; and

Whereas, in February 2022, Arizona Attorney General Mark Brnovich issued a legal opinion determining that the current crisis at Arizona's southern border with the violence and lawlessness of cartels and gangs legally qualifies as an "invasion" under the United States Constitution.

Therefore, Representative Gail Griffin and the following members of the House of Representatives of the State of Arizona denounce the continued breach of our nation's southern border and support safe communities, immediate, decisive action to secure the border and alleviate the security and humanitarian crises associated with illegal immigration.

Over the past 10 months we have witnessed the continued breach of the border by illegal Immigrants who seek to find refuge in the United States. Many are hoping to reach our homeland in search of a life of freedom. Many will come here with a debt owed to the drug cartels of Mexico and South America. For some, reaching the United States marks the beginning of years of drug distribution, slavery, and prostitution in order to pay back the drug cartels for the privilege of being brought to the U.S.

This is not a new phenomenon. This has been occurring for decades. This is the reason our Border Patrol, southern border Sheriffs and Immigration and Customs enforcement exists. A concerted effort to curb the northward flow of illegal Immigrants has long been the focus of these enforcement officers. For the past several years, much effort and financial resources was focused on the southern border and a great deal of progress was made in limiting the number of illegal crossings.

Today we are witnessing a complete and total breakdown of efforts of the past several years. Over a million illegal crossings already this year. Dear Mr. President:

I am writing on behalf of the nation's 3,080 plus sheriffs requesting an appointment with you and staff to discuss the ever-increasing demands along our southern border.

Yesterday alone more than 530 persons crossed into Del Rio, Texas illegally, putting a burden on the local sheriff and his community, preventing them from doing their assigned duties of protecting, patrolling, and responding to local needs.

So far this fiscal year has recorded more than 200,000 individuals who have avoided local law enforcement and border patrol arrests, an average of 1,100 "get-aways" per day. 60,000 were in the Tucson Sector alone, making it the highest in the nation. In addition, April 2021 recorded 18,000 unaccompanied minors, the highest total ever. It is clear that the situation in these local communities is at or beyond the breaking point insofar that the Border Patrol has no resources or ability to respond to the surge without violating existing policies.

Our members are sworn to uphold the constitutions and laws of their states. However, unless cross-sworn with federal agencies they have no ability to support the CBP in apprehending and registering those crossing illegally into their communities. At this point they are merely watching (not detaining, arresting or preventing exit) without force border crossers who actively request asylum from our deputy Sheriffs. It is these deputies that are the front line law enforcement officers for these towns and communities along the border. Fortunately our relationships with the Border Patrol are close. However, we have become the defacto holding agents for them until an authorized federal agent arrives and takes custody of these persons.

This situation has escalated to the point where our border communities are facing significant increases in crime and exorbitant costs to assist the federal government. Between overtime, shortfalls of deputies and officers, health risks, and now an apparently orchestrated effort to cross in locations where shortfalls of manpower of both the Border Patrol and local law enforcement is causing massive problems.

Crime along the border resulting from illegal border incursions is staggering. One example, from the New York Times, reports the death of nine-year-old girl drowned while trying to cross the Rio Grande into Texas with her family. At the same time we are seeing increasing brazen behaviors by Coyotes, dropping

individuals in the desert or from border fences. Directly related is the level of opioids and other illegal substances that continue to pour across the border – exacerbating an already epidemic plague in the nation's interior.

Equally troubling is the rise in violence against women – indentured servitude, prostitution, and human trafficking violence are increasing on the border. In March, USBP brought a 13-year-old girl to the Yuma County Sheriff's Office. She said she was raped two days earlier while walking through Mexico after leaving El Salvador. Law enforcement finds Plan B abortion pills near the border – a terrible sign of what young people go through as they walk to the border.

At the Del Rio USBP sector, arrests of migrants with sex offense records are up more than 2,500%. This region of the border, relatively quiet for the past decade, has become a major crossing point this year. We need a focused enforcement and federal prosecution strategy to target every high-crossing region. We remain troubled that more immigration judges are not available along the border and able to make decisions in hours and days not months and years.

Adding further concern are confirmed COVID cases of those crossing the border, or in detention facilities. For example, an Immigration and Customs Enforcement facility in Aurora, Colorado had a coronavirus outbreak that hit 94 individuals transported to the facility in April and May. It appears a lack of testing and vaccines has caused unneeded cases of the virus moving to the interior of the country. Yet when asked about COVID testing the Border Patrol says "suspected COVID-19 cases are referred to local health systems for appropriate testing, diagnosis, and treatment," leaving local governments to take on the added responsibility of care-giver for federal wards.

Your administration has prided itself upon seeking a laudable solution "at the source" of this border problem. However, that solution is years in the making and our communities, Sheriffs, and law enforcement are overwhelmed now. They need your help and commitment.

We request a meeting with you and Secretary Myorkas to discuss identifying a new approach to minimizing this dangerous and emergent problem. Our president, Sheriff Vernon Stanforth, the NSA's Border Security Committee chair Sheriff Mark Dannels, NSA's Government Affairs chair Sheriff Jim Skinner, and myself stand ready to meet at your earliest convenience to identify a mutually agreeable path forward.
