This is the email that I mentioned to you. My conversations with (b)(6) and the congressional staff have all been via telephone, not email or letter. The proposal I was preparing was a draft compatibility determination, which would have a public comment period. When I was able to fully engage the Regional Office (Tom H and others) in the new year after the holidays and use or lose were over, the discussion moved away from a specific CD on skiing and towards a more robust CD covering all types of boating (which would also include public comment) and a modification to the existing buoy line prior to the start of the boating season.
