Urban Eberhart – Member, Yakima River Basin Water Enhancement Project Working Group and Implementation Committee; Urban is leading the way in planning for drought resiliency. A resident of the Kittitas Valley since he was a boy, Urban has lived on a farm his whole life and was active in the Future Farmers of America throughout high school.
