On Tuesday, March 29, 2022 at 2:00 p.m. ET, in room 1324 Longworth House Office Building and Cisco WebEx, the Subcommittee on Water, Oceans, and Wildlife will hold a legislative hearing on the following bills:

- H.R. 5996 (Rep. Jeff Fortenberry, R-NE) To continue the whole-of-government approach to ending global wildlife poaching and trafficking by permanently reauthorizing the activities of the Presidential Task Force on Wildlife Trafficking, and for other purposes. Eliminate, Neutralize, and Disrupt Wildlife Trafficking Reauthorization and Improvements Act of 2021.
- <u>H.R. 6427</u> (Rep. Mike Johnson, R-LA) To amend the Red River National Wildlife Refuge Act to modify the boundary of the Red River National Wildlife Refuge, and for other purposes. *Red River National Wildlife Refuge Boundary Modification Act*.
- <u>H.R. 6734</u> (Rep. Hakeem Jeffries, D-NY) A bill to amend the Fish and Wildlife Act of 1956 to reauthorize the volunteer services, community partnership, and refuge education programs of the National Wildlife Refuge System, and for other purposes. *Keep America's Refuges Operational Act of 2022*.
- <u>H.R. 7025</u> (Rep. Raúl Grijalva, D-AZ) To prohibit the Director of the United States Fish and Wildlife Service from funding entities that commit, fund, or support gross violations of internationally recognized human rights, and for other purposes. *Advancing Human Rights-Centered International Conservation Act of 2022*.
