Mississippi Farm Bureau Federation (MFBF) represents farmers and ranchers who are affected by black vultures attacking their livestock. I am the President of MFBF and as a cattle producer, I am directly affected by the losses of calves that are attacked by black vultures. The losses caused by black vultures can result in substantial financial strain on a cattle operation.

Mississippi Farm Bureau Federation (MFBF) obtained a statewide depredation permit for black vultures from the United States Fish and Wildlife Services (USFWS). The MFBF statewide depredation permit provides livestock producers with the opportunity to apply for a Livestock Protection Depredation Sub-Permit, which allows legal "takes" of black vultures attacking livestock. MFBF administers the statewide permit. There is no cost to apply or to obtain the MFBF Livestock Protection Depredation Sub-Permit and MFBF obtains no funds from USFWS.
