**Being an avid hunter, I committed significant resources, both financial and otherwise, to Zimbabwe's conservation programs to help fund anti-poaching programs and protect the African Elephant by participating in an elephant hunt in Zimbabwe in March 2014. I have first-hand experience with the elephant populations in Zimbabwe as a result of this once-in-a-lifetime hunt that I was able to partake in. Further I have spent significant time over the past decade on the ground in Zimbabwe and Tanzania, specifically:**

- **As stated previously, in March 2014 I was in Zimbabwe for 20 days on elephant safaris within four National Forests (Gwayi, Mbembesi, Sikumi and Ngamo).**
- **In August and September of 2013 I was in Zimbabwe for 10 days at Bishopstone.**
- **In August and September of 2010 I was in Tanzania's Rungwa area for 21 days.**
- **In August and September of 2009 I was in Tanzania's Rungwa area for 21 days.**
- **In August and September of 2008 I was in Tanzania's Kigosi area for 21 days.**
