Support for H.R. 1884/S. 915, the Save Oak Flat Act

Dear Chairman Grijalva:

On behalf of London Mining Network, I am writing to express strong support for H.R. 1884/S. 915, the Save Oak Flat Act.

It is our belief that London-listed mining companies Rio Tinto and BHP, through their joint venture Resolution Copper Mining, LLC, would effectively destroy Oak Flat in southeastern Arizona if they develop their planned copper mine.

Members of London Mining Network have worked for years with communities around the world affected by the operations of both these companies. Both have long histories of causing serious environmental damage and social dislocation.

Just over a year ago, London Mining Network published a report, *Cut and Run*, about the way in which both Rio Tinto and BHP's operations have created catastrophic environmental damage and social dislocation in Pacific Rim countries and then been abandoned, leaving others to deal with their legacy. On the basis of our experience with both companies, we hope that Congress will protect Oak Flat from the Resolution Copper project. Our opinion is that both companies' histories suggest the need for extreme caution.
