- 3. As a tribal leader, can you explain how securing advance appropriations for the Indian Health Service would enable the federal government to better fulfill its trust obligations to Indian Country?
- 4. During federal funding gaps for tribal programs, tribal governments must often utilize their own funds to "keep the lights on."
 - a. The last partial government shutdown occurred for 35 days back in 2018. What were some actions that your tribal government had to undertake during this time?
 - b. If Navajo Nation had to cover any federal costs, were these added costs ever addressed by the federal government after the shutdown ended
