Under P.L.93-638, the Great Plains Tribal Leaders Health Board has an IHS Self Determination Title I contract since to provide ambulatory healthcare services at the Oyate Health Center in Rapid City, South Dakota, for the amount of \$34,770,543. The GPTLHB holds a long-standing Cooperative Agreement for the Great Plains Tribal Epidemiology Center, including subcontracts, and also receives several IHS grants listed below. In addition, we have a 105 (L) lease which afforded us facilities support of \$298,210.00 towards an alternative care site for the Oyate Health Center also in Rapid City, SD

(\$707,880 DEDP + \$70,000 NIH + Supplements) 9/30/2021-2026 Epidemiology Program for AI/AN Tribes and Urban Indian Communities IHS Great Plains Tribal Epidemiology Center (GPTEC) GPTEC's mission is to provide leadership, technical assistance, support, and advocacy for the 17 tribal nations and 2 HIS service communities serviced by the Great Plains Area IHS to eliminate the health disparities that currently exist for tribal peoples within the four-state region of South Dakota, North Dakota,

Nebraska, and Iowa. In consultation with and on the request of Indian tribes, tribal organizations, and urban Indian organizations, GPTEC is charged with: Collecting data; Evaluating data and programs; Identifying health priorities along with tribes; Improving health care delivery systems; Providing epidemiologic technical assistance to tribes and tribal organizations; Providing disease surveillance to tribes. This award includes funds to provide technical assistance to area SASPP/DVPP grantees, NIMHD supplemental funding, funding for Ending the HIV Epidemic in the Great Plains Area, funding for IHS Cancer Support Leadership Trainings. and CARES Act funding to support GPTEC's COVID response activities (surveillance and reporting, outreach and education, communication, others).

It assesses and identifies current child passenger safety capacity, resources, and needs. It increases community Child Passenger Safety Technician capacity and provides community education on proper usage of child passenger safety seats, and distributes seats to families who lack the resources to purchase them.

The program also partners with Native Women's Health to offer sexual assault medical forensic examinations, forensic interviewing, and advocacy for survivors.

This program funds two additional Support Navigators and a Licensed Clinical Social Worker dedicated to providing behavioral health treatment to youth and families. The program trains the Licensed Clinical Social Worker and Oyate Health Center Behavioral Health providers to provide three evidence-based therapies not currently offered at OHC.

IHS 618 \$200,000 5/1/2022-2027 Domestic Violence Prevention Program Trauma & Violence Prevention Initiative TVPI addresses existing regional gaps in data sharing, reporting, education, and advocacy by conducting needs-based assessments and designing a strategic training curriculum for tribal law enforcement, tribal school administrative staff, and students, Domestic Violence (DV) shelter staff, and community members. The program expands awareness and access to culturally appropriate, trauma-informed DV prevention services.
