- The President/CEO is responsible for the overall functionality and operational performance of a 501(C) (3), P.L. 93-638 Title 1 Tribal Organization on behalf of 17 Federally Recognized Tribes & 1 IHS service area encompassing the four states of North Dakota, South Dakota, Nebraska and Iowa serving more than 150,000 American Indians/Alaskan Natives. Provide strategic leadership to Great Plains Public Health programs, including the Great Plains Tribal Epidemiology Center, and provide Intergovernmental, Tribal Health Policy advocacy and technical assistance. Responsible for the operational management of GPTLHB Oyate Health Center, a tribal ambulatory health center, providing primary care, behavioral health, dental, optometry, pharmacy, imaging, laboratory, and rehabilitative services to over 25,000 AI/AN in the Black Hills of South Dakota.
- Led area-wide initiative on behalf of the Great Plains tribes to evaluate programs, functions, services, and activities of the Great Plains IHS area office. Develop and implement area-wide needs assessment for the tribes in the Great Plains region to determine priorities for greater tribal control of the Great Plains IHS area.

- Increased access to care at Oyate Health Center from 73,462 ambulatory visits in 2020 to 132,130 ambulatory visits in F.Y. 2022, reflecting an 80% increase in annual visits.
