## **Chairman Jeff Hurd**

1) Is the U.S. Forest Service aware of any opposition to placing land into trust for the Quinault Indian Nation in respect to H.R. 2839?

**Response:** The USDA Forest Service is not aware of any opposition to placing land into trust for the Quinault Indian Nation and supports H.R. 2839.

2) The U.S. Forest Service currently manages Allotment 1157. What does the U.S. Forest Service currently do with this land?

**Response:** The Olympic National Forest manages Allotment 1157 to preserve old-growth forest in alignment with our Tribal Trust relationship and Treaty responsibilities and as habitat for the northern spotted owl, marbled murrelet and other native species. The Allotment is located within the boundaries of the Quinault Indian Reservation, outside of the administrative boundary of the Olympic National Forest. The Allotment has no land designation under the Northwest Forest Plan or the 1990 Land Resource Management Plan.

3) Is the U.S. Forest Service aware of any opposition to placing land into trust for the Pit River Tribe in respect to H.R. 2400?

**Response:** The USDA Forest Service is not aware of any opposition to placing land into trust for the Pit River Tribe and supports H.R. 2400. We would appreciate the opportunity to continue working with the Committee to ensure that any existing special use permits, along with the rights of way and road permits, are also excluded from the land transferred.
