#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Good Samaritan As-

5 sessment Act of 2016".

#### 6 SEC. 2. FINDING.

7 The Congress finds that the Executive branch, in-8 cluding the Office of National Drug Control Policy, has

a policy focus on preventing and addressing prescription
 drug misuse and heroin use, and has worked with States
 and municipalities to enact Good Samaritan laws that
 would protect caregivers, law enforcement personnel, and
 first responders who administer opioid overdose reversal
 drugs or devices.

# 7 SEC. 3. GAO STUDY ON GOOD SAMARITAN LAWS PER8 TAINING TO TREATMENT OF OPIOID 9 OVERDOSES.

10 The Comptroller General of the United States shall 11 submit to the Committee on the Judiciary of the House 12 of Representatives, the Committee on Oversight and Gov-13 ernment Reform of the House of Representatives, the 14 Committee on the Judiciary of the Senate, and the Com-15 mittee on Homeland Security and Governmental Affairs 16 of the Senate a report on—

(1) the extent to which the Director of National
Drug Control Policy has reviewed Good Samaritan
laws, and any findings from such a review, including
findings related to the potential effects of such laws,
if available;

(2) efforts by the Director to encourage the en-actment of Good Samaritan laws; and

(3) a compilation of Good Samaritan laws in ef fect in the States, the territories, and the District of
 Columbia.

#### 4 SEC. 4. DEFINITIONS.

5 In this Act—

6 (1) the term "Good Samaritan law" means a 7 law of a State or unit of local government that ex-8 empts from criminal or civil liability any individual 9 who administers an opioid overdose reversal drug or 10 device, or who contacts emergency services providers 11 in response to an overdose; and

(2) the term "opioid" means any drug, including heroin, having an addiction-forming or addictionsustaining liability similar to morphine or being capable of conversion into a drug having such addiction-forming or addiction-sustaining liability.
