A BILL

To require a study by the Comptroller General of the United States on Good Samaritan laws that pertain to treatment of opioid overdoses, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Good Samaritan As-
5 sessment Act of 2016”.

6 **SEC. 2. FINDING.**

7 The Congress finds that the Executive branch, in-
8 cluding the Office of National Drug Control Policy, has

1 a policy focus on preventing and addressing prescription
2 drug misuse and heroin use, and has worked with States
3 and municipalities to enact Good Samaritan laws that
4 would protect caregivers, law enforcement personnel, and
5 first responders who administer opioid overdose reversal
6 drugs or devices.

7 **SEC. 3. GAO STUDY ON GOOD SAMARITAN LAWS PER-**
8 **TAINING TO TREATMENT OF OPIOID**
9 **OVERDOSES.**

10 The Comptroller General of the United States shall
11 submit to the Committee on the Judiciary of the House
12 of Representatives, the Committee on Oversight and Gov-
13 ernment Reform of the House of Representatives, the
14 Committee on the Judiciary of the Senate, and the Com-
15 mittee on Homeland Security and Governmental Affairs
16 of the Senate a report on—

17 (1) the extent to which the Director of National
18 Drug Control Policy has reviewed Good Samaritan
19 laws, and any findings from such a review, including
20 findings related to the potential effects of such laws,
21 if available;

22 (2) efforts by the Director to encourage the en-
23 actment of Good Samaritan laws; and

1 (3) a compilation of Good Samaritan laws in ef-
2 fect in the States, the territories, and the District of
3 Columbia.

4 **SEC. 4. DEFINITIONS.**

5 In this Act—

6 (1) the term “Good Samaritan law” means a
7 law of a State or unit of local government that ex-
8 empts from criminal or civil liability any individual
9 who administers an opioid overdose reversal drug or
10 device, or who contacts emergency services providers
11 in response to an overdose; and

12 (2) the term “opioid” means any drug, includ-
13 ing heroin, having an addiction-forming or addiction-
14 sustaining liability similar to morphine or being ca-
15 pable of conversion into a drug having such addic-
16 tion-forming or addiction-sustaining liability.
