Page 6, strike line 3 and all that follows through
line 7, and insert the following:

1 “(c) REVIEW OF SOCIAL MEDIA ACTIVITY; FBI
2 STUDY AND DEVELOPMENT OF METHODOLOGY FOR
3 SCRUTINY OF SOCIAL MEDIA.—Not later than 180 days
4 after enactment, the Attorney General shall complete a
5 study on methods and policies for reviewing an alien’s
6 publicly available interactions on and posting of material
7 to the Internet (including social media services) and shall
8 establish a method and policy, in conjunction with the Sec-
9 retary of Homeland Security and the Secretary of State,
10 for conducting such a review.”.
