

AMENDMENT TO H.R. 4477  
OFFERED BY MR. Goodlatte

Page 9, line 12, strike “**REAUTHORIZATION OF**”.

Page 10, strike lines 14 through 22 and insert the following:

- 1 (2) in subsection (e), by striking paragraph (2)
- 2 and inserting the following:

Page 11, line 13, strike “this subsection” and insert “section 7 of the NICS Fix Act of 2017”.

Page 12, line 14, strike “**REAUTHORIZATION OF THE**”.

Page 13, line 15, insert “and” after the semicolon.

Page 13, line 20, strike “; and” and insert a period.

Page 13, strike lines 21 and 22.

Page 17, line 23, strike “Within” and insert “Using amounts made available for research, evaluation or statistical purposes, within”.

At the end of the bill, add the following:

1 **SEC. 7. AUTHORIZATIONS OF APPROPRIATIONS.**

2 (a) IN GENERAL.—There is authorized to be appro-  
3 priated \$100,000,000 for each of fiscal years 2018  
4 through 2022 to carry out, in accordance with the NICS  
5 Act Record Improvement Program and the National  
6 Criminal History Improvement Program, the activities  
7 under—

8 (1) section 102 of the NICS Improvement  
9 Amendments Act of 2007;

10 (2) section 103 of the NICS Improvement  
11 Amendments Act of 2007;

12 (3) section 102 of the Crime Identification  
13 Technology Act of 1998; and

14 (4) section 106(b) of the Brady Handgun Vio-  
15 lence Prevention Act

16 (b) ADDITIONAL AUTHORIZATIONS.—Section  
17 1001(a) of the Omnibus Crime Control and Safe Streets  
18 Act of 1968 (34 U.S.C. 10261(a)) is amended—

19 (1) in paragraph (1)—

20 (A) by striking “\$33,000,000” and insert-  
21 ing “\$31,000,000”;

22 (B) by striking “1994 and 1995” and in-  
23 serting “2018 through 2022”; and

24 (C) by inserting “, in addition to any  
25 amounts otherwise made available for research,

1 evaluation or statistical purposes in a fiscal  
2 year” before the period; and  
3 (2) in paragraph (2)—  
4 (A) by striking “\$33,000,000” and insert-  
5 ing “\$27,000,000”;  
6 (B) by striking “1994 and 1995” and in-  
7 serting “2018 through 2022”; and  
8 (C) by inserting “, in addition to any  
9 amounts otherwise made available for research,  
10 evaluation or statistical purposes in a fiscal  
11 year” before the period.
