At the end of the grant period, we have \$20,154.31 that we were not able to claim, this amount was returned to DCESP. The total amount claim for DCESP 2023 is \$529,845.69.

We asked for extra to use the money for the Large Torres Martinez Grow. Since the operation never happened, we returned money.

2023/2024 – 500,000.00. Still working on spending for this fiscal year.

Imperial Stonegarden is two years behind, so we are spending 2022 right now. 2023 and 2024 have not been awarded yet.

2020 Operation Stonegarden San Diego – Awarded \$170,000 2021 Operation Stonegarden San Diego – Awarded \$219,300

2021 was last year we were sub-recipient of San Diego.

RSO was involved in three different Stonegarden Grants. We are now the fiduciary for several "Friendly Forces" so we receive the grant money from USBP who gets it from FEMA. We disperse to all the friendly forces (other agencies).

We are also a "Friendly Force" for Imperial.

As a member of the law enforcement community and a leader making policy decisions, I am sick of battling the deeply flawed changes being made by California politicians and that of the current presidential administration. Our state and nation matter, and our citizens are afraid of the consequences of an open border. Drugs, human trafficking, and the unknown number of terrorists and bad actors entering unchecked is eye opening and terrifying. It puts our county and communities in jeopardy. Duty in government is easy to understand and it starts with the core responsibility of the job you have accepted to do. The current administration has lost their understanding of the job of government and public safety.

I can only hope and pray the obvious and necessary actions needed to protect and strengthen the United States border are taken seriously and repaired immediately.
