4	with the ad	ministration, yes.

7	place in 2020?		
8	А	I'm not an expert on those policies. My recollection is that, from the start	
9	of the pandemic, the company considered how to approach COVID from a content polic

12	2021, Donald Trump was President, correct?

14	Q	Meta's work you work on the U.S. Policy Team?

19	expressed over what Meta's policies covered and Meta's enforcement of those policies.
