After years of targeting Moms for Liberty and many others, justice could be on the way.

On April 21, 2026 the Justice Department announced indictment against Southern Poverty Law Center (SPLC). The indictment alleges SPLC secretly funneled MORE THAN \$3 MILLION in funds to members of white supremacist and extremist groups.

Moms for Liberty members are all too familiar with the SPLC's tactics as you can see from the timeline below.

December 2025 **250 companies use SPLC to screen donations**

Hundreds of companies use the software company Benevity to connect with nonprofits, allowing employees to donate their time and money, but Benevity's platform blacklists conservative nonprofits like Moms for Liberty.



October 2025 **Director Kash Patel announces directive for the FBI to cut ties with SPLC**

In this same month, Moms for Liberty National Summit hosts a major panel examining SPLC's impact.

The Heritage Foundation decides to file a lawsuit on behalf of Moms for Liberty to obtain the records.

Local and national media coverage starts to routinely lead with the SPLC's "hate group" label on anyone associated with Moms for Liberty.

Chapter leaders begin to report issues at their workplaces with connections to the SPLC's label and their association with Moms for Liberty.

The upcoming 4th of July holiday is a welcome chance to remember the freedoms we treasure and reflect on those we're still fighting for. As educators, we teach about the hard work and sacrifice that has gone into making the United States of America a more perfect union, to be the best it can be for all its citizens.

The decision to allow an 'anti-government organization' like Moms for Liberty to participate in the Round Rock & Sertoma 4th of July Parade this year is an affront to our values as Americans and an insult to the sacrifices made by our national heroes. The [Southern Poverty Law Center has identified Moms for Liberty](#) as an extremist organization. They are not for liberty. They espouse hateful rhetoric and while we, as educators, truly value everyone's right to free speech, we cannot stand by while a group is actively harming our fellow Americans. Some of their members have spoken up at our Round Rock ISD school board meetings, even endorsing candidates in the recent school board race that support book banning and targeting school employees and student groups.

We respectfully ask that the group, Moms for Liberty, be withdrawn from the upcoming parade. Their participation is insulting to freedom-loving Americans that want to honor our country's history.

Education Round Rock is a merged local union of Round Rock ISD staff. We are proud members of AFT, NEA, TSTA, and the AFL-CIO.

June 2023 **SPLC Designates Moms for Liberty as a “hate group”**

SPLC officially adds Moms for Liberty to its “Hate Map,” labeling it an “anti-government extremist group.”

Immediate Ripple Effects:

- A surge of **death threats** are reported by Moms for Liberty (see here)
- M4L forced to **increase security spending** (see here)



- **June 29:** National summit in Philadelphia faces violent protests (road blockages, harassment) (see here)



- National figures (Ted Cruz, Nikki Haley, Tim Scott, Vivek Ramaswamy, others) publicly defend Moms for Liberty

- The hacker group “Anonymous” successfully attacks Moms for Liberty, bringing down our website and other parts of our operations. (see here)
- Six Pennsylvania State Senators send a letter on Senate letterhead to the Museum of the American Revolution requested they cancel their event contract due to the SPLC Hate Group Label. (see here)



April 2023 **SPLC begins series of visits to the Biden White House**

Thanks to the lawsuit from our friends at The Heritage Foundation later in 2024, we now know in hindsight that the SPLC began a series of visits to the Biden White House between April and June.



January 2023 **Moms for Liberty starts inviting presidential candidates**

Moms for Liberty starts planning and inviting multiple presidential candidates to speak at our National Summit in July 2023



November 2022 **Massive Election Wins for Moms for Liberty**

Moms for Liberty wins **275 school board seats** in the November 2022 election. Our members flip entire school boards, even in blue states.

Barely 2 years old, if we weren't on the far left's radar before, we are now.



May 2022 **House begins investigating Biden DOJ**

The House Judiciary Committee issues a letter to Attorney General Garland beginning an investigation into the October 2021 directive that led the FBI to investigate parents protesting at school board meetings.

The claim of the investigation is that the Biden DOJ used federal law enforcement tools to intimidate or chill parents' speech, putting a spotlight on these activities.
