

Victims of Criminal Aliens Under Biden:

The border crisis has invited scores of criminals and other bad actors to our nation, many of whom crossed the southern border illegally without detection or were intercepted by authorities and then released only to victimize someone in the interior.

- **November 4, 2021:** Illegal immigrant who posed as minor while crossing border charged with murder in Florida:
 - **Victim:** Fransisco Javier Cuellar, father of four, of Jacksonville, Florida.
 - **Suspect:** In 2021, **Yery Noel Medina Ulloa**, a 24-year-old illegal alien from Honduras, who presented himself as a UAC under a fake name to Texas border officials where they **RELEASED** him to a sponsor.
 - **Suspect's Mother Knew About the Ruse:** Medina-Ulloa told his mother about his intent to use a false identity to gain entry into the U.S., where HHS and an NGO eventually took him to help with resettlement.
 - **Florida:** Florida resident Fransisco Javier Cuellar, father of four, took 17-year-old Medina into his home in Jacksonville despite no familial relation to him.
 - **Murder:** Sometime after, Medina-Ulloa brutally stabbed to death his caretaker, Cuellar, to death. Medina was found covered in blood.
- **September 24, 2021:** Afghan Allegedly Molested 12-Year-Old, 14-Year-Old Boys at Fort McCoy:
 - **Victims:** A 12-year-old boy and 14-year-old boy. Both of whom were refugees.
 - **Suspect: Bahrullah Noori**, a 20-year-old Afghan who was **PLACED** at Fort McCoy, Wisconsin as apart of Biden-Harris' **REFUGEE RESETTLEMENT OPERATION** after the Afghanistan withdrawal.
 - **Sexual Assault on Military Base:** In September 2021, Another Afghan living on the military base caught Noori molesting the two children on two separate occasions, leading him to report him to the FBI.
 - **Threats of Retaliation:** Noori reportedly threaten to beat the boys if they told anyone of the abuse.
- **September 24, 2021:** Afghan Pleads Not Guilty to Strangling Wife on Wisconsin Military Base:

- **Victim:** An Afghan refugee.
- **Suspect: Mohammad Haroon Imaad**, a 32-year-old Afghan refugee, who was **PLACED** at Fort McCoy, Wisconsin as part of Biden-Harris' **REFUGEE RESTTLEMENT OPERATION** after the Afghanistan withdrawal.
- **Strangulation of Wife:** On September 7, 2021, Imaad allegedly strangled and suffocated his wife while they were temporarily residing in Fort McCoy.
- **Warning Signs:** His wife told American soldiers at the base that her husband had a history of beating her, to the point where she lost her vision, and their children.
- **March 4, 2022: The Biden Admin Released A Suspected Terrorist Into The United States After He Illegally Crossed The Border:**
 - **Suspect: Issam Bazzi**, a 50-year-old Lebanese-born Venezuelan who was a **confirmed terrorist** based on the FBI terror watchlist.
 - **Release from the Border:** While Bazzi was detained, the FBI confirmed he has ties to an unspecified terrorist group and recommend he be detained but ICE headquarters demand he Bazzi be released due to might contract COVID-19. Bazzi was **RELEASED** into the interior under his asylum claim.
 - **Arrest in the Interior:** He has yet to be arrested and deported. Detroit is the last known location for Bazzi and his family.
- **May 24, 2022: Report: Biden's DHS Released Illegal Alien on 'Terrorism Watch List' Into U.S.:**
 - **Suspect: Insardo Garcia Amado**, a 35-year-old illegal alien from Colombia, who is a **confirmed terrorist** on the Terrorist Watchlist.
 - **Release from the Border:** On April 18, 2022, Garcia-Amado illegally crossed the southern border near Yuma, Arizona, and was **RELEASED** by Border Patrol. Officials placed him on an ATD program while he was in the interior.
 - **Arrest in the Interior:** Three days later, on April 21, the FBI flagged Garcia-Amado's status as confirmed terrorist. ICE did not receive authorization to arrest him until May 4.

- **October 16, 2022: Illegal Aliens, Released Into U.S. By Biden's DHS, Linked to Robbery Gang In Sanctuary State New York:**
 - **Victims:** Burglarizing between 20 to 30 homeowners in Long Island, New York.
 - **Suspects:**
 - **Brayan Alexis Ortiz-Ramos**, a 20-year-old illegal alien from Colombia. He illegally crossed the southern border near San Lis, Arizona and was **RELEASED** with and immigration court date set for July 2023.
 - **Daniel Esteban Jiminez-Carillo**, a 30-year-old illegal alien from Colombia. He illegally crossed the southern border near San Ysidro, California, in June 2022 – he was subsequently **RELEASED** without a scheduled immigration court date.
 - **Gersson Jhoan Hernandez-Gomez**, a 33-year-old illegal alien from Colombia. He illegally crossed the southern border near Hidalgo, Texas and was **RELEASED** into the interior while being placed into deportation proceedings.
 - **Burglary:** Burglarized between 20 to 30 homeowners in Long Island, New York.
- **January 20, 2023: Illegal MS-13 Gang Member Accused of Murdering 20-Year-Old Kayla Hamilton:**
 - **Victim: Kayla Hamilton**, a 20-year-old with autism living in Aberdeen, Maryland.
 - **Suspect:** Walter Martinez, a 16-year-old from El Salvador who illegally crossed the Texas border in March 2022, posing as a UAC and was **RELEASED** into the country to a sponsor. HHS failed to properly vet Martinez, as he was **CONFIRMED** MS-13 gang member with an arrest record and is believed to have killed others.
 - **Brutal Assault and Rape:** In July 2022, Martinez talked his way into Kayla's home, where he proceeded to **strangle and rape her to death.** Kayla attempted to call her boyfriend for help, but the call went to voicemail, where her cries for help could be heard.
- **February 10, 2023: Illegal Alien, Freed Into U.S. By Biden DHS, Now Wanted for Drug Trafficking in Brazil:**

- **Suspect:** Diogo De-Sales Gomes, a 34-year-old Brazilian national who illegally crossed the southern border near San Luis, Arizona, in December 2021.
 - **Release from the Border:** He was **RELEASED** on his own recognizance with an NTA. DeSales Gomes failed to appear for his hearing.
 - **Arrest in the Interior:** On February 3, 2023, ICE arrested him in Somerville, Massachusetts. De-Sales Gomes had an active **criminal warrant for drug trafficking in his home country of Brazil.**
- **May 16, 2023: Illegal Alien, Charged with Raping Teen Girl, Released into U.S. by Biden's DHS:**
 - **Victim:** A teenage girl in Prattville, Alabama.
 - **Suspect: Grevi Geovanni Rivera-Zavala**, a 29-year-old illegal alien from Honduras who crossed the southern border illegally in November 2021 using a fake name and was **RELEASED** and wound working in the construction industry in Prattville.
 - **Rape:** Rivera-Zavala forced the victim into a bathroom stall in a women's restroom at a restraint where he proceeded to rape her, a random attack, according to sources.
 - **Criminal Record:** Rivera-Zavala had a criminal record in Honduras.
- **June 5, 2023: Migrant arrested, charged with capital murder in death of another migrant:**
 - **Victim: Carmen Unilda Navas-Zuniga**, a 40-year-old Honduran national.
 - **Suspect: Eddy Ortega-Alvarado**, a 34-year-old illegal alien from Venezuela who crossed the border and was **RELEASED** by Border Patrol on May 20, 2023.
 - **Murder:** On May 21, 2023, police found Navas-Zuniga dead in a motel in downtown El Paso. Authorities said she was robbed and unresponsive in her room, which she shared with Ortega-Alvarado. Police charged him with capital murder after they believed he took her money and fled to the Dallas-Fort Worth area.

- **August 27, 2023: Illegal Alien, Freed into U.S. by Biden's HHS, Denied Bail for Allegedly Raping and Murdering 11-Year-Old Girl:**
 - **Victim: Maria Gonzalez**, an 11-year-old girl from Guatemala residing in Pasadena, Texas.
 - **Suspect: Juan Carlos Garica-Rodriguez**, who arrived at the southern border in January 2023, as a 17-year-old UAC from Guatemala, was transferred into HHS custody, where he was **RELEASED** to an adult sponsor in Shreveport, Louisiana.
 - **Strangulation and Rape:** On August 12, 2023, Maria texted her father that someone (Garcia-Rodriguez) was at the door. Family members arrived to check on her, only to find Maria's body raped and strangled to death in a laundry basket underneath her bed.

- **August 28, 2023: Illegal Alien, Freed into U.S. from Southern Border, Charged with Killing 11-Year-Old Aiden Clark:**
 - **Victim:** 11-year-old middle school student **Aiden Clark** of Ohio who was killed on his first day of school in August 2023.
 - **Suspect:** A 35-year-old illegal alien from Haiti who was paroled and **RELEASED** into the country in August 2022.
 - **Homicide:** In August 2023, the illegal alien was driving and struck a school bus in Ohio full of children, resulting in the bus flipping and ejecting Aiden from the bus, killing him.

- **September 20, 2023: Peruvian illegal immigrant's alleged murder victim is US citizen, sheriff confirms:**
 - **Victim:** A 40-year-old man from Houston who was a U.S. citizen.
 - **Suspect: Roberto Emilio Vasquez-Santamaria**, a 64-year-old illegal alien from Peru, crossed the southern border into Eagle Pass in May 2023 and was **RELEASED** into the interior with an NTA, with a court date until 2025.
 - **Murder:** In September 2023, Vasquez-Santamaria got into a physical confrontation with the victim in his house in Eagle Pass and struck him in the head.
 - **Alternative to Detention:** On May 8, Vasquez-Santamaria was enrolled in ATD with instructions to report to the ICE Miami field office. Once he complied with the instructions, he was released from ATD.

- **November 2, 2023: ICE arrests African illegal immigrant, wanted in Senegal for terrorist offenses, who was released into US:**
 - **Suspect:** A 29-year-old illegal alien from either Mauritania or Senegal wanted for criminal conspiracy in relation to a terrorist organization; destruction, degradation and damages in relation to a terrorist organization; direct provocation of an armed crowd and acts (or preparatory acts) aimed at compromising public safety in his home country.
 - **Release from the Border:** On October 3, 2023, the suspect illegally crossed the southern border near Lukeville, Arizona, where was **RELEASED** with an NTA in New York City.
 - **Arrest in the Interior:** On October 3, 2023, a week later, ICE arrested the individual in New York City.

- **November 6, 2023: Virginia Sanctuary County Frees From Jail Illegal Alien Accused of Child Rape After Biden's DHS Freed Him into U.S.:**
 - **Victim:** A 13-year-old residing in Northern Virginia.
 - **Suspect:** An illegal alien from Peru crossed the southern border without authorization in March 2022 and was **RELEASED** with an NTA.
 - **Rape:** In July 2023, the illegal alien was arrested in Herndon, Fairfax County and charged with two counts of felony sodomy of a victim under the age of 13, two counts of felony sexual penetration of a victim under the age of 13, three counts of aggravated sexual battery of a victim under the age of 13, and one count of misdemeanor French kissing a child under the age of 13.
 - **Sanctuary Jurisdiction:** ICE lodged a detainer asking Fairfax County to hold the alien until it could have agents take custody – the County **RELEASED** the Honduran national back into the community, defying federal authorities.
 - **Rap Sheet:** In October 2022, five months after arriving to the U.S., the suspect was arrested for petit larceny in Fairfax County but had his conviction deferred by a judge.

- **November 7, 2023: Illegal Migrant Released By Border Patrol Charged With Rape After Local Police Ignored ICE And Let Him Go:**

- **Victim:** Family member in Herndon, Virginia.
 - **Suspect:** An illegal alien from Honduras who crossed the southern border illegally near Roma, Texas, in June 2021. He was **RELEASED** by Border Patrol.
 - **Felony Rape and Abduction:** On October 12, 2023, the Honduran national was arrested for rape, kidnapping, and assault.
 - **Rap Sheet and Sanctuary Jurisdiction:** In July 2023, the alien was arrested rape by force, threat or intimidation; abduction by force and assault on family member – ICE lodged a detainer, but Fairfax County **RELEASED** him instead of honoring the detainer.
- **December 8, 2023:** ICE Nabs Fugitive Wanted For Assaulting Child Who Was Previously Released By Border Patrol:
 - **Suspect:** A 35-year-old Brazilian national who was convicted of bodily injury and threatening a minor in 2014.
 - **Release from the Border:** In September 2021, the suspect illegal crossed the southern border near San Luis, Arizona, where she was **RELEASED** into the interior.
 - **Arrest in the Interior:** In December 2023, two years later, the Brazilian national was arrested by ICE in Worcester, Massachusetts.
- **January 18, 2024:** Immigration officials detain man arrested in Boston for alleged rape of disabled person:
 - **Victim:** A developmentally disabled person in Massachusetts.
 - **Suspect: Pierre Lucard Emile** is a 31-year-old Haitian national who appeared at a port of entry in Brownsville, Texas, in December 2022. He was deemed inadmissible but was **RELEASED** into the interior with an NTA.
 - **Rape of Disabled Person:** In September 2023, Boston police arrested Emile **for rape and indecent assault and battery on a developmentally disabled person.**
 - **Sanctuary Nonsense:** ICE lodged a detainer with the Dorchester District Court, but the court **RELEASED** from jail into electronic monitoring.

- **January 29, 2024: Terrorist Caught Illegally Crossing The Border Was Allowed To Roam Free For Nearly A Year, Memo Says:**
 - **Suspect:** An illegal alien who was a confirmed member of the terrorist organization al-Shabaab.
 - **Release from the Border:** On March 13, 2023, the alien illegally crossed the border near San Ysidro, California. The Terrorist Screening Center “deemed him a ‘mismatch’” after running his name through the terror watchlist where he was eventually **RELEASED** into the interior.
 - **Arrest in the Interior:** On January 18, 2024, nearly a year later, the Terrorist Screening Center “made a redetermination” that the individual was “a confirmed member of al-Shabaab” and was involved in the use, manufacture or transport of explosives or firearms – ICE arrested the alien two days later in Minnesota.

- **February 7, 2024: Illegal Alien Freed into U.S. by Biden’s DHS Charged with Killing Young Mother, Toddler:**
 - **Victims:** 20-year-old Anjelica Guadalupe Amaya Briceno and her Three-Year-Old Daughter in Montgomery County, Pennsylvania.
 - **Suspect:** Bryan Alejandro Gonzalez-Perez, a 22-year-old illegal alien from Venezuela, was paroled and **RELEASED** under Biden at an unknown time.
 - **Homicide:** In January 2023, Gonzalez-Perez was driving 70 to 80 miles per hour, when the speed limit was 35 mph, without a license when he stuck Anjelica and her daughter, killing both of them.
 - **Bottom Line:** Yet **ANOTHER** instance of an alien who **SHOULD HAVE** been detained instead of being released only to take the life of a young mother and her child.

- **February 7, 2024: Illegal Alien Charged with Sexually Abusing Virginia Girl After Being Freed into U.S. by Biden’s DHS:**
 - **Victim:** A 14-year-old girl in Campbell County, Virginia.
 - **Suspect: Renzo Mendoza Montes**, a 32-year-old illegal alien from Venezuela, who crossed the border illegally and was **RELEASED** into the interior in September 2023.

- **Sexual Assault:** On February 22, 2024, Mendoza-Montes was arrested and charged with carnal knowledge of a child without force and one felony charge taking indecent liberties with a child in Cambell county.
- **More:** According to authorities, Montes knew the 14-year-old victim. The incident occurred in January, months after he crossed the border.
- **February 9, 2024: Pakistani Illegal Immigrant On Terror Watchlist Given Free Day of Release In US:**
 - **Suspect:** On November 9, 2023, a Pakistani national who illegally crossed the southern border into Tecate, California, **whose name appeared on the terror watchlist**. On November 11, 2023, the national expressed he had “credible fear” of returning to Pakistan after Border Patrol hit him with an expedited removal order.
 - **Release from the Border:** On November 22, 2023, while in Border Patrol custody, the Terrorism Screening Center confirmed the alien was a positive match on the terror watchlist. Despite this information, he was **RELEASED** on ATD on January 23, 2024.
 - **Arrest in the Interior:** On January 24, 2024, the Los Angeles ICE field office was notified of the Pakistani alien’s presence on the terror watchlist and were able to arrest him once the national reported to the office for a check-in.
- **February 22, 2024: The Consequences of the Biden-Harris Administration’s Open-Borders Policies: The Case of the Illegal Aliens Who Killed Laken Riley:**
 - **Victim: Laken Hope Riley**, a 22-year-old nursing student who attended Augusta University.
 - **Suspect: Jose Ibarra**, a 26-year-old Venezuelan national who was **PAROLED** and **RELEASED** into the U.S. after he illegally crossed the border into El Paso in September 2022.
 - **Murder and Attempted Sexual Assault:** On February 22, 2024, Jose Ibarra allegedly murdered 22-year-old Georgia nursing student Laken Riley. Laken’s “body was found on the University of Georgia campus after going for a run.” Ibarra beat her to death after Laken tried to fight him off, as Ibarra was trying to sexually assault her.

- **Career Criminal:** Ibarra began his crime spree in the U.S. after applied for ASYLYM in May 2023.
 - **New York City Arrest:** Ibarra wound up in New York City where he was arrested for endangering a 5-year-old child in August 2023 but was **RELEASED** by local authorities before ICE could lodge a detainer.
 - **Georgia Arrests:** Ultimately, Ibarra ended up in the Athens, Georgia area where was **arrested three times** between September 2023 and December 2023. He was arrested for DUI, driving without a license, and shoplifting.
- **March 17, 2024: Haitian immigrant charged with raping 15-year-old girl in migrant hotel: prosecutors:**
 - **Victim:** 15-year-old migrant girl who was staying at a hotel that was housing illegal aliens.
 - **Suspect: Cory Alvarez,** a 26-year-old Haitian national who was **PAROLED** through the CHNV program. Alvarez took a plane from Haiti to New York City with a sponsor in New Jersey.
 - **Sexual Assault:** While Alvarez was staying at the hotel located in Rockland Massachusetts, he raped a 15-year-old girl.
- **March 19, 2024: Illegal migrant charges with stabbing 2 men in Missouri laundromat: 'Violent ambush':**
 - **Victims:** Two brothers, one of whom was neighbors with the suspect.
 - **Suspect: Jose Barrera Amaya,** an illegal alien who unlawfully crossed into Eagle Pass, Texas, in 2021, and was **RELEASED.**
 - **Double Stabbing at Laundromat:** On March 17, 2024, **Barrera-Amaya** purportedly 'ambushed' his neighbor and his brother at a laundromat in O'Fallon, Missouri, where **he stabbed both in the back with a pocketknife.** According to ICE, the suspect killed people with a machete in Honduras.
- **March 21, 2024: Biden Administration Releases Colombian Drug Lord After Apprehension At Border:**

- **Suspect: Aderbis Segundo Pirela-Pirela**, a 29-year-old illegal alien from Venezuela who was on Interpol's most wanted list for murder, extortion, and drug dealing in Colombia. Pirela is reportedly a top member of the Colombian drug gang Stanas, which harbors ties to the Venezuelan prison gang Tren de Aragua.
 - **Release from the Border:** On January 2, 2024, Pirela crossed the southern border illegally into Eagle Pass where he was **RELEASED** a few days later with an NTA on January 5.
 - **Arrest in the Interior:** On March 14, 2024, law enforcement located and arrested Pirela in New Braunfels.
- **April 11, 2024: Man on terror watchlist was released by Border Patrol:**
 - **Suspect: Mohammad Kharwin**, a 45-year-old Afghan national who was a confirmed member of terrorist organization Hezb-e-Islami.
 - **Release from the Border:** Kharwin illegal crossed the southern border near San Ysidro, California, on March 10, 2023. CBP took his biometrics data and **RELEASED** him to ICE without flagging his suspected ties to terrorism that Border Patrol found one a piece of Kharwin's information matched a person on the terrorist watchlist.
 - **Arrest in the Interior:** ICE placed him into ATD where he was free to roam. In February 2024, the FBI passed information to ICE indicating that Kharwin had potential terrorist ties and might pose a risk to national security. Soon after, nearly a year after he was released near the border, ICE agents conducted an operation and arrested Kharwin in San Antonio on Feb. 28, 2024.
 - **More:** Kharwin was held in ICE detention until his court hearing March 28, 2024, when he appeared before an immigration judge in Pearsall, Texas.
 - **More:** When ICE prosecutors appeared in court, they did not share some classified information with the judge that purportedly showed Kharwin's ties to HIG, two U.S. officials said. Prosecutors argued that he should be detained without bond because he was a flight risk, but they did not say he was a national security risk, according to sources familiar with the case.
 - **More:** On March 30, 2024, ICE released Kharwin after he paid the \$12,000 bond mandated by the immigration judge; he was later arrested by ICE in April.

- **April 17, 2024: Haitian migrant, now a double homicide suspect, was allowed into US by Biden admin via controversial app:**
 - **Victims:** Two Haitian nationals were allegedly murdered by their roommate in Middletown, New York.
 - **Suspect: Kenol Baptiste**, an illegal alien from Haiti, presented himself at the El Paso sector on July 25, 2023, after scheduling an appointment via the CBP One app where he was paroled and **RELEASED** with an NTA.
 - **Murders:** On April 1, 2024, Baptiste stabbed his two roommates to death. One died on scene while the other later passed away during surgery.

- **April 17, 2024: Suspect in death of Sen. Cortez Masto's adviser entered US illegally in 2021: DHS:**
 - **Victim: Kurt Englehart**, a 38-year-old campaign and senior adviser for Sen. Cortez-Masto (D-Nev.) based in Nevada. Kurt worked for the senator since 2017.
 - **Suspect:** Elmer Rueda-Linares, an 18-year-old illegal alien, who crossed the border illegally in the Rio Grande City, Texas, area on March 12, 2021 – he was subsequently **RELEASED** by border officials.
 - **Hit-and-Run:** On April 6, 2024, Rudea-Linares was driving in Washoe County, Nevada, where he struck Kurt's vehicle, killing him. Rudea failed to stop after the car collision.

- **April 18, 2024: Sanctuary Massachusetts: Illegal Alien Accused of Raping Child After Being Freed into U.S.:**
 - **Victim:** A minor under 16-years-old in Milford, Massachusetts.
 - **Suspect:** A 20-year-old Brazilian national who crossed the Arizona border with his parents illegally in July 2021. He was **RELEASED** with an NTA.
 - **Rape of a Minor:** In December 2023, the Milford Police Department issued a warrant for the Brazilian national's arrest for child rape charges and enticement of a child under 16 years old.
 - **Previous Arrests:** In August 2023, the Brazilian national was arrested for motor vehicle violations in Billerica, Massachusetts. Those charges were later dismissed.

- **April 19, 2024: Biden's Border Honor System Frees Illegal Alien Convicted Killer Into U.S.:**
 - **Suspect:** A 44-year-old illegal alien from Colombia who was convicted for premeditated murder and sentenced to four years in prison in April 2016.
 - **Release from the Border:** The alien illegal crossed the border in on September 30, 2022, and lied to border officials saying he had never been arrested in the U.S. or Colombia. He was given an NTA and placed in ICE custody on October 6, 2022, where he was **RELEASED** from its custody on November 10, 2022, through ATD.
 - **Arrest in the Interior:** A year later, on November 7, 2023, ICE discovered the alien's conviction in his home country and arrested him on April 3, 2024, roaming the U.S. for over a year.

- **April 26, 2024: Illegal Alien Accused of 'Extremely Gruesome' Murder of Young Mother, 4-Year-Old Daughter in FL:**
 - **Victims:** Amalia Coc Choc de Pec, a 36-year-old mother and her 4-year-old daughter Estrella Anastasia Pec Coc of Dover, Florida.
 - **Suspect: Angel Gabriel Cuz-Choc,** a 31-year-old illegal alien from Guatemala who crossed illegal crossed the southern border in September 2023. Cuz-Choc was **WANTED** for two separate murders back in Guatemala.
 - **Double Murder:** On April 25, 2024, Amalia and her daughters' bodies were found lying in pools of blood in their home by a roommate – Cuz-Choc savagely stabbed them to death. He was in a romantic relationship with Amalia and lived with her and Estrella, her daughter.

- **April 30, 2024: Illegal Wanted for Murder Among Nearly 2M 'Got-Aways' at Biden's Border:**
 - **Suspect: David Antonio Hernandez-Ventura,** a 26-year-old illegal alien from Mexico crossed the border illegally three separate times in 2021: March 30, April 1, and April 8. He was caught each time but successfully infiltrated the southern border as a **GOTAWAY** after May 2023.
 - **Arrest in the Interior:** Hernandez-Ventura was arrested on local criminal charges in Fresno, California, on December 2, 2023. ICE arrested him on

January 24, 2023, where he was later ordered deported on February 8. He is wanted for **MURDER** in Mexico.

- **May 6, 2024: Illegal Alien Accused of Sexually Assaulting 11-Year-Old Girl After Being Freed into U.S. by Biden's DHS:**
 - **Victim:** An 11-year-old girl in Palm Beach County, Florida.
 - **Suspect: Marvin Perez-Lopez**, a 20-year-old illegal alien from Guatemala who illegally crossed the southern border in January. He was **RELEASED** into the interior with an assigned court date to appear before an immigration judge in 2027.
 - **Sexual Assault of Minor Under 13:** The mother of the victim went looking for her daughter when she realized she was not inside their residence at the apartment building. She found her daughter inside a van with a man, later identified as Lopez, who also lives in the building. According to the girl, the illegal alien started touching her and she responded by pushing him away.
- **May 13, 2024: Catch and Release: Biden's DHS Freed Illegal Alien Convicted Killer into U.S.:**
 - **Suspect:** A 49-year-old illegal alien, whom ICE did not identify, was arrested in Bucaramanga, Colombia, on April 5, 2014, and charged with aggravated homicide, aggravated theft, and possession of a weapon. In September 2016, the illegal alien was convicted and sentenced to 17 years in prison.
 - **Release from the Border:** On November 27, 2023, Border Patrol agents **apprehended** the illegal alien after he crossed the border near San Luis, Arizona. He was given an NTA before a federal immigration judge and **RELEASED** into the interior.
 - **Arrest in the Interior:** On May 6, 2024, ICE agents arrested the illegal alien at his residence in Pittsfield after learning that he was a convicted killer and fugitive in his native Colombia. He will remain in ICE custody pending his deportation from the U.S.
- **May 28, 2024: Biden's Catch and Release: Criminal Illegal Alien, Freed Into U.S., Charged With Murdering West Virginia Woman:**
 - **Victims:** A 33-year-old woman in Berkley County, West Virginia. Two homeless people Jefferson County, West Virginia.

- **Suspect: David Antonio Calderon**, a 46-year-old illegal alien from El Salvador who served time in prison at an El Salvador prison from January 1999 to August 2021 for drunk driving, sexual assault, murder, aggravated robbery, and drug crimes. In March 2023, Calderon sought asylum in Canada but was denied and was turned over to DHS authorities where northern border officials **RELEASED** him into the interior with an NTA.
- **Murder and Separate Assaults:** On May 6, 2024, West Virginia police found the burned body of 33-year-old woman after firefighters extinguished a couch that was set on fire – she was reported missing from Jefferson County’s home confinement program. In April, two homeless individuals were attacked at random with a baseball bat. Police allege Calderon is responsible for both crimes.
- **May 29, 2024: Wisconsin: Illegal Alien Mother Accused of Letting Illegal Alien Man Rape Her Daughter:**
 - **Victim:** A 12-year-old girl in Oakfield, Fond du Lac County, Wisconsin.
 - **Suspects: Juan Carlos Rocha-Meija**, a 31-year-old illegal alien from Nicaragua, illegally crossed the southern border into Texas in October 2021 and was **RELEASED** into the interior by authorities. He was charged with has been arrested and charged with first-degree sexual assault, child enticement, strangulation, and false imprisonment.
 - **Exploitation of Child:** Rocha-Meija allegedly paid Antonio more than \$250 to Antonio to be alone with her 12-year-old daughter, who proceeded to transport her to a remote area and blindfolded and restrained where he sexually assaulted her. The girl escaped from the vehicle where she was held captive.
 - **More:** He was charged with has been arrested and charged with first-degree sexual assault, child enticement, strangulation, and false imprisonment.
- **June 3, 2024: Migrant accused of shooting two NYPD cops had immigration case dismissed within a year of illegally crossing into US:**
 - **Victims:** NYPD Officer **Richard Yarusso**, 26, who was struck in his vest; NYPD Officer **Christopher Abreu**, 26, who was struck in the leg.
 - **Suspect: Bernardo Castro-Mata**, a 19-year-old Venezuelan who illegally crossed the southern border into Eagle Pass, Texas, in July 2023. He was **RELEASED** into the interior.

- **Case Dismissal:** On May 6, 2024, Castro-Mata had an immigration hearing in Chicago where the judge closed his case, allowing him to remain in the country.
 - **Shooting:** On June 3, 2024, NYPD officers Yarusso and Abreu attempted to detain Castro-Mata riding his moped for a traffic violation in Queens. Castro-Mata opened fire on the officers, wounding both of them.
 - **Suspected Rap Sheet:** He is suspected of helping attack two women during a robbery, in addition to other crimes. Castro-Mata is suspected of being a member of the Venezuelan gang Tren de Aragua.
- **June 6, 2024: Illegal Alien Charged With Raping Disabled Person Was Freed Into U.S. By Biden's DHS:**
 - **Victim:** A Rhode Island resident with a severe mental handicap.
 - **Suspect: Rigberto Hoyos-Alban**, a 33-year-old illegal alien from Colombia who illegally crossed the southern border near Rio Grande Valley, Texas, in November 2023. He was **RELEASED** into the interior with an NTA.
 - **Sexual Assault:** In March 2024, Hoyos-Alban was arrested by the Central Falls Police Department and charged with two counts of first-degree sexual assault, two counts of second-degree sexual assault, and one count of felony assault on a person mentally impaired.
 - **Sanctuary Stupidity:** Following his arrest, ICE lodged a detainer against Hoyos-Alba, requesting Rhode Island Adult Correctional Institute to detain him. The request was **IGNORED**, and correctional officials **RELEASED** back into the community.
 - **June 17, 2024: Illegal immigrant suspected in Rachel Morin's murder went on months-long terror-spree:**
 - **Victim: Rachel Morin**, 37, Maryland mother of 5.
 - **Suspect: Victor Antonio Martinez-Hernandez**, a 23-year-old illegal alien from El Salvador who illegally crossed the southern border **four times within two months**, with his last trying being successful, entering as a **GOTAWAY** sometime between February and March 2023.
 - **Murder:** In August 2023, Rachel went missing after going for a walk on the Ma and Pa Heritage Trail in Bel Air; her body was found **MURDERED and RAPED** a day later in a nearby culvert. In June 2024, law enforcement

arrested Martinez-Hernandez for Rachel Morin's at a bar in Tulsa, Oklahoma, after he was named as the culprit a month earlier.

- **Rap Sheet:** On March 26, 2023, Martinez-Hernandez allegedly attacked a 9-year-old girl and her mom during a brutal home invasion in Los Angeles. He is suspected of murdering a young woman in El Salvador before entering the U.S.
- **June 20, 2024: Prosecutors: Migrant Filmed Himself Raping Girl at Knifepoint in NYC Park:**
 - **Victim:** A 13-year-old girl in East Flushing, Queens.
 - **Suspect: Christian Inga**, a 25-year-old illegal alien from Ecuador who illegally crossed the southern border with his three-year-old son near Eagle Pass, Texas in June 2021. He was **RELEASED** into the interior with an NTA.
 - **Sexual Assault in Broad Daylight:** On June 13, 2024, Inga approached two 13-year-olds who had just gotten out of school near Kissena Park in East Flushing, Queens, and demanded they him into a wooded area near the park. Inga **tied the children and proceeded to RAPE the 13-year-old girl at machete point while recording the act.**
 - **Run-ins with the Police and Deportation Order:** Inga was ordered to be deported by an immigration judge in February 2022. He also had three encounters with police, all resulting in summonses: One for having an open container in December 2022, one for jumping a subway turnstile in March 2023, and another for trespassing in May 2023.
- **June 21, 2024: Reports: Biden's DHS Freed Illegal Aliens Into U.S. Who Are Now Accused of Murdering Jocelyn Nungaray:**
 - **Victim: Jocelyn Nungaray**, a 12-year-old girl in Houston.
 - **Suspects: Johan Jose Martinez-Rangel**, 22, and **Franklin Pena**, 26, illegal aliens from Venezuela. Martinez-Rangel illegally crossed the southern border near El Paso, Texas, and was **RELEASED** into the interior with an NTA. Pena illegally in March 2024. Rangel illegally crossed into El Paso in May 2024 and was also **RELEASED** into the interior with an NTA.
 - **Jocelyn's Rape and Murder:** On June 16, 2024, Jocelyn snuck out of her apartment building after her mother slept. Surveillance footage revealed that she was alongside the two Venezuelan illegal aliens at a 7/11 convenience store. Sometime later, between 1:00 and 2:00 am, Martinez-Rangel and Pena

RAPED Jocelyn before **STRANGLING** her to death and left her body in a creek located under a bridge.

- **June 21, 2024:** **Illegal immigrant in Iowa pleads guilty to Sexually Assaulting 12-year-old girl:**
 - **Victim:** A 12-year-old girl in Waterloo, Iowa.
 - **Suspect: Juan Manuel Dubon-Benitez**, an 18-year-old illegal alien from Honduras who unlawfully crossed the southern border near Hidalgo, Texas, in April 2022. He was **RELEASED** into the interior.
 - **Sexual Assault on Minor:** On February 14, 2024, Dubon-Benitez was arrested on suspicion of **SEXUAL ABUSE** of a 12-year-old girl. He pleaded guilty to a reduced charge in May 2024.
- **June 27, 2024:** **Turkish migrant arrested for allegedly raping 15-year-old in his car in Albany:**
 - **Victim:** A 15-year-old girl in Albany, New York.
 - **Suspect: Sakir Akkan**, a 21-year-old illegal aliens from Turkey who unlawfully crossed the southern border near San Diego, California, in November 2023. Due to “lack of detention space,” he was **RELEASED** into the interior days later with a 2025 court date.
 - **Rape of 15-Year-Old in Car:** On May 14, 2024, Akkan allegedly had a 15-year-old girl, who ran away from a local group home, in his car whom he threatened to strike with a metal pole if she fled the vehicle. **He reportedly took the girl’s clothes off and RAPED her.**
- **June 27, 2024:** **Illegal migrant suffocated Syracuse woman, 21, he’d known since childhood on her birthday, buried her body in park: cops:**
 - **Victim: Joselyn Jhoana Toaquiza**, a 21-year-old from Ecuador residing in upstate New York.
 - **Suspect: Jhon Moises Chacaguasay-Ilbis**, a 21-year-old illegal alien from Ecuador, who crossed the border without authorization in El Paso, Texas, in January 2023. He was **RELEASED** into the interior “because there wasn’t enough space to hold him” without a tracking device.

- **Suffocation to Death:** On June 18, 2024, Joselyn traveled to meet Jhon at his Airbnb in Syracuse for her birthday. At some point during the visit, Chacaguasay-Ilbis allegedly suffocated Joselyn to death; he was seen carrying her body on surveillance video. Jocelyn's body was found in a shallow grave in upstate New York. Both are believed to have attended elementary school in Ecuador together.

- **July 24, 2024: Illegal immigrant facing 18 years in prison for homicide captured in Maryland:**
 - **Suspect:** A 35-year-old illegal alien from Colombia who was convicted of aggravated homicide in his home country in 2017. He was sentenced to 17 years in prison and managed to flee from Colombia.
 - **Release from the Border:** In April 2022, the Colombian national illegally crossed into Arizona. He was **RELEASED** into the interior with an NTA and enrolled in Alternatives to Detention. He left the U.S. to return to Colombia and came back to the U.S.
 - **Arrest in the Interior:** On June 20, 2024, ICE arrested him at his residence in Lanham, Maryland.

- **July 24, 2024: Salvadoran fugitive convicted of attempted aggravated femicide arrested in Maryland:**
 - **Suspect:** A 57-year-old illegal alien from El Salvador who was convicted of attempted aggravated femicide and culpable injury on June 29, 2023, and was sentenced to 21 years in prison.
 - **Release from the Border:** On July 1, 2023, the Salvadoran national illegally crossed into the southern border, near Rio Grande, Texas, where Border Patrol transferred the fugitive to ERO Harlingen on July 7, 2023. He was **RELEASED** into the interior with an NTA on August 16, 2023. Authorities were unaware of his criminal history.
 - **Arrest in the Interior:** On June 20, 2024, ICE arrested the Salvadoran alien near his residence in Gaithersburg, Maryland.

- **July 27, 2024: Brazilian Fugitive Wanted for Rape Arrested By ICE Boston After Entering Country in Arizona:**

- **Suspect:** A 23-year-old Brazilian national who illegally crossed the Southwest border near Lukeville, Arizona, on July 12, 2023.
 - **Release from the Border:** The illegal alien was **RELEASED** on his own recognizance with an NTA two days later.
 - **Arrest in the Interior:** On July 23, 2024, ICE arrested the alien after it was discovered he was wanted on criminal charges relating to the rape of a 13-year-old child in Brazil.
- **July 28, 2024: Illegal migrant shoots Texas police officer with rifle after domestic violence call, sources say:**
 - **Victim:** A San Antonio Police Department officer who had less than three years of service.
 - **Suspect:** Jorge Chacon-Gutierrez, a 25-year-old illegal alien from Venezuela, who illegally crossed into Eagle Pass, Texas, in November 2023. He was **RELEASED** into the interior with a court date set for April 2026.
 - **Domestic Violence Turned Shooting:** On July 28, 2024, around 3:15 am, three SAPD officers responded to a domestic violence call at the 1300 block of Patricia Drive. Upon arrival, officers observed a female who incurred physical injuries purportedly inflicted by her boyfriend. The suspect was found lying in bed with a rifle by his side. At some point, gunfire erupted, striking one of them multiple times, resulting in her hospitalization.
- **August 1, 2024: Illegal Migrant Arrested for Ditching Baby in Dumpster Immediately After Giving Birth in Taco Truck:**
 - **Victim:** A newborn baby named Gabriel.
 - **Suspect: Everilda Cux Ajtzalam**, an 18-year-old illegal alien from Guatemala who illegally crossed the border in the Rio Grande Valley sector in April 2023 as an unaccompanied alien minor. She was **RELEASED** into the interior to a sponsor and was ordered deported last July during a hearing she failed to appear for.
 - **Leaving Newborn Baby in a Dumpster:** On July 21, 2024, Ajtzalam gave birth to her newborn baby in a taco truck and then tossed the infant into a dumpster behind an apartment complex in southwest Houston. First responders were able to rescue Gabriel from the trash bag he was in.

- **August 1, 2024:** Guatemalan fugitive wanted for child abuse deported from Texas:
 - **Victim:** Unnamed aggravated assault child victim.
 - **Suspect:** Lina Elizabeth Chilel Bail, a 30-year-old illegal alien from Guatemala who illegally crossed into McAllen, Texas, on September 30, 2022. She was **RELEASED** on her own recognizance on October 5, 2022.
 - **Abuse of a Child:** On August 30, 2023, Chilel-Bail was arrested for aggravated assault causing serious bodily injury of a child.

- **August 3, 2024:** ERO Boston arrests Brazilian fugitive in Fall River wanted for rape:
 - **Suspect:** A 55-year-old Brazilian national who illegally crossed the northern border in Detroit, Michigan, on April 26, 2024.
 - **Release from the Border:** Border officials **RELEASED** the illegal alien into the interior
 - **Arrest in the Interior:** On July 31, 2024, ICE arrested the Brazilian national after discovering he was wanted in his home country to serve prison time for an October 2023 rape conviction.

- **August 7, 2024:** Venezuelan migrant with suspected gang ties released into US before ‘terrorizing’ NYC – and has yet to be deported:
 - **Victims:** Terrorized numerous residents across New York City, including an undercover police officer, an assaulted bystander, and a uniformed NYPD officer.
 - **Suspect: Daniel Hernandez Martinez**, a 30-year-old illegal alien from Venezuela who illegally entered the U.S. as a **GOTAWAY** after January 2023. He is a documented member of the Tren de Aragua gang.
 - **22 Crimes Committed:** Between June 2023 and November 2023, Hernandez-Martinez committed at least 22 criminal offenses in NYC, leading eight times on 14 charges, some of which were dropped. ICE lodged a detainer on him in September 2023.

- **August 12, 2024:** NYC migrants – including one charged in sex assault 4 months ago – raped woman at knifepoint, beat her boyfriend: sources:
 - **Victims:** A 46-year-old woman and her 34-year-old boyfriend residing in Coney Island.
 - **Suspects:** **Daniel Davon-Bonillo**, a 24-year-old Nicaraguan national who illegally crossed through Eagle Pass, Texas, on December 7, 2022, and **Leovando Moreno**, a 37-year-old Mexican national. Davon-Bonillo was arrested in April 2023 for allegedly raping a woman at migrant shelter while Moreno was arrested for public lewdness in August 2022.
 - **Rape at Knifepoint at Coney Island:** On August 12, 2024, the two foreign nationals attempted to rape a 46-year-old woman on the Coney Island boardwalk and assaulted her boyfriend who tried to defend her.
- **August 13, 2024:** Migrant charged with rape in third NYC sex crime bust of an asylum seeker in two weeks:
 - **Victims:** A 36-year-old woman in the Bronx.
 - **Suspect:** **Papa Diop**, a 38-year-old Senegalese national who illegally crossed into Yuma, Arizona, in May 2023. He was **RELEASED** into the interior due to a lack of detention space and was given a work permit with a 2029 expiration date after he applied for asylum.
 - **Sexual Assault in the Bronx:** On August 5, 2024, Diop allegedly sexually assaulted a 26-year-old Bronx woman at a park bench.
- **August 14, 2024:** Machete-wielder at Capitol was illegal immigrant despite being a ‘priority’ for detention:
 - **Suspect:** On August 21, 2022, Venezuelan illegal alien **Jose Leonardo Marquez-Marquez** crossed into Eagle Pass without authorization. After border officials determined Marquez-Marquez had no criminal record, he was **RELEASED** into the interior with an NTA.
 - **More:** During his check-in at an ICE field office on October 5, 2023, he was issued a warrant for removal but was allowed to roam the U.S.
 - **Arrest in the Interior:** On December 26, 2023, on U.S. Capitol grounds for possessing a machete, knife, and brick. He also possessed a fraudulent visa and Social Security card.

- **August 15, 2024:** US officials nab Peruvian gang leader wanted for nearly 2 dozen killings in home country: 'Significant threat':
 - **Suspect: Gianfranco Torres-Navarro**, a 38-year-old Peruvian gang leader of the Los Killers de Ventanilla y Callao who was wanted for 23 murders in his home country, including a retired police officer.
 - **Release from the Border:** He illegally crossed near Roma, Texas, on May 16, 2024. He was **RELEASED** into the interior with an NTA.
 - **Arrest in the Interior:** On August 14, 2024, federal agents arrested Torres-Navarro and his girlfriend in Endicott, New York, after taking two months to realize that he was wanted for two dozen murders.

- **August 15, 2024:** Haitian illegal immigrant charged with raping pregnant woman at Massachusetts migrant motel:
 - **Victim:** A pregnant woman at a Massachusetts migrant hotel.
 - **Suspect: Marc Kervens Beauvais**, a 34-year-old Haitian national who illegally crossed near Del Rio, Texas, on June 26, 2021. He was **RELEASED** into the interior with a Notice to Report for processing.
 - **Rape of Pregnant Woman:** On July 31, 2024, Beauvais was arrested for aggravated rape, two counts of assault and battery with a dangerous weapon on a pregnant victim and attempt to commit a crime against a pregnant woman in a migrant shelter in Peabody, Massachusetts.

- **August 16, 2024:** Tren de Aragua gangbanger was cut loose by a Chicago judge before violent Denver jewelry heist:
 - **Victim:** Several jewelry store employees who were pistol-whipped.
 - **Suspect: Jean Torres-Roman**, a 21-year-old illegal alien from Venezuela who Crossed the El Paso border without authorization in September 2023.
 - **String of Armed Jewelry Store Robberies:** In May 2024, Torres-Roman was arrested in Chicago for **unlawful use of a weapon after he was caught trying to stash a stolen gun and ammo**. A Cook County judge ignored ICE's detainer, releasing him. In June 2024, Torres-Roman was charged for pistol-whipping two female jewelry store employees, attempting to obtain merchandise.
 - **Accomplices:** Torres-Roman's accomplices remain at-large.

- **Gang Affiliation:** The suspect is a CONFIRMED Tren de Aragua gang member.
- **August 17, 2024:** Brazilian migrant accused of multiple Massachusetts sex crimes arrested: ICE:
 - **Victim:** Several sexual assault victims.
 - **Suspect: Jackson Bento-Pinheiro**, a 35-year-old illegal alien from Brazil who crossed the border near San Ysidro, California, on July 10, 2021. He was RELEASED into the interior with an NTA.
 - **Sex Offenses:** Bento-Pinheiro was arrested for assault to rape, indecent assault and battery, and domestic assault and battery in Massachusetts.
- **August 25, 2024:** House Links 'Radical' Border Policies to Chicago Robbery:
 - **Victim:** 49-year-old man.
 - **Suspects:** Four Venezuelan illegal aliens:
 - **Carlos Luis Carreno-Carreno**, a 20-year-old who illegally crossed in the Eagle Pass area on July 15, 2023. He refused to answer Border Patrol's question and to sign a sworn statement. He claimed credible fear and was RELEASED into the interior with an NTA in Chicago Immigration court on May 20, 2026.
 - **Yonnier Jose Guasamucare-Garcia**, a 16-year-old who admitted to illegally crossing through the Rio Grande River solo on September 18, 2022. He indicated his parents lived in Colombia and did not express fear of returning home. Despite this, he was RELEASED as a UAC into the interior.
 - **Johandry Fernando Loyo-Rodriguez**, a 21-year-old who illegally crossed on or about July 15, 2023, in the Eagle Pass area. He refused to answer Border Patrol's question and to sign a sworn statement.
 - He agreed to enter the U.S. through CHNV and instead of waiting in Mexico, he unlawfully crossed AGAIN on or about September 16, 2024, where he was RELEASED into the interior with an NTA due to "lack of detention space."
 - **Wilker Miguel Gutierrez Sierra** illegally crossed in the El Paso, Texas, area on or about September 21, 2023. He claimed credible

fear but was given an interview. Instead, he was **RELEASED** into the interior a few days later.

- **Chicago Subway Robbery:** On February 17, 2024, these four illegal aliens held a subway rider at knifepoint. They choked him unconsciously and stole \$400 and his phone.
- **August 27, 2025:** **'Legion' of Florida sheriff's deputies sent to arrest illegal alien for alleged assault of ICE agents**
 - **Victims:** Two ICE Homeland Security Investigation Special Agents
 - **Suspect: Denis Corea-Miranda**, an illegal alien from Nicaragua who was arrested at the border in California and was **RELEASED** into the country in 2021. The suspect managed to avoid deportation after being arrested in Galveston, Texas, for driving while intoxicated in July 2024.
 - **Battery on a law enforcement officer:** When ICE officials attempted to arrest Corea-Miranda, he attempted to flee on foot but was chased down and tackled. The suspect resisted arrest and engaged in what was described as a “fight lasting five minutes.” Despite being pepper-sprayed, Corea-Miranda fled into the nearby woods and was later detained by Polk County deputies.
- **August 28, 2024:** **ICE arrests Bolivian man convicted of child sex crimes claims Fairfax refused detainers:**
 - **Victim:** A child living in Fairfax County, Virginia.
 - **Suspect: Fabricio Veizaga-Vargas**, a 36-year-old Bolivian national who illegally entered the border near El Paso, Texas, on April 25, 2023. He was **RELEASED** into the interior the next day with an NTA.
 - **Sex Offenses and DUI:** On May 3, 2024, Veizaga-Vargas was arrested for misdemeanor sexual assault of a child aged 13 to 14. Fairfax County ignored ICE's detainer and was **RELEASED** where he was arrested for DUI on August 8.
 - **More:** Fairfax County Police arrested him for possessing child pornography and felony possession of obscene material with minor. Once again, an ICE detainer was ignored, and he was released where ICE eventually nabbed him.

- **August 30, 2024:** The Case of the Illegal Alien Who Brutally Assaulted a New York Woman:
 - **Victim:** Unnamed woman.
 - **Suspect: Kindu Jeancy Zamabu**, a 23-year-old illegal alien and **ASYLUM SEEKER** from the Democratic Republic of the Congo who illegally crossed in the San Ysidro, California area on February 13, 2023. He was **RELEASED** into the interior under ICE's Alternatives to Detention program.
 - **Sexual Assault and Unlawful Restraint at Hotel:** On August 11, 2024, the suspect was charged with forcing a victim into sexual contact at hotel in Cheektowaga, New York. He allegedly held her arms down and forced himself on top of her.
- **September 3, 2024:** The Consequences of the Biden-Harris Administration's Open Borders Policies: The Case of the Illegal Alien Who Brutally Assaulted a Teenage Louisiana Girl:
 - **Victim:** 14-year-old girl and a bystander.
 - **Suspect: Angel Matias Castellanos-Orellana**, a 19-year-old Honduran national who illegally crossed into Eagle Pass, Texas, on October 6, 2023. He was **RELEASED** with an NTA due to a "lack of space."
 - **Rape and Stabbing:** Months after his release, Castellanos-Orellana was arrested for sexually assaulting a 14-year-old girl and stabbing a man during a robbery in Kenner, Louisiana.
- **September 4, 2024:** Haitian migrant accused of molesting child is in US via controversial Biden-Harris program:
 - **Victim:** An unnamed 10-year-old boy who lived next door to the perpetrator.
 - **Suspect: Akim Marc Desire**, an 18-year-old illegal alien from Haiti who was unlawfully **PAROLED** into the U.S. through the **CHNV program** on June 4, 2023.
 - **Molestation of Minor Neighbor:** In August 2024, Mansfield, Massachusetts, Police arrested Desire for indecent assault and battery on a child under 14 for sexually assaulting his minor neighbor.
- **September 5, 2024:** ICE confirms, Aurora, Colorado gang members are in the United States illegally, release by Biden admin:

- **Victim:** Shooting incident at apartment complex in Aurora, Colorado.
- **Suspects:**
 - **Jhonnardy Jose Pacheco-Chirinos**, who is a “shot caller” of the gang known as “Cookie”, was apprehended by Border Patrol in the Del Rio sector on October 2, 2022, and he was RELEASED into the U.S. with an NTA.
 - **Jhonnarty De Jesus Pacheco-Chirinos** was also apprehended by Border Patrol in the Del Rio sector on October 2, 2022, and RELEASED into the U.S. with an NTA. He was terminated from ICE’s Supervision Appearance Program as an absconder when he failed to report to an ICE office.
 - **Nixon Jose Azuaje Perez** was apprehended by Border Patrol in Eagle Pass, Texas, on August 22, 2023, and was RELEASED into the U.S. with an NTA and paroled into the country. ICE had placed a detainer on him with local authorities.
 - **Dixon Jose Azuaje Perez** was also apprehended by Border Patrol in Eagle Pass, Texas, on August 22, 2023. He was given an NTA and was RELEASED/PAROLED into the U.S. ICE has placed a detainer on him with local authorities.
- **Shooting:** Local police arrested these individuals for their connection to a shooting/attempted murder in July 2024.
- **September 8, 2024:** Virginia Peruvian illegal immigrant arrested in Virginia after allegedly abducting teenager: police
 - **Victim:** A teenage girl walking to school in Manassas, Virginia.
 - **Suspect: Jesus Enrique Ramirez-Cabrera**, a 23-year-old illegal alien from Peru who crossed into the San Luis, Arizona area without authorization on December 19, 2023. He was RELEASED into the interior.
 - **Impersonation and Abduction:** Ramirez-Cabrera impersonated a police officer to coerce a girl to get inside his vehicle. He grabbed the teenager’s arm and put her in the front passenger seat and drove off. The girl was able to escape when the vehicle came to a stop.
- **September 10, 2024:** Palestinian migrant accused of beating Jewish NY man, stealing flag crossed US border illegally:

- **Victim: Aleksandr Binyaminov**, a Long Island resident.
 - **Suspect: Bechir Lehbeib**, a 26-year-old Mauritanian who snuck into the southern border into Lukeville, Arizona, on July 20, 2023, with a group of 200 people. He was **RELEASED** on his own recognizance after he “claimed fear” in his home country.
 - **Impersonation and Abduction:** In February 2024, Lehbeib stole a pro-Israel flag from a porch on Hewlett in Nassau County. When Binyaminov attempted to stop him, Binyaminov punched him in the face and claimed he was “from Palestine.”
- **September 11, 2024:** Migrant, Freed Into U.S., Via Biden-Harris Admin’s Parole Pipeline, Accused of Murdering 25-Year-Old Dayana Garcia:
 - **Victim: Dayana Garcia**, a 25-year-old of Cleveland, Tennessee.
 - **Suspect: Dayren Roque Lopez**, a 41-year-old Cuban national who **ENTERED** the southern border into San Ysidro, California, port of entry via the unlawful **CBP One application**. He was **RELEASED** into the interior with a work permit.
 - **Alleged Murder:** Dayana went missing, leading to a missing person alert being placed on her. Tennessee authorities found her body inside a residence, and Lopez was named as the primary suspect.
- **September 12, 2024:** Haitian illegal immigrant facing several charges was released at US border last year:
 - **Suspect: Gasnoy Saintlime**, a 19-year-old Haitian illegal alien who crossed the border without authorization in February 2023.
 - **Release from the Border:** He was **RELEASED** and **PAROLED** into the interior with an NTA the same day he was caught by Border Patrol.
 - **Drug Distribution and Gun Violations:** On March 7, 2024, Worcester, Massachusetts, police arrested Saintlime for conspiracy to violate drug laws, but he was released on recognizance before again being arrested in April on weapons and drugs charges.

- **September 17, 2024:** The Consequences of the Biden-Harris Administration's Open-Borders Policies: The Case of the Illegal Aliens Who Attacked New York City Police Officers:
 - **Victims:** An NYPD lieutenant and officer.
 - **Suspects:**
 - **Darwin Gomez Izquierd**, a Venezuelan national who illegally crossed the southern border near Brownsville, Texas, on August 21, 2023. He was either **RELEASED** or entered as a **GOTAWAY** into the interior after he claimed fear of returning home but was told to return to Mexico instead of being formally removed.
 - **Wilson Juarez-Aguilarte**, a Venezuelan national who entered the U.S. near Eagle Pass, Texas, on July 31, 2022. Despite not explaining why he left Venezuela, he was **RELEASED** into the interior in August 2022. On June 2, 2023, he returned to the U.S., illegally entering through Champlain, New York, where he was **RELEASED AGAIN** despite agents aware of his previous CBP encounters.
 - **Kelvin Servita Arocha**, a Venezuelan national who was **RELEASED** into the interior on January 15, 2023, after Border Patrol detained him for wandering around in Chazy, New York. He claims to have previously **ENTERED** the U.S. via the Texas border as **GOTAWAY**.
 - **Yorman Yoel Riveron-Rivera**, a Venezuelan national who unlawfully entered near Brownsville, Texas, on May 11, 2023. He was **RELEASED** into the interior. He reported to an ICE office in NYC where he was **RELEASED** on his own recognizance where he was eventually arrested for separate shoplifting and assault offenses.
 - **Mob Assault on Police Officers:** On January 27, 2024, the four illegal aliens brutally attacked to NYPD officers near a migrant shelter in Times Square after the officers wanted to question them their alleged involvement in shoplifting.
- **September 23, 2024:** Texas offers reward for info on Tren de Aragua members that spread 'terror and carnage,' Gov. Abbott says:
 - **Suspect: Eiber Gabriel Sira-Vargas**, a Venezuelan national and confirmed Tren de Aragua gang member.
 - **Release from the Border:** He crossed the southern border illegally, where he was **CAUGHT** and **RELEASED** into the interior by authorities in August 2022.

- **Arrest in the Interior:** In September 2024, ICE arrested Sira-Vargas in San Antonio. He is suspected of weapons trafficking in connection to TdA.

- **September 25, 2024:** Salvadoran migrant caught and released at border arrested for murder of girlfriend in Maryland:
 - **Victim: Dania Carolina Cruz-Mejia**, an 18-year-old Salvadoran woman living in Montgomery County, Maryland.
 - **Suspect: Gerber Luis Sanchez-Centeno**, a 23-year-old illegal alien from El Salvador, who unlawfully entered the border near Santa Teresa, Mexico, on June 2, 2024. He was **RELEASED** into the interior under ATD GPS monitor, where ICE later removed him from the program after he absconded on August 8.
 - **Murder of 18-year-old Girlfriend:** On September 20, 2024, the Montgomery County Police Department arrested Sanchez-Centeno for the **murder of his girlfriend**. He claims that he killed her after an argument, expressing remorse after death. The victim's brother found her body.

- **October 8, 2024:** Texas woman robbed, pistol-whipped in ritzy Dallas area by illegal Venezuelan migrants with gang ties: report:
 - **Victim:** Unnamed woman residing in the Bluffview neighborhood in Dallas.
 - **Suspects:**
 - **Manuel Hernandez-Hernandez**, a 28-year-old illegal alien from Venezuela, who unlawfully entered the country near the El Paso border as **GOTAWAY** in March 2024.
 - **Rap Sheet:** On May 21, Hernandez-Hernandez pleaded guilty to driving while intoxicated and was sentenced to three days' confinement, ICE said. Hernandez-Hernandez was also arrested by Colleyville police on September 19 and released a day before the robbery occurred.
 - **Yean Brayhan Torrealba-Sanabria**, a 20-year-old illegal alien from Venezuela, who illegal crossed at or near Eagle Pass on December 12, 2023. He was **RELEASED** with an NTA with a January 2025 court date.

- **Wilmer Jesus Colmenares-Gonzalez**, a 27-year-old illegal alien from Venezuela who was encountered by Border Patrol at or near Brownsville on May 6, 2023. He was **RELEASED** with an NTA and January 2025 court date.
- **Carlos Alberto Martinez-Silva**, a 27-year-old illegal alien Venezuela who was encountered by CBP at or near the San Ysidro, California, port of entry on July 7, 2024. He was paroled and **RELEASED** with an NTA on August 1.
- **Robbery of Dallas Woman:** On September 21, 2024, the four suspects forced the Dallas woman into her home, tying her up while pointing guns at her head, striking her head with a firearm. The suspects allegedly used Google Translate to communicate with the victim and made off with \$75,000 worth of jewelry, a Gucci purse, a Ferragamo handbag, a Judith Leiber handbag, the victim's phone and coins from a wooden box, court documents state
- **October 8, 2024:** **Afghan man in Oklahoma plotted Election Day terror attack in US on behalf of ISIS, Justice Department says:**
 - **Suspect:** Nasir Ahmad Tawhedi, a 27-year-old Aghan national.
 - **Admission into the U.S.:** On September 9, 2021, week after the U.S. withdrew its troops from Afghanistan, Tawhedi **ADMITTED** the U.S. on a **Special Immigrant Visa** and is currently on parole status pending adjudication of his immigration proceedings.
 - **Terrorist Plot on Election Day:** On October 7, 2024, police arrested Tawhedi for conspiring and **attempting to provide material support to ISIS and receiving a firearm to be used to commit a felony or a federal crime of terrorism** in Oklahoma. Police said Tawhedi planned to carry out the attack on Election Day on U.S. soil.
- **October 15, 2024:** **Suspects from Honduras involved in horrific crime against child:**
 - **Victim:** A minor under 12-years-old in Palm Beach County, Florida.
 - **Suspects:**
 - **Selvin Lopez-Lopez**, an illegal alien from Honduras, crossed the U.S.-Mexico border and turned himself into Border Patrol with Erik Lopez-Lopez in 2021. He was **RELEASED** into the interior.

- **Erick Lopez-Lopez**, an illegal alien from Honduras, crossed the U.S.-Mexico border and turned himself into Border Patrol with Selvin Lopez-Lopez in 2021. He was **RELEASED** into the interior.
 - **Jesersson Lopez-Lopez**, an illegal alien from Honduras who illegally crossed the U.S.-Mexico border in 2023. He was **RELEASED** into the interior with a 2028 court date.
- **Sexual Assault on Minor:** On October 11, 2024, local police arrested all three men for numerous counts of **Lewd Lascivious Behavior (Capital Sexual Battery) on a minor under 12 years of age**. It is believed the crime took place between August 2024 to the present.
- **October 18, 2024: 'Gotaway' illegal and Tren de Aragua gang member accused in suburban hotel murder:**
 - **Victim: Angel Samaniego**, a 59-year-old legal immigrant from Ecuador lawfully residing in Stamford, Connecticut.
 - **Suspect(s): Gregory Marlyn Galindez-Trias**, a 24-year-old illegal alien from Venezuela, who entered the U.S. near Fort Brown, Texas, in 2022. She was **RELEASED** into the interior.
 - **Gang Affiliation:** Galindez-Trias is a **confirmed** TdA member.
 - **Hotel Murder in Connecticut:** In October 2024, Galindez-Trias and Moises Alejandro Condollo-Urbaneja, a 22-year-old Venezuelan illegal alien TdA member, were arrested for their connection in the robbery and murder of Angel Samaniego in a Connecticut hotel.
- **October 22, 2024: Tren de Aragua member trafficked 15-year-old NYC runaway while free on attempted-slay rap: cops:**
 - **Victims:** A Bronx resident and a 15-year-old teenage runaway from New York City.
 - **Suspect(s): Enyerbert Blanco**, a 27-year-old illegal alien from Venezuela, who illegally crossed into Texas in May 2023 and was ordered removed. At some point, he ended up at a holding center in New Jersey and was **RELEASED** a month later.
 - **Gang Affiliation:** Blanco is a **suspected** TdA member.
 - **Sex-Trafficking A Girl and Rap Sheet:** On October 22, 2023, Blanco opened fire on a Bronx man, resulting in his arrest but was **FREED** on bail. Two weeks later, he was arrested for drug crimes in Miami, only to be

RELEASED. In October 2024, he was arrested for sex-trafficking a minor in Palm Beach County.

- **October 23, 2024:** Illegal Alien Accused of Assaulting Child in Massachusetts Freed Into U.S. by Biden-Harris DHS:
 - **Victim:** A child in Marlborough, Massachusetts.
 - **Suspect: Mateus Silva-Kerkovsky**, 24-year-old illegal alien from Brazil, who illegal crossed the southern border near San Luis, Arizona, on October 22, 2021. He was **PAROLED** and **RELEASED** into the interior with a NTA on October 29, 2021.
 - **Assaulting a Child:** On August 9, 2024, the Hudson Police Department arrested Silva-Kerkovsky for **assaulting a child**, including two counts of strangulation or suffocation.
 - **Previous Removal Order:** In March 2023, an immigration judge ordered Silva-Kerkovsky deported from the U.S., but he was not removed.
- **October 30, 2024:** Illegal immigration status revealed in shooting of Jewish man in Dem-controlled city:
 - **Victim:** A Jewish man from Chicago's West Rogers Park neighborhood.
 - **Suspect:** Sidi Mohamed Abdallahi, a 22-year-old Mauritanian national, who illegally crossed the southern border in March 2023 at the San Diego Sector. He was **RELEASED** into the interior.
 - **Shooting a Man in Public:** In October 2024, Abdallahi walked up to the Orthodox Jew, who was wearing traditional Jewish clothing and shot him multiple times without saying a word. He then got into a shootout with responding officers, and he shot himself. He is now charged with 14 felonies.
- **November 21, 2024:** Man convicted of raping minor in Brazil arrested in Methuen, ICE says:
 - **Suspect: Alexandre Romao De Oliveria**, an illegal alien from Brazil who was **convicted of child rape** in Brazil in 2022. He was sentenced to 14 years in prison.

- **Release from the Border:** He wound up fleeing to the U.S., where he illegally crossed into New Mexico April 2022 and was **RELEASED** into the interior with an NTA despite his criminal conviction.
- **Arrest in the Interior:** In November 2024, ICE agents in Boston arrested De Oliveria during an enforcement operation.
- **November 21, 2024:** Venezuelan migrant charged with raping his boss' 14-year-old daughter while living in their Colorado home:
 - **Victim:** A 14-year-old girl in Jefferson County, Colorado.
 - **Suspect:** Jesus Alberto Pereira Castillo, a 20-year-old from Venezuela who illegally crossed into El Paso, Texas, on September 30, 2023. He was **RELEASED** into the interior due to lack of detention space.
 - **Sexual Assault of Minor:** On August 29, 2024, while temporarily living with in his boss's home, Pereira-Castillio was accused of **forcing himself on his boss's 14-year-old daughter and sexually assaulting her**. He fled the area where he was eventually arrested in Denver in November 2024.
- **December 3, 2024:** Migrant accused of violent crimes arrested by ICE after Massachusetts court refused to honor detainer:
 - **Victim:** Unknown victims of kidnapping, home invasion, and assault.
 - **Suspect:** Julio Esteban-Castillo, a 24-year-old illegal alien who illegally entered the country and was **RELEASED** into the interior in January 2023.
 - **Felony Crime Spree:** While in Boston, Esteban-Castillo was arrested and charged for kidnapping, assault with a firearm and strangulation, and home invasion. He was **RELEASED** by local police, ignoring the ICE detainer placed on him.
- **December 18, 2024:** Texas Detained, but Feds Released Terror Watchlist Suspect:
 - **Suspect:** Umar Farooq Ashraf, a South African national who was traveling with a group of 30 illegal aliens in Del Rio, was detained by Texas DPS in September 2024, and was turned over to Border Patrol.

- **Release from the Border:** He was **RELEASED** into the interior since authorities did not see derogatory information during his background check.
- **Arrest in the Interior:** At a later time, Ashraf yielded a positive result on the terror watchlist and was arrested by ICE in Brooklyn, New York, in December 2024.
- **March 1, 2025:** Haitian man charged in NC triple murder flew into US under Biden migrant flights program: ICE:
 - **Victims:** A 4-year-old child, a 13-year-child, and a 77-year-old Beatrice Desir, all of whom were family members to the suspect.
 - **Suspect:** Mackendy Darbouze, a 34-year-old Haitian national who was ADMITTED into the U.S. through the unlawful CHNV program in July 2024 via aircraft.
 - **Triple Homicide of Family:** On February 21, 2025, Fayetteville, North Carolina, police responded to a home after receiving a report of stabbing where they discovered Darbouze covered in blood and his relatives dead.
- **March 1, 2025:** Haitian man charged in NC triple murder flew into US under Biden migrant flights program: ICE:
 - **Victims:** A 4-year-old child, a 13-year-child, and a 77-year-old Beatrice Desir, all of whom were family members to the suspect.
 - **Suspect:** Mackendy Darbouze, a 34-year-old Haitian national who was ADMITTED into the U.S. through the unlawful CHNV program in July 2024 via aircraft.
 - **Triple Homicide of Family:** On February 21, 2025, Fayetteville, North Carolina, police responded to a home after receiving a report of stabbing where they discovered Darbouze covered in blood and his relatives dead.
- **March 21, 2025:** Illegal immigrant released by Biden admin charged with killing Georgia grandmother in random attack:
 - **Victim: Camilia Williams,** a 52-year-old mother of five and grandmother in Marietta, Georgia.
 - **Suspect:** Hector David Sagastume Rivas, a 21-year-old Honduran national who illegally crossed the southern border and was **PAROLED** and

RELEASED into the interior with a NTA in March 2021. An immigration judge ordered him removed in July 2023.

- **Brutal Stabbing of Father of Four:** On March 21, 2025, Rivas put Williams in a chokehold, causing her to lose consciousness and crushed her neck with his body weight. Williams' body was dumped in the woods.
- **April 21, 2025: ICE arrests illegal immigrant with alleged terror ties in California, one of the most wanted men in India:**
 - **Suspect: Harpeet Sing**, an Indian national who was one of the most wanted fugitives in India for **connections with terrorist activities and a member of the Pakistan-based terrorist organization Babbar Khalsa International.**
 - **Release from the Border:** In January 2022, Sing illegally crossed the southern border in Arizona. Border Patrol arrested him and placed him in removal proceedings and then **RELEASED** him into the interior.
 - **Arrest in the Interior:** Sing was arrested by ICE during routine operations in Sacramento, California, on April 16, 2025.
 - **Connections to Terrorism:** Singh allegedly provided terrorist funds, recruitment, and planning of a grenade attack on an Indian Police Station and on a retired Punjab police officer's house with the intent to kill and instill fear among law enforcement officers.
- **April 25, 2025: Illegal migrant cut loose by Biden admin accused of raping 13-year-old boy during twisted game of hide-and-seek:**
 - **Victim:** A 13-year-old boy in Florida.
 - **Suspect:** Samuel Cobos-Carmona, a 20-year-old Mexican national who illegally crossed the border in July 2024 and was **RELEASED** into the interior. He illegally crossed the southern border in 2021 and was sent back to Mexico.
 - **Sexual Assault of 13-year-old Boy:** On April 13, 2025, Cobos-Carmona sexually assaulted a 13-year-old boy while playing a game of hide-and-seek. He assaulted the boy orally and anally, according to police.

- **June 4, 2025:** ICE arrests Russian national accused of being member of Al Qaeda:
 - **Suspect:** Unnamed 39-year-old Tajikistan-born Russian national who is wanted overseas and suspected member of Al-Qaeda.
 - **Release from the Border:** On May 21, 2023, he illegally crossed into San Ysidro and was PAROLED and RELEASED into the U.S. with an NTA.
 - **Arrest in the Interior:** In June 2025, ICE and the FBI arrested the illegal alien in Philadelphia.

- **June 4, 2025:** Trump's DHS says Biden released 'barbaric' illegal immigrant now accused of heinous crime:
 - **Victim:** An unnamed 10-year-old boy who lived next door to the perpetrator.
 - **Suspect: Lorenzo Lopez Alcario**, a 30-year-old Guatemalan illegal who was previously deported for drug possession in September 2017. He illegally crossed the border in June 2022 where he was RELEASED into the interior despite his criminal history and deportation.
 - **Molestation of Minor Neighbor:** In June 2025, Marlborough, Massachusetts, Police arrested Lopez-Alcario for brutally sexually assaulting a child while capturing the crime on video.

- **June 23, 2025:** Illegal Alien Gang Member, Freed Into U.S. By Biden Administration, Charged With Attempted Murder of ICE Agents:
 - **Victims:** Unnamed ICE agent and unnamed FBI agent attempting to arrest the suspect in Bellevue, Nebraska.
 - **Suspect: Gabriel Hurtado-Cariaco**, an illegal alien from Venezuela and known member of Tren de Aragua. He illegally crossed the southern border in 2023 and was REMOVED by Border Patrol. The following year, Hurtado-Cariaco crossed the border again, and was RELEASED into the interior with an NTA.
 - **Attack on ICE Agent:** During an ICE operation, Hurtado-Cariaco allegedly threw an ICE agent to the ground, bashed her head into the pavement, and ripped off her protective armor while repeatedly making violent contact with the agent.

- **August 4, 2025:** ICE lodges detainers against 3 Venezuelans charge with capital murder in Texas:
 - **Victims:** A minor under 12-years-old in Palm Beach County, Florida.
 - **Suspects:**
 - **Yosguar Aponte-Jimenez**, an illegal alien from Venezuela who illegally crossed the border in May 2023 and was **RELEASED** into the interior where he was later charged with murder.
 - **Jose Trivino-Cruz**, an illegal alien from Venezuela was **ADMITTED** and **RELEASED** into the interior via the CBP One app in October 2024.
 - He is also a suspect for a separate robbery that occurred before the murder, where he robbed and raped a woman at Deluxe Inn, a mile away from the Motel 6.
 - **Jesus Bellorin-Guzman**, an illegal alien from Venezuela was **ADMITTED** and **RELEASED** into the interior via the CBP One app in January 2025, two weeks before Trump took office.
 - He is also a suspect for a separate robbery that occurred before the murder, where he robbed and raped a woman at Deluxe Inn, a mile away from the Motel 6.
 - **Murdered Man in Motel:** On June 20, 2025, the three men shot Santiago Lopez Morales to death at a Motel 6 in Garland, Texas.
- **August 29, 2025:** Venezuelan Torture Suspect Freed Under Biden-Era Policies Cries During ICE Arrest in Texas
 - **Victims:** a young woman from Venezuela
 - **Suspect: Raul Enrique Pargas Rodriguez**, a 31-year-old alien from Venezuela entered the country on August 10, 2022, near Eagle Pass, Texas. Biden-era policies led to his **RELEASE** after being **ARRESTED** by Del Rio Sector Border Patrol agents.
 - **Tortured a young woman through Russian Roulette:** Pargas called a woman to his workshop in February 2021. He reportedly entered a violent rage and began insulting, hitting, and attacking the woman. Officials report that he then took a black pistol and pointed it at her. He then reportedly

placed the pistol at her head before removing the bullets and replacing some of them. He then re-aimed the gun at her head.

- **March 30, 2026:** Biden-Released Illegal Alien Charged with Two Murders in North Carolina Sanctuary County:
 - **Victims:** 44-year-old **Ludvin Antonio Guzman Morales** and **Luis Guitierrez Mora**.
 - **Suspect: Jesus Quintero Fernandez**, a 22-year-old illegal alien from Venezuela was **RELEASED** into the interior via the CBP One app in July 2023.
 - **Rap Sheet:** Fernandez has been arrested and charged with first-degree murder, attempted first-degree murder, assault with a deadly weapon with intent to kill by inflicting serious injury, possession of a stolen firearm, and felony conspiracy.
 - **Murdered two people in Mecklenburg County:** Police allege that Fernandez murdered 44-year-old Ludvin Antonio Guzman Morales on January 24 in a shooting and later, on March 22, murdered Luis Guitierrez Mora. Fernandez was arrested for murder on March 23.
- **May 1, 2026:** Biden-Released illegal immigrant accused of murdering San Francisco social worker
 - **Victims:** A 51-year-old licensed marriage and family therapist in San Francisco General Hospital
 - **Suspect: Wilfredo Jose Tortolero-Arriechi**, a 35-year-old illegal alien from Venezuela was **RELEASED** into the interior in 2023 as part of the administration's catch and release policy
 - **Murdered a Social Worker:** On Dec. 4, 2025, 35-year-old illegal alien Wilfredo Jose Tortolero-Arriechi of Venezuela entered Zuckerberg San Francisco General Hospital and asked to speak with his doctor.
 - Officials allege Tortolero-Arriechi had become obsessed with his doctor and police believe that is who he intended to target that day. Hospital staff re-directed Tortolero-Arriechi to 51-year-old Alberto Rangel, a licensed marriage and family therapist.
 - While Rangel was not looking, police said Tortolero-Arriechi stabbed him. Two days later, on December 6, 2025, Rangel died from his injuries.

- **May 18, 2026:** Biden-Released illegal alien accused of repeatedly raping 12 year old girl:
 - **Victims:** A minor under 12-years-old in Martin County, Florida
 - **Suspect: Henry Ronaldo Perez-Roblero**, a 20-year-old illegal alien from Guatemala, was **RELEASED** into the interior after he illegally crossed the border as an Unaccompanied Alien Child (UAC) in January 2021
 - **Molestation of a minor:** According to police, Perez-Roblero allegedly repeatedly had sex with a 12-year-old girl, going back to when she was just 10 years old.

- **June 10, 2026:** Biden-Released Illegal Alien Convicted in Counterfeit Drug Scheme that killed 45-year-old army veteran:
 - **Victims:** In one case, a 45-year-old woman, who thought she was purchasing prescription oxycodone from the fake online pharmacy, died after having taken the fentanyl-laced pills. She was a veteran of the U.S. Army.
 - **Suspect: Edward Eustate Jimenez**, an illegal alien from the Dominican Republic, was **RELEASED** into the interior as part of Biden's and then-DHS Secretary Alejandro Mayorkas' expensive catch-and-release policy that released millions into the country
 - **Involvement in a nationwide counterfeit drug operation:**

- **January 2, 2025:** Illegal Alien, Freed into U.S. by Biden's DHS, Accused of Attempted Rape:
 - **Victims:** An adult complainant in Massachusetts
 - **Suspect:** Emilio Jose Pena-Casilla, a 46-year-old Dominican national.
 - **Release/Immigration History:** Pena-Casilla crossed near Eagle Pass, Texas, on January 9, 2023. ICE enrolled him in Alternatives to Detention, placed him in removal proceedings, and **RELEASED** him on his own recognizance. He was removed from ATD on February 16, 2023.
 - **Rape and Release:** He was arraigned in July 2024 on charges including attempted rape, kidnapping, indecent assault and battery on a person age 14 or older, and witness intimidation. The local jail later **RELEASED** him on bail despite an ICE detainer; ICE arrested him on December 17, 2024.

- **March 14, 2025:** New York: released border entrant accused of killing his infant daughter:
 - **Victims:** Liseyda Rabanales-Barrios, the suspect's two-month-old daughter.
 - **Suspect:** Marlon Rabanales-Pretzantzin, a 20-year-old Guatemalan national.
 - **Release/Immigration History:** Border Patrol apprehended him after he crossed near El Paso, Texas, in 2022 and **RELEASED** him into the interior while his immigration case was pending.
 - **Infanticide:** Nassau County police arrested him and charged him with second-degree murder after the infant died from severe injuries. Police alleged that he struck, shook, and compressed the child. He pleaded not guilty.

- **May 6, 2025:** Illinois: released border entrant accused in fatal wheelchair hit-and-run:
 - **Victims:** James McCammon, 58, who was crossing a street in a wheelchair.
 - **Suspect:** Fernando Lorenzo-Raymundo, a 36-year-old Guatemalan national.
 - **Release/Immigration History:** Lorenzo-Raymundo was apprehended after crossing the U.S.-Mexico border in March 2024 and was then **RELEASED** into the interior.
 - **Hit-and-Run:** Champaign police accused him of striking and killing McCammon in early March 2025 and leaving the scene. The article states that he was charged in connection with the fatal hit-and-run and had pleaded guilty to battery.

- **May 23, 2025:** Honduran fugitive accused of child rape had been paroled at the border:
 - **Victims:** A child in Honduras.
 - **Suspect:** Felipe Nery Casco Murillo, a Honduran national and foreign fugitive.
 - **Release/Immigration History:** Murillo applied for admission at the Hidalgo, Texas, port of entry on May 13, 2023. He was **PAROLED** and **RELEASED** into the U.S. that day.

- **Fugitive from Justice:** Honduran authorities sought him for alleged child rape and production of child sexual-abuse material. ICE received notice of the warrant in November 2024, arrested him on January 28, 2025, and removed him to Honduras on May 16, 2025, after an immigration judge ordered removal.
- **September 23, 2025:** Chicago: released deportation subject accused of murder and concealing body in concrete:
 - **Victims:** Gregori Arias, 31.
 - **Suspect:** Jose Javier Coronado-Meza, a 25-year-old Venezuelan national.
 - **Release/Immigration History:** Coronado-Meza crossed near Laredo, Texas, in September 2023, was removed, crossed again the following month, and entered ICE custody. An immigration judge ordered him removed in December 2023, but ICE **RELEASED** him from custody in April 2024.
 - **Murder After Release:** Chicago authorities charged him with murdering Arias and allegedly concealing the remains in concrete at an unidentified construction site.
- **April 14, 2026:** Missouri: released border entrant accused of kidnapping and rape:
 - **Victims:** An adult woman in Kirksville, Missouri.
 - **Suspect:** Cristian Lopez-Gomez, a 25-year-old Honduran national.
 - **Release/Immigration History:** Lopez-Gomez was **RELEASED** into the U.S. after he unlawfully crossed the southern border in April 2024.
 - **Sexual Assault:** Kirksville authorities arrested him and charged him with kidnapping and rape arising from an alleged attack on Easter Sunday. ICE lodged a detainer.
- **June 18, 2026:** Illegal Alien Indicted for Allegedly Murdering Roommate with Machete in Mississippi:
 - **Victims:** Reyes' roommate killed by a machete-wielding murderer.
 - **Suspect:** Maberic Javier Reyes, 21, an illegal alien from Mexico.

- **Release/Immigration History:** Reyes had been **RELEASED** into the United States from the southern border by the Biden administration.
- **Deadly Argument:** Reyes used a machete to murder his roommate, following an argument between the two at their residence in Southaven, Mississippi, on January 13.
- **June 26, 2026; Florida: Biden-Released Illegal Alien Accused of Drugging, Raping Woman:**
 - **Victims:** An adult woman who simply went clubbing.
 - **Suspect:** Yusel Keoma Perez-Leyva, an illegal alien from Cuba.
 - **Release/Immigration History:** Perez-Leyva first illegally crossed the U.S.-Mexico border into Arizona in 2021. He was subsequently **RELEASED** into the U.S. interior.
 - **Stalking and Rape:** Perez-Leyva allegedly drugged a woman following a night of clubbing, brought her to his apartment, and raped her. Police said surveillance footage shows Perez-Leyva carrying the woman, as she was inebriated, to his apartment.
