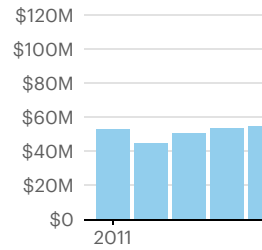

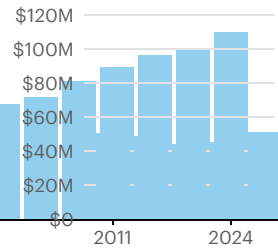

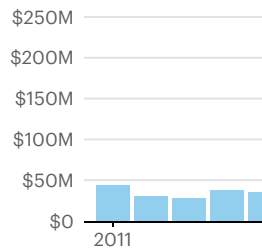

**\$110M** (2024)



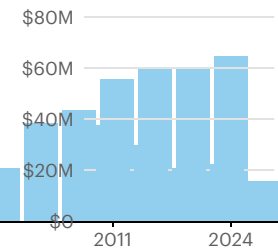
Expenses
