Tina McKinney I am a mother, and voice for victims of violent crime. My son, Officer Joseph 'Rusty' McKinney, was killed in the line of duty on April 12, 2024, in Memphis, Tennessee. His death was not just a personal tragedy, but a systemic failure caused by repeat offenders and lenient policies. Chairman and Members of the Committee,

Thank you for allowing me to speak today. My name is Tina McKinney, and I am the mother of Officer Joseph "Rusty" McKinney, who was killed in the line of duty on April 12, 2024, in Memphis, Tennessee. Rusty was only 26 years old—a devoted father, loving fiancé and a son who lived with purpose and integrity.

His death was not an isolated tragedy. It was the result of systemic failures—soft-oncrime policies, repeat offenders released despite serious charges, and leadership that prioritized leniency over accountability. These decisions cost my son his life.

I urge this Committee to take bold action:

- Enforce stricter bail and bond policies for violent offenders.
- Hold Judges, Political Leaders and District Attorneys accountable for decisions that compromise public safety.
- Bring the National Guard and keep all the Federal Law enforcement agencies in Memphis.

Rusty died a hero protecting others. It is time for our leaders and courts to protect those who remain. Memphis deserves better. America deserves better.
