7	"(a) In General.—Trains originating in or destined

12	"(1) are citizens or lawful permanent residents
13	of the United States; or
14	"(2) meet all of the following requirements:
15	"(A) Have current Mexican passports,

18	(1101(a)(15)(B)), and meet reasonable require-

1	ments for access and clearance set by United
2	States Customs and Border Protection.
3	"(B) Are licensed by the Mexican Govern-
4	ment to operate trains in Mexico.
5	"(C) Are certified under locomotive engi-
6	neer or conductor certification programs filed
7	with the Federal Railroad Administration under
8	parts 240 and 242 of title 49, Code of Federal
9	Regulations.
10	"(D) Comply with United States hours of
11	service requirements in chapter 211 of title 49,
12	United States Code.
13	"(b) Notwithstanding subsection (a), no train origi-
14	nating in or destined to Mexico may be operated in the
15	United States for distances in excess of 20 air-miles from
16	the intersection of the international border and the exist-
17	ing rail border crossing or rail gateway, unless by crews
18	comprised entirely of citizens or lawful permanent resi-
19	dents of the United States.".
20	(b) REGULATIONS REQUIRED.—Not later than 180
21	days after the date of enactment of this Act, the Secretary
22	of Transportation shall issue such regulations as are nec-
23	essary to carry out the amendments made by this section.
