1 SEC. 3____. NEW SAVANNAH BLUFF LOCK AND DAM, GEOR 2 GIA AND SOUTH CAROLINA.

3 Section 1319(c) of the Water Resources Development
4 Act of 2016 (130 Stat. 1703; 136 Stat. 3792) is amend5 ed—

6 (1) by amending paragraph (1) to read as fol-7 lows:

8 "(1) IN GENERAL.—Notwithstanding any other
9 provision of law, the Project is modified to include—
10 "(A) full repair of the New Savannah
11 Bluff Lock and Dam structure;

"(B) modification of the structure such
that the structure is able to maintain a stable
pool with the same daily average elevation as is
achieved by the existing structure, as measured
at both the United States Geological Survey
Gage 02196999, located at the New Savannah
Bluff Lock and Dam, and the United States

1	Geological Survey Gage 02196670, located in
2	the vicinity of the Fifth Street Bridge, Augusta,
3	Georgia, which at the New Savannah Bluff
4	Lock and Dam is between 114.5 and 115 feet
5	National Geodetic Vertical Datum of 1929
6	(NGVD29);
7	"(C) construction of a fish passage struc-
8	ture as recommended in the report of the Chief
9	of Engineers for the Project, dated August 17,
10	2012, or such other Project feature that appro-
11	priately mitigates impacts to fish habitat caused
12	by the Project without removing the dam; and
13	"(D) conveyance by the Secretary to Au-
14	gusta-Richmond County, Georgia, of the park
15	and recreation area adjacent to the New Savan-
16	nah Bluff Lock and Dam, without consider-
17	ation.";
18	(2) in paragraph (2), by adding at the end the
19	following:
20	"(C) Ceiling.—The costs of construction
21	to be paid by the Georgia Port Authority as a
22	non-Federal interest for the Project for the
23	modifications authorized under paragraph (1)
24	shall not exceed the costs that would be paid by
25	such non-Federal interest for construction of

 (3) in paragraph (3), by striking "the cost
 sharing of the Project as provided by law" and in-

6 serting "the cost sharing of the fish passage struc7 ture as recommended in the report of the Chief of
