Add at the end the following:

1	SEC INSPECTOR GENERAL AUDIT OF WASTE, FRAUD,
2	AND ABUSE.
3	(a) In General.—Not later than 90 days after the
4	date of enactment of this section, the inspector general
5	of the Department of Transportation shall conduct an
6	independent audit of waste, fraud, and abuse at the De-
7	partment related to SpaceX, Tesla, Starlink, The Boring
8	Company, Neural Link, and xAI.
9	(b) Contents.—In conducting the study required
10	under subsection (a), the inspector general shall—
11	(1) compile a list of all matters under the pur-
12	view of the Department in which SpaceX, Tesla,
13	Starlink, The Boring Company, Neural Link, or xAI
14	has any interest, stake, or engagement;
15	(2) compile all documents and communications
16	related to any procurements, grants, contracts, coop-
17	erative agreements, or interagency agreements,
18	under the jurisdiction of the Department in which
19	any of Elon Musk's businesses is a party;

1	(3) compile a detailed and complete list, includ-
2	ing roles, titles, and length of service with the Fed-
3	eral Government, of any Federal employees or con-
4	tractors terminated, placed on administrative leave,
5	transferred, or in any way removed from their posi-
6	tions by, or on the recommendation or orders of the
7	Department of Governmental Efficiency or a special
8	government employee who were involved in any in-
9	vestigation into any of SpaceX, Tesla, Starlink, The
10	Boring Company, Neural Link, or xAI;
11	(4) compile a detailed and complete list of all
12	steps the Department is taking to ensure compliance
13	with all relevant conflicts of interest and ethics laws
14	pertaining to SpaceX, Tesla, Starlink, The Boring
15	Company, Neural Link, or xAI;
16	(5) compile a detailed and complete list of all
17	actions the Department is taking to ensure that spe-
18	cial government employees, the Department of Gov-
19	ernmental Efficiency, or employees of SpaceX,
20	Tesla, Starlink, The Boring Company, Neural Link,
21	and xAI are not permitted access to information
22	that would give SpaceX, Tesla, Starlink, The Boring
23	Company, Neural Link, or xAI an advantage over
24	competitors;

1	(6) provide recommendations to eliminate or
2	mitigate any cases of waste, fraud, and abuse at the
3	Department related to SpaceX, Tesla, Starlink, The
4	Boring Company, Neuralink, and xAI; and
5	(7) determine whether any actions or resources
6	are needed to improve oversight, prevent conflicts of
7	interest, and eliminate waste, fraud and abuse.
8	(e) Report.—The inspector general shall submit to
9	Congress and make publicly available a report containing
10	the findings of the study conducted under this section.
