The Pascua Yaqui Tribe was grant funded \$578,000 through the Arizona environmental infrastructure authority in January 2022 that will help the tribe complete a crucial water pipeline started last year. The tribe had received \$900,000 in January 2021 to begin construction of this crucial pipeline, and it was the first tribal project funded under this infrastructure authority.


