During career in the U.S. Coast Guard, attained the rank of Captain and last served in the position of Chief of Staff for the Alaska region before retiring. As Chief of Staff, provided oversight to a work force of 1,500 personnel assigned to boats, ships, aircraft, and shore installations in accomplishing a wide array of missions. Oversaw issues and activities regarding search and rescue, homeland security and defense,

maritime law enforcement, marine transportation safety, and environmental protection in an area encompassing over 3.8 million square miles of ocean, 44,000 miles of coastline and the U.S. Arctic region.

Served in many capacities at sea and ashore leading and planning operations. Served aboard seven Coast Guard cutters in both the Atlantic and Pacific regions, commanding four of the cutters. Shore assignments were focused on overseeing operations and emergency response, such as Chief of Operations and Chief of Planning for the U.S. Coast Guard, Atlantic region, and as Chief of Operations for the Alaska region.

While serving in the Atlantic region as Chief of Operations and as Chief of Planning and Preparedness, exercised oversight in accomplishing Coast Guard operations with a work force of 26,000 personnel assigned to boats, ships, aircraft, and shore installations throughout the Coast Guard Atlantic Area. Managed over 4,000 employees assigned to 36 ships, Patrol Forces Southwest Asia, and Helicopter Interdiction Squadron dispersed throughout the Atlantic realm and Arabian Gulf. Allocated deployment of aviation assets encompassing 108 aircraft.

As a senior officer, directed the coordination of the U.S. Coast Guard's efforts during many significant natural disaster humanitarian relief efforts caused by hurricanes, flooding, and earthquakes in saving lives, protecting the environment, and restoring the marine transportation system. Commanded the response efforts for numerous significant lifesaving and pollution response incidents as On Scene Commander, as well as protecting the U.S. homeland in making numerous at-sea seizures of illegal drug shipments and interdicting hundreds of migrants destined to the United States. Led the Administrative Investigation for the dive accident aboard the Coast Guard Icebreaker *Healy* in which two Coast Guard divers died during a training dive in the Arctic.
