- 20 amendments described in section 2 of this resolution; (3)
- 21 the amendments en bloc described in section 3 of this reso-
- 22 lution; and (4) one motion to recommit.
- Sec. 2. After debate pursuant to the first section of
- 24 this resolution, each further amendment printed in part

- 1 B of the report of the Committee on Rules not earlier con-
- 2 sidered as part of amendments en bloc pursuant to section
- 3 3 of this resolution shall be considered only in the order
- 4 printed in the report, may be offered only by a Member
- 5 designated in the report, shall be considered as read, shall
- 6 be debatable for the time specified in the report equally
- 7 divided and controlled by the proponent and an opponent,
- 8 may be withdrawn by the proponent at any time before
- 9 the question is put thereon, shall not be subject to amend-
- 10 ment, and shall not be subject to a demand for division
- 11 of the question.
- 12 Sec. 3. It shall be in order at any time after debate
- 13 pursuant to the first section of this resolution for the chair
- 14 of the Committee on Financial Services or her designee
- 15 to offer amendments en bloc consisting of further amend-
- 16 ments printed in part B of the report of the Committee
- 17 on Rules accompanying this resolution not earlier disposed
- 18 of. Amendments en bloc offered pursuant to this section
- 19 shall be considered as read, shall be debatable for 20 min-
- 20 utes equally divided and controlled by the chair and rank-
- 21 ing minority member of the Committee on Financial Serv-
- 22 ices or their respective designees, shall not be subject to
- 23 amendment, and shall not be subject to a demand for divi-
- 24 sion of the question.

1 SEC. 4. All points of order against the further amendments printed in part B of the report of the Committee 3 on Rules or amendments en bloc described in section 3 4 of this resolution are waived. 5 SEC. 5. Upon adoption of this resolution it shall be in order to consider in the House the bill (H.R. 1065) to eliminate discrimination and promote women's health 8 and economic security by ensuring reasonable workplace accommodations for workers whose ability to perform the 10 functions of a job are limited by pregnancy, childbirth, or a related medical condition. All points of order against 11 12 consideration of the bill are waived. The amendment in the nature of a substitute recommended by the Committee 14 on Education and Labor now printed in the bill shall be 15 considered as adopted. The bill, as amended, shall be considered as read. All points of order against provisions in 16 the bill, as amended, are waived. The previous question 17 18 shall be considered as ordered on the bill, as amended, 19 and on any further amendment thereto, to final passage 20 without intervening motion except: (1) one hour of debate 21 equally divided and controlled by the chair and ranking minority member of the Committee on Education and Labor or their respective designees; and (2) one motion to recommit.

- 1 Sec. 6. (a) At any time through the legislative day
- 2 of Friday, May 14, 2021, the Speaker may entertain mo-
- 3 tions offered by the Majority Leader or a designee that
- 4 the House suspend the rules as though under clause 1 of
- 5 rule XV with respect to multiple measures described in
- 6 subsection (b), and the Chair shall put the question on
- 7 any such motion without debate or intervening motion.
- 8 (b) A measure referred to in subsection (a) includes
- 9 any measure that was the object of a motion to suspend
- 10 the rules on the legislative day of May 11, 2021, or May
- 11 12, 2021, in the form as so offered, on which the yeas
- 12 and nays were ordered and further proceedings postponed
- 13 pursuant to clause 8 of rule XX.
- (c) Upon the offering of a motion pursuant to sub-
- 15 section (a) concerning multiple measures, the ordering of
- 16 the year and nays on postponed motions to suspend the
- 17 rules with respect to such measures is vacated to the end
- 18 that all such motions are considered as withdrawn.
