1 "SEC. 60607. PILOT PROGRAM FOR OBTAINING COMMER-2CIAL SECTOR SPACE WEATHER DATA.

3 "(a) ESTABLISHMENT.—Not later than one year after the date of enactment of this Act, the Administrator 4 5 of the National Oceanic and Atmospheric Administration 6 may establish a pilot program under which the Administrator will offer to enter into contracts with one or more 7 entities in the commercial space weather sector for the 8 9 provision to the Administrator of the National Oceanic and Atmospheric Administration of space weather data 10 11 generated by such an entity that meets the standards and 12 specifications published under subsection (b).

13 "(b) DATA STANDARD AND SPECIFICATIONS.—Not 14 later than 18 months after the date of enactment of this 15 Act, the Administrator of the National Oceanic and At-16 mospheric Administration, in consultation with the Sec-17 retary of Defense, may publish standards and specifica-18 tions for ground-based, ocean-based, air-based, and space-19 based commercial space weather data and metadata.

20 "(c) CONTRACTS.—

1	"(1) IN GENERAL.—Within 12 months after the
2	date of transmission of the review of the integrated
3	strategy to Congress under 60602(c)(3) and taking
4	into account the results of the review, the Adminis-
5	trator of the National Oceanic and Atmospheric Ad-
6	ministration may offer to enter, through an open
7	competition, into at least one contract with one or
8	more commercial space weather sector entities capa-
9	ble of providing space weather data that—
10	"(A) meets the standards and specifica-
