Add at the end the following:

SEC. 15. REPORT ON MERITS AND OPTIONS FOR ESTAB LISHING AN INSTITUTE RELATING TO SPACE RESOURCES.

4 (a) REPORT.—Not later than 180 days after the date 5 of the enactment of this Act, the Administrator and Sec-6 retary shall jointly submit to the appropriate congressional committees a report on the merits of, and options for, es-7 8 tablishing an institute relating to space resources to ad-9 vance the objectives of NASA and the Department in maintaining United States preeminence in space. Such ob-10 11 jectives shall include the following:

12 (1) Identifying, developing, and distributing
13 space resources, including by encouraging the devel14 opment of foundational science and technology.

15 (2) Reducing the technological risks associated
16 with identifying, developing, and distributing space
17 resources.

18 (3) Developing options for using space re-19 sources to—

1	(A) support current and future space ar-
2	chitectures, programs, and missions; and
3	(B) enable such architectures, programs,
4	and missions that would not otherwise be pos-
5	sible.
6	(b) Additional Matters.—The report required
7	under subsection (a) shall also include the following as-
8	sessments of the Administrator and the Secretary:
9	(1) Whether a virtual or physical institute relat-
10	ing to space resources is most cost effective and ap-
11	propriate.
12	(2) Whether partnering with institutions of
13	higher education and the aerospace industry, and
14	the extractive industry as appropriate, would be ef-
15	fective in increasing information available to the in-

17	scribed in subsection (a).
18	(c) DEFINITIONS.—In this section:
19	(1) Administrator.—The term "Adminis-
20	trator" means the Administrator of NASA.

8	(4) EXTRACTIVE INDUSTRY.—The term "ex-
9	tractive industry" means companies and individuals
10	involved in the processes of extracting, including
11	mining, quarrying, drilling, and dredging, raw, nat-
12	ural materials or energy sources.
13	(5) INSTITUTION OF HIGHER EDUCATION.—The
14	term "institution of higher education" has the
15	meaning given such term in section 101(a) of the
16	Higher Education Act of 1965 (20 U.S.C. 1001(a)).
17	(6) NASA.—The term "NASA" means the Na-
18	tional Aeronautics and Space Administration.
19	(7) Secretary.—The term "Secretary" means
20	the Secretary of Commerce.
21	(8) Space resource.—
22	(A) IN GENERAL.—The term "space re-
23	source" means an abiotic resource in situ in
24	outer space.

1 (B) INCLUSIONS.—The term "space re-2 source" includes a raw, natural material or en-3 ergy source.
