None of these MoUs currently includes any financial payment. We have a contract with the European Space Agency relating to cycles of our Bishop Airlock on the ISS. We have performed mission management services for the European, Italian and Canadian Space Agencies as well as the IAEA and public academic institutions in the UK, Chile, and Thailand. Our previous operations in Abu Dhabi received incentive funding from the Abu Dhabi investment office, but such operations (and associated incentives) have ceased. We are happy to provide more detail on any of these items should the committee have questions.
