On Wednesday, July 24, 2019, the Committee on Veterans' Affairs will hold an oversight hearing entitled, "True Transparency? Assessing Wait Times Five Years after Phoenix." This hearing will examine how VA currently measures veterans' access to health care, both internally and in the community, what information VA makes available to veterans, and the accuracy of VA's reported wait times. We will also discuss how other health care systems monitor patients' access to care and whether opportunities exist to improve the transparency and availability of VA's wait time data, so that veterans can make informed choices about where to receive their care.
