## **3 SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Veterans' Compensa5 tion Cost-of-Living Adjustment Act of 2020".

# 1SEC. 2. INCREASE IN RATES OF DISABILITY COMPENSA-2TION AND DEPENDENCY AND INDEMNITY3COMPENSATION.

4 (a) RATE ADJUSTMENT.—Effective on December 1, 5 2020, the Secretary of Veterans Affairs shall increase, in 6 accordance with subsection (c), the dollar amounts in ef-7 fect on November 30, 2020, for the payment of disability 8 compensation and dependency and indemnity compensa-9 tion under the provisions specified in subsection (b).

10 (b) AMOUNTS TO BE INCREASED.—The dollar 11 amounts to be increased pursuant to subsection (a) are 12 the following:

13 (1) WARTIME DISABILITY COMPENSATION.—
14 Each of the dollar amounts under section 1114 of
15 title 38, United States Code.

16 (2) ADDITIONAL COMPENSATION FOR DEPEND17 ENTS.—Each of the dollar amounts under section
18 1115(1) of such title.

19 (3) CLOTHING ALLOWANCE.—The dollar
20 amount under section 1162 of such title.

(4) DEPENDENCY AND INDEMNITY COMPENSATION TO SURVIVING SPOUSE.—Each of the dollar
amounts under subsections (a) through (d) of section 1311 of such title.

(5) DEPENDENCY AND INDEMNITY COMPENSA TION TO CHILDREN.—Each of the dollar amounts
 under sections 1313(a) and 1314 of such title.

4 (c) DETERMINATION OF INCREASE.—Each dollar 5 amount described in subsection (b) shall be increased by 6 the same percentage as the percentage by which benefit 7 amounts payable under title II of the Social Security Act 8 (42 U.S.C. 401 ct seq.) are increased effective December 9 1, 2020, as a result of a determination under section 10 215(i) of such Act (42 U.S.C. 415(i)).

11 (d) SPECIAL RULE.—The Secretary of Veterans Af-12 fairs may adjust administratively, consistent with the in-13 creases made under subsection (a), the rates of disability 14 compensation payable to persons under section 10 of Pub-15 lic Law 85–857 (72 Stat. 1263) who have not received 16 compensation under chapter 11 of title 38, United States 17 Code.

## 18 SEC. 3. PUBLICATION OF ADJUSTED RATES.

19 The Secretary of Veterans Affairs shall publish in the 20 Federal Register the amounts specified in section 2(b), as 21 increased under that section, not later than the date on 22 which the matters specified in section 215(i)(2)(D) of the 23 Social Security Act (42 U.S.C. 415(i)(2)(D)) are required 24 to be published by reason of a determination made under 25 section 215(i) of such Act during fiscal year 2021.
