6 (a) IN GENERAL.—Subsection (d) of section 2 of the
7 West Los Angeles Leasing Act of 2016 (Public Law 114–
8 226; 130 Stat. 927) is amended to read as follows:

9 "(d) LAND USE REVENUES AT THE CAMPUS.—

"(1) IN GENERAL.—Any land use revenues received by the Secretary shall be credited to the applicable Department medical facilities accounts or
minor construction accounts and shall be available,
without fiscal year limitation and without further
appropriation, exclusively for any of the following:

16 "(A) Supporting construction, mainte-17 nance, and services at the Campus relating to

3	"(B) Renovating and maintaining the land
4	and facilities at the Campus.
5	"(C) Carrying out minor construction
6	projects at the Campus.

9	emergency shelter or supportive housing for
10	homeless or at-risk veterans and their families.
11	"(2) LAND USE REVENUE DEFINED.—In this
12	subsection, the term 'land use revenue' means
13	"(A) any funds received by the Secretary
14	under a lease described in subsection (b); and
15	"(B) any funds received as proceeds from
16	any assets seized or forfeited, and any restitu-
17	tion paid, in connection with any third-party
18	land use at the Campus.".
19	(b) EFFECTIVE DATE.—The amendment made by
20	subsection (a) shall apply with respect to funds received
21	by the Secretary of Veterans Affairs after the date of the
22	enactment of the West Los Angeles Leasing Act of 2016
23	(Public Law 114–226; 130 Stat. 927).

1SEC. 3. MODIFICATION TO ENHANCED USE LEASES AT THE2DEPARTMENT OF VETERANS AFFAIRS WEST3LOS ANGELES CAMPUS.

Paragraph (1) of section 2(b) of the West Los Angeles Leasing Act of 2016 (Public Law 114-226; 130 Stat.
927), is amended by adding at the end the following new
sentence: "Notwithstanding section 8162(b)(2) of such
title, the term of such an enhanced-use lease at the Campus may not exceed 99 years.".
