To make certain improvements in the laws administered by the Secretary of Veterans Affairs relating to homelessness, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Housing our Military
- 5 Veterans Effectively Act of 2023" or the "HOME Act of6 2023".

1	SEC. 2. PER DIEM PAYMENTS PROVIDED BY THE SEC-
2	RETARY OF VETERANS AFFAIRS FOR SERV-
3	ICES FURNISHED TO HOMELESS VETERANS.
4	Section 2012 of title 38, United States Code, is
5	amended—
6	(1) in subsection (a)—
7	(A) in paragraph (2)(B)—
8	(i) in clause (i)(II)(aa)(BB)—
9	(I) by striking "115 percent" and
10	inserting "133 percent"; and
11	(II) by inserting ", plus, for each
12	of fiscal years 2024 through 2028, a
13	percentage increase to such rate equal
14	to the percentage determined under
15	section 3564(a) of this title" after "of
16	that section";
17	(ii) by adding at the end the fol-
18	lowing:
19	"(iii) Subject to clause (iv), during each of fiscal
20	years 2024 through 2028, the Secretary may waive the
21	maximum rate for per diem payments under clause
22	(i)(II)(aa)(BB) or (ii) and provide such payments at a rate
23	that does not exceed 200 percent of the rate authorized
24	for State homes for domiciliary care under subsection
25	(a)(1)(A) of section 1741 of this title, as the Secretary

1	may increase from time to time under subsection (c) of
2	that section, if the Secretary—
3	"(I) determines that the grant recipient or eligi-
4	ble entity furnishes services to homeless veterans
5	in—
6	"(aa) a rural or highly rural area;
7	"(bb) an area with a high rate of suicide
8	among veterans; or
9	"(cc) an area with a high rate of homeless-
10	ness among veterans; and
11	"(II) notifies Congress of the need for such
12	waiver.
13	"(iv) The Secretary may not, pursuant to clause (iii),
14	waive the maximum rate described in such clause for more
15	than 20 percent of all grant recipients and eligible entities
16	in a fiscal year."; and
17	(B) by adding at the end the following new
18	paragraph:
19	"(4) The Secretary may not provide more than
20	10,500 payments under this section in a fiscal year."; and
21	(2) by adding at the end the following new sub-
22	section:
23	"(f) REPORTS REQUIRED.—Not later than 90 days
24	after the date of the enactment of the HOME Act of 2023,
25	and not less frequently than twice each year thereafter,

the Secretary shall submit to the Committee on Veterans' 1 2 Affairs of the Senate and the Committee on Veterans' Affairs of the House of Representatives a report on the rate 3 4 for per diem payments under this section that includes, 5 for each Veterans Integrated Service Network of the Department, the following data: 6

7 "(1) The average rate for such a payment.

8 "(2) A list of locations where the rate for such 9 a payment is within 10 percent of the maximum rate 10 for such a payment authorized under this section.

11 "(3) The average length of stay by a veteran 12 participating in a program described in section 13 2011(a) of this title.".

14 SEC. 3. TEMPORARY AUTHORIZATION FOR SECRETARY OF

15

VETERANS AFFAIRS TO USE OF CERTAIN 16 FUNDS FOR IMPROVED FLEXIBILITY IN AS-

17 SISTANCE TO HOMELESS VETERANS.

18 (a) USE OF FUNDS.—The Secretary of Veterans Af-19 fairs may use amounts appropriated or otherwise made 20 available to the Department of Veterans Affairs to carry 21 out section 2011, 2012, 2031, or 2061 of title 38, United 22 States Code, to provide to a covered veteran, as the Sec-23 retary determines necessary—

(1) food, shelter, clothing, blankets, and hy giene items required for the safety and survival of
 the veteran;

4 (2) transportation required to support the sta5 bility and health of the veteran for appointments
6 with service providers, the conduct of housing
7 searches, and the obtainment of food and supplies;
8 and

9 (3) tablets, smartphones, disposable phones,
10 and related service plans required to support the
11 stability and health of the veteran through the main12 tenance of contact with service providers, prospective
13 landlords, and family members.

14 (b) HOMELESS VETERANS ON DEPARTMENT OF VET-15 ERANS AFFAIRS LAND.—

16 (1) IN GENERAL.—The Secretary may collabo17 rate, to the extent practicable, with one or more or18 ganizations to manage the use of land of the Depart19 ment of Veterans Affairs for homeless veterans for
20 living and sleeping.

(2) FORMS OF COLLABORATION.—Collaboration
under paragraph (1) may include the provision by either the Secretary or the head of the organization
concerned of food services and security for property,

1	buildings, and other facilities owned or controlled by
2	the Department of Veterans Affairs.
3	(c) REPORT REQUIRED.—Not later than six months
4	after the date of the enactment of this Act, and every six
5	months thereafter until the date specified in subsection
6	(d), the Secretary shall submit to Congress a report that
7	includes, with respect to the period covered by such re-
8	port—
9	(1) a statement, disaggregated by each medical
10	center of the Department of Veterans Affairs, of the
11	amount of funds under this section—
12	(A) each such medical center requested
13	from the Secretary; and
14	(B) to which the Secretary provided each
15	such medical center;
16	(2) data, disaggregated by each such medical
17	center, relating to how each such medical center
18	used amounts provided by the Secretary under this
19	section;
20	(3) the number of covered veterans to which the
21	Secretary provided assistance under this section;
22	(4) the total amount of assistance the Secretary
23	provided to covered veterans pursuant to subsection
24	(a)(3) for communications equipment, broken down
25	by the type of equipment provided;

1	(5) the total amount of assistance the Secretary
2	provided covered veterans pursuant to subsection
3	(a)(2) for ridesharing;
4	(6) the number of covered veterans who re-
5	ceived such assistance; and
6	(7) a description, for each rideshare used by a
7	covered veteran with such assistance, of the reasons
8	such covered veteran used such rideshare.
9	(8) the number of covered veterans who lived or
10	slept on Department land;
11	(9) the amount of funds used to make available
12	Department land for covered veterans to live and
13	sleep;
14	(10) the number of Department employees
15	whose primary responsibilities involved providing
16	services for covered veterans living or sleeping on
17	Department land;
18	(11) the average length of time a covered vet-
19	eran lived or slept on Department land, and
20	(12) the period of time the Secretary expects
21	Department land will be made available for covered
22	veterans to live and sleep.
23	(d) SUNSET.—The authority under this section shall
24	terminate on September 30, 2024.

(e) DEFINITIONS.—In this section, the term "covered
 veteran" means—

- 3 (1) a homeless veteran; and
 - (2) a veteran participating in the program car-
- 5 ried out under section 8(0)(19) of the United States
- 6 Housing Act of 1937 (42 U.S.C. 1437f(o)(19)).
