- 16 dress Comprehensive Toxics Act of 2022 (Public Law
- 17 117-168; 38 U.S.C. 324 note) to carry out this sub-

1	(b) System or Process Requirements.—The Sec-
2	retary shall ensure that the system or process developed
3	under subsection (a) is designed to monitor, and log and
4	store data, with respect to—
5	(1) the volume of traffic to the covered website;
6	(2) the number of submissions made using a
7	covered feature;
8	(3) software updates or other modifications to
9	a covered feature or underlying interface or system;
10	(4) needs, deficiencies, or obsolescence of a cov-
11	ered feature or underlying interface or system;
12	(5) adverse events, including—
13	(A) the date and time of any such adverse
14	event;
15	(B) the number of users of the covered
16	website who were affected by the adverse event;
17	(C) the number of submissions affected by
18	the adverse event; and
19	(D) any factor related to an underlying
20	interface or system that caused or contributed
21	to the adverse event; and
22	(6) any other factors, as determined by the Sec-
23	retary.
24	(e) Notice and Report Regarding Certain Ad-
25	VERSE EVENTS.—

1	(1) NOTICE.—In the case of any significant ad-
2	verse event affecting the covered website, not later
3	than 30 days after the date of such event, the Sec-
4	retary shall submit to the Committees on Veterans'
5	Affairs of the Senate and House of Representatives
6	notice of the event, including a description of the
7	event.
8	(2) Report.—Not later than 30 days after re-
9	ceiving a request from the Chair of the Committee
10	on Veterans' Affairs of the Senate or the Chair of
11	the Committee on Veterans' Affairs of the House of
12	Representatives for a report about an adverse event,
13	including a significant adverse event, the Secretary
14	shall submit to the Committees on Veterans' Affairs
15	of the Senate and the House of Representatives a
16	report on the adverse event covered by the request.
17	Each such report shall include—
18	(A) a description of the adverse event;
19	(B) the date and time when the adverse
20	event began and ended;
21	(C) the number of users of the covered
22	website who were affected;
23	(D) the number of submissions made using
24	a covered feature that were affected; and

1	(E) a description of any underlying inter-
2	face or system that was affected.
3	(3) Sunset.—The requirements under this
4	subsection shall expire on the date that is seven
5	years after the date of the enactment of this Act.
6	(d) Report Regarding Exercise of Certain Au-
7	THORITY.—If the Secretary exercises authority under sec-
8	tion 701(a) of the Sergeant First Class Heath Robinson
9	Honoring our Promise to Address Comprehensive Toxics
10	Act of 2022 (Public Law 117–168; 38 U.S.C. 324 note)
11	to carry out subsection (a), not later than 30 days after
12	the date on which the Secretary first exercises such au-
13	thority for such purpose, the Secretary shall submit to the
14	Committees on Veterans' Affairs of the Senate and the
15	House of Representatives and the Committees on Appro-
16	priations of the Senate and the House of Representatives
17	a report about the exercise of such authority. Such report
18	shall include—
19	(1) the cost of implementing the system or
20	process developed under subsection (a);
21	(2) a description of any modernization or re-
22	placement of an underlying interface or system nec-
23	essary to implement the system or process:

1	(3) an identification of any ways in which the
2	covered website and any underlying interface or sys-
3	tem is susceptible to any adverse event; and
4	(4) a description of how the Secretary plans to
5	eliminate or mitigate, to the extent possible, any
6	such susceptibility.
7	(e) Testing Strategy.—Not later than one year
8	after the date of the enactment of this Act, the Assistant
9	Secretary for Information and Technology of the Depart-
10	ment of Veterans Affairs shall submit to the Committees
11	on Veterans' Affairs of the Senate and the House of Rep-
12	resentatives a strategy to reduce the occurrence of adverse
13	events by improving testing for each modification or soft-
14	ware update to a covered feature or underlying system or
15	interface.
16	(f) DEFINITIONS.—In this section:
17	(1) The term "adverse event" means, with re-
18	spect to the covered website, including covered fea-
19	tures—
20	(A) a failure to properly receive or process
21	a submission;
22	(B) a system outage;
23	(C) an error in an underlying interface or
24	system that prevents the transmission of data;

1	(D) a deficiency in information storage ca-
2	pacity;
3	(E) a loss of data;
4	(F) a presentation of incorrect informa-
5	tion;
6	(G) an error regarding a status notifica-
7	tion; or
8	(H) any similar event that affects a func-
9	tion of the covered website, as determined by
10	the Secretary.
11	(2) The term "covered feature" means any fea-
12	ture or function of the covered website for use in the
13	facilitation of the application, maintenance, or re-
14	ceipt of benefits under the laws administered by the
15	Secretary.
16	(3) The term "covered website" means the
17	main internet website of the Department of Veterans
18	Affairs.
19	(4) The term "significant adverse event", with
20	respect to the covered website, including covered fea-
21	tures, means an adverse event that affects users of,
22	or submissions to, the covered website for a period
23	of 24 hours or longer.
24	(5) The term "underlying interface or system"
25	means—

1	(A) any information technology system
2	that transmits data through, or accepts data
3	from, a covered feature; or
4	(B) any mechanism through which any
5	such information technology system connects
6	and interacts with the covered website.
