1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Veteran Appeals
3	Transparency Act of 2024".
4	SEC. 2. OPTIONS OF CLAIMANTS FOR BENEFITS UNDER
5	LAWS ADMINISTERED BY SECRETARY OF
6	VETERANS AFFAIRS FOLLOWING DECISION
7	BY AGENCY OF ORIGINAL JURISDICTION.
8	Section 5104C(a) of title 38, United States Code, is
9	amended—
10	(1) in paragraph (1), by striking "any of the
11	following" and inserting "one of the following"; and
12	(2) in paragraph (2)(B)—
13	(A) by striking "Nothing in this subsection
14	shall prohibit a claimant from taking" and in-
15	serting "A claimant may take";
16	(B) by striking "in succession"; and
17	(C) by striking the period and inserting
18	"if—"; and
19	(D) by adding at the end the following new
20	clauses:
21	"(i) the claimant takes one such action at a
22	time; and
23	"(ii) any such action is taken in response to,
24	and not later than one year after, the date of the
25	most recent decision on the claim made by the agen-
26	cy of original jurisdiction".

1	SEC. 3. BOARD OF VETERANS' APPEALS PUBLICATION OF
2	DATES OF DOCKET ACTIVITY.
3	Section 7107 of title 38, United States Code, is
4	amended by adding at the end the following new sub-
5	section:
6	"(f) Publication of Expected Actions.—(1) On
7	a weekly basis, for each docket, the Board shall publish,
8	on a website of the Department, notice of the docket dates
9	of the cases assigned to a Board member for a decision
10	for that week.
11	"(2) Each notice published under paragraph (1) shall
12	include a statement that an assignment described in such
13	paragraph does not require the Board to issue a decision
14	regarding the case during such week.
15	"(3) Paragraph (1) shall not apply to a case—
16	"(A) that has been advanced under subsection
17	(b); or
18	"(B) remanded by the United States Court of
19	Appeals for Veterans Claims.".
