DAV Department of California (DAV-CAL) was signatory to a Donation Agreement with the Department of Veterans Affairs (VA) signed on September 12, 2017, in which DAV-CAL agreed to receive donated funds from Breitburn Energy LP, per a separate 2017 agreement between Breitburn and VA, and DAV-CAL would use those funds to provide transportation for veterans traveling to and from the VA West Los Angeles campus for medical appointments. This agreement was ended in 2024. A copy of this agreement and an accounting of the funds received and disbursed in compliance with the agreement were previously sent to the Committee last year.




