4 (1) IN GENERAL.—The Secretary of Veterans 5 Affairs shall ensure that the director of each medical 6 facility of the Department of Veterans Affairs annu-7 ally certifies to the Secretary that the medical facil-8 ity is in full compliance with all provisions of law 9 and regulations relating to scheduling appointments 10 for veterans to receive hospital care and medical 11 services, including pursuant to Veterans Health Ad-12 ministration Directive 2010–027, or any successor 13 directive.
