A BILL

To authorize the Secretary of Veterans Affairs to furnish seasonal influenza vaccines to certain individuals, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

1	SECTION 1. AUTHORITY OF SECRETARY OF VETERANS AF-
2	FAIRS TO FURNISH SEASONAL INFLUENZA
3	VACCINES TO CERTAIN INDIVIDUALS NOT EN-
4	ROLLED IN PATIENT ENROLLMENT SYSTEM
5	OF DEPARTMENT OF VETERANS AFFAIRS.
6	(a) In General.—Section 2 of the SAVE LIVES
7	Act (Public Law 117–4; 38 U.S.C. 1701 note) is amend-
8	ed—
9	(1) by striking "a vaccine for COVID-19" each
10	place it appears and inserting "a vaccine for
11	COVID-19, a seasonal influenza vaccine, or both";
12	(2) in subsection (b)—
13	(A) in the matter preceding paragraph (1),
14	by inserting "and seasonal influenza vaccines"
15	after "vaccines for COVID-19"; and
16	(B) in paragraph (2), by inserting ", sea-
17	sonal influenza vaccines, or both" after "vac-
18	cines for COVID-19";
19	(3) in subsection (d), by striking "VACCINE AL-
20	LOCATION" in the heading and inserting "COVID-
21	19 VACCINE ALLOCATION";
22	(4) in subsection (e)—
23	(A) by redesignating paragraph (6) as
24	paragraph (7); and
25	(B) by inserting after paragraph (5) the
26	following new paragraph:

1	"(6) Seasonal influenza vaccine.—The
2	term 'seasonal influenza vaccine' means any product
3	that is—
4	"(A) approved by the Food and Drug Ad-
5	ministration;
6	"(B) commercially available; and
7	"(C) recommended by the Centers for Dis-
8	ease Control and Prevention for the prevention
9	of influenza in a particular season."; and
10	(5) in the section heading by striking "VAC-
11	CINE" and inserting "AND INFLUENZA VAC-
12	CINES".
13	(b) Funding.—No additional funds are authorized
14	to be appropriated to carry out the amendments made by
15	subsection (a), and such amendments shall be carried out
16	using amounts otherwise made available for such purpose.
