 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "VA Acquisition Review
- 5 Board Act of 2023".

1	SEC. 2. ESTABLISHMENT OF ACQUISITION REVIEW BOARD
2	IN DEPARTMENT OF VETERANS AFFAIRS.
3	(a) IN GENERAL.—Chapter 81 of title 38, United
4	States Code, is amended by inserting after subchapter VI
5	the following new subchapter:
6	"SUBCHAPTER VII—ACQUISITION REVIEW
7	BOARD
8	"§8181. Definitions
9	"In this subchapter:
10	"(1) The term 'major acquisition program'
11	means a program of the Department to acquire
12	property, assets, supplies, services, or a combination
13	thereof, with an estimated life-cycle cost of
14	\$250,000,000 or more, as determined by the Sec-
15	retary.
16	"(2) The term 'non-major acquisition program'

16 "(2) The term 'non-major acquisition program'
17 means a program of the Department to acquire
18 property, assets, supplies, services, or a combination
19 thereof, with an estimated life-cycle cost of less than
20 \$250,000,000, as determined by the Secretary.

21 "§ 8182. Acquisition Review Board

"(a) IN GENERAL.—There is established in the Department a board, to be known as the 'Acquisition Review
Board', to support the Secretary in managing acquisition
programs under the laws administered by the Secretary.

"(b) COMPOSITION.—(1) The Deputy Secretary of
 Veterans Affairs shall serve as Chair of the Acquisition
 Review Board.

4 "(2) The Deputy Secretary may designate an em5 ployee of the Department to oversee the operations of the
6 Acquisition Review Board.

7 "(3) The Deputy Secretary shall ensure participation
8 by other relevant Department officials with responsibilities
9 relating to acquisitions as permanent members of the Ac10 quisition Review Board, including the following:

11 "(A) The Chief Acquisition Officer.

12 "(B) The Chief Financial Officer.

13 "(C) The Chief Veterans Experience Officer.

14 "(D) The Chief Information Officer.

15 "(E) The Assistant Secretary for Enterprise In-16 tegration.

"(F) Other relevant senior Department officials, as the Deputy Secretary determines appropriate, including such officials from the Veterans
Health Administration, the Veterans Benefits Administration, and the National Cemetery Administration.

23 "(c) MEETINGS.—The Acquisition Review Board24 shall convene—

1	"(1) at the discretion of the Deputy Secretary;
2	and
3	((2)) not later than 45 days after any date on
4	which—
5	"(A) a major acquisition program—
6	"(i) is proposed to the Secretary;
7	"(ii) is approved by the Secretary to
8	commence;
9	"(iii) concludes an acquisition phase;
10	"(iv) is not in compliance with re-
11	quirements relating to cost, schedule, or
12	performance under the applicable program
13	baseline described in section $8183(b)(1)$ of
14	this title, as determined by the Deputy
15	Secretary; or
16	"(v) requires additional review, as de-
17	termined by the Deputy Secretary; and
18	"(B) a non-major acquisition program re-
19	quires review, as determined by the Deputy
20	Secretary.
21	"(d) Responsibilities.—The Acquisition Review
22	Board shall be responsible for—
23	"(1) with respect to a major acquisition pro-
24	gram proposed to the Secretary, determining wheth-
25	er the business strategy, budget, management, and

organization of such program is feasible and in ac-

2 cordance with the mission and strategic goals of the 3 Department; "(2) with respect to a major acquisition pro-4 5 gram approved by the Secretary to commence, deter-6 mining the appropriate acquisition category for such 7 program; "(3) with respect to a major acquisition pro-8 9 gram that has concluded an acquisition phase— 10 "(A) authorizing the manager of such pro-11 gram appointed pursuant to section 8183(a) of 12 this title to advance such program to a subse-13 quent acquisition phase if the relevant require-14 ments in such applicable program baseline have 15 been satisfied; and "(B) advising such manager on appro-16 17 priate corrective action if such requirements 18 have not been satisfied; and 19 "(4) reviewing, on a continuous basis, each 20 major acquisition program to ensure each such pro-21 gram is in compliance with— 22 "(A) the relevant requirements in such ap-23 plicable program baseline; and "(B) the certification requirement under 24 subsection (c) of such section. 25 (866326|17)

"(e) Acquisition Decision Memorandum.—Not 1 2 later than 30 days after any date on which the Deputy Secretary convenes a meeting pursuant to subsection (c), 3 4 the Deputy Secretary shall submit to the Secretary and 5 the Committees on Veterans' Affairs of the House of Representatives and the Senate an acquisition decision memo-6 7 randum that includes— 8

"(1) a summary of—

"(A) the purpose of such meeting;

10 "(B) any matter discussed during such 11 meeting;

12 "(C) any decision of the Acquisition Re-13 view Board made during such meeting, includ-14 ing any such decision to allow a major acquisi-15 tion program to deviate from the relevant re-16 quirements in such applicable program baseline; 17 and

18 "(D) any matters assigned for further dis-19 cussion during a subsequent meeting of the Ac-20 quisition Review Board; and

"(2) a certification by the Deputy Secretary 21 22 that the contents of such memorandum are accurate.

23 "§ 8183. Major acquisition program managers

24 "(a) APPOINTMENTS.—Not later than 30 days after any date on which the Secretary approves a major acquisi-25

tion program to commence, the Deputy Secretary shall ap point a manager to be responsible for administering such
 program.

4 "(b) DUTIES.—Each manager appointed pursuant to
5 subsection (a) shall be responsible for, with respect to the
6 applicable major acquisition program—

"(1) developing, in coordination with the Acquisition Review Board, a plan to administer such program, to be known as the 'program baseline', that
includes—

11 "(A) a description of each acquisition12 phase of such program;

13 "(B) for each such acquisition phase, re14 quirements for advancing such program to a
15 subsequent acquisition phase; and

16 "(C) estimates of the cost, schedule, and
17 performance of such program that account for
18 the entire life cycle of such program;

19 "(2) ensuring such program is in compliance20 with such requirements;

21 "(3) securing funding necessary to satisfy such
22 requirements;

23 "(4) adopting standardized processes with es24 tablished success to support the progress of such
25 program, including—

-
"(A) milestones;
"(B) exit criteria; and
"(C) specific accomplishments;
"(5) to the extent practicable, ensuring that
personnel of the Department responsible for esti-
mating the budget and cost of such program are
provided with an opportunity to raise concerns relat-
ing to such budget and cost prior to the establish-
ment of the program baseline under paragraph (1);
"(6) on a continuous basis, assessing and man-
aging risks to satisfying the requirements of such
program baseline relating to cost and schedule;
"(7) establishing a workforce for such program
that is qualified and sufficient to perform the nec-
essary functions of such program; and
"(8) ensuring such program has adequate tech-
nology and production capacity prior to commencing
an acquisition phase of such program related to
manufacturing, if applicable.
"(c) Consideration of Alternate Require-
MENTS.—Not later than 90 days after any date on which
a manager appointed pursuant to subsection (a) estab-
lishes a program baseline described in subsection $(b)(1)$,
such manager shall submit to the Chair of the Acquisition
Review Board a certification that such manager consid-

ered establishing alternate requirements in such program
 baseline relating to the cost, schedule, and performance
 of each acquisition phase of such program prior to estab lishing such program baseline.

5 "(d) ACQUISITION REVIEW BOARD AUTHORIZATION
6 REQUIRED.—(1) Not later than 30 days after any date
7 on which a major acquisition program concludes an acqui8 sition phase, the manager of such program appointed pur9 suant to subsection (a) shall notify the Acquisition Review
10 Board under section 8182 of this title.

"(2) Such manager may not advance such program
to a subsequent acquisition phase without the authorization of such Acquisition Review Board pursuant to subsection (d)(3) of such section.".

(b) CLERICAL AMENDMENT.—The table of sections
at the beginning of such chapter is amended by adding
