## A BILL

To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to award grants to States to improve outreach to veterans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Commitment to Vet-  
5 eran Support and Outreach Act”.

1 **SEC. 2. AUTHORITY FOR SECRETARY OF VETERANS AF-**  
2 **FAIRS TO AWARD GRANTS TO STATES TO IM-**  
3 **PROVE OUTREACH TO VETERANS.**

4 (a) IN GENERAL.—Chapter 63 of title 38, United  
5 States Code, is amended—

6 (1) by redesignating sections 6307 and 6308  
7 and sections 6308 and 6309, respectively; and

8 (2) by inserting after section 6306 the following  
9 new section 6307:

10 **“§ 6307. Grants to States to improve outreach to vet-**  
11 **erans**

12 “(a) PURPOSE.—It is the purpose of this section to  
13 provide for assistance by the Secretary to States to carry  
14 out programs that improve outreach and assistance to vet-  
15 erans and the spouses, children, and parents of veterans,  
16 to ensure that such individuals are fully informed about,  
17 and assisted in applying for, any veterans and veterans-  
18 related benefits and programs (including State veterans  
19 programs) for which they may be eligible.

20 “(b) AUTHORITY.—The Secretary may award grants  
21 to States—

22 “(1) to carry out, coordinate, improve, or other-  
23 wise enhance—

24 “(A) outreach activities; or

1           “(B) activities to assist in the development  
2           and submittal of claims for veterans and vet-  
3           erans-related benefits; or

4           “(2) to increase the number of county or tribal  
5           veterans service officers serving in the State by hir-  
6           ing new, additional such officers.

7           “(c) APPLICATION.—(1) To be eligible for a grant  
8           under this section, a State shall submit to the Secretary  
9           an application therefor at such time, in such manner, and  
10          containing such information as the Secretary may require.

11          “(2) Each application submitted under paragraph (1)  
12          shall include the following:

13           “(A) A detailed plan for the use of the grant.

14           “(B) A description of the programs through  
15           which the State will meet the outcome measures de-  
16           veloped by the Secretary under subsection (i).

17           “(C) A description of how the State will dis-  
18           tribute grant amounts equitably among counties  
19           with varying levels of urbanization.

20           “(D) A plan for how the grant will be used to  
21           meet the unique needs of American Indian or Alaska  
22           Native veterans, elderly veterans, women veterans,  
23           and veterans from other underserved communities.

24          “(d) DISTRIBUTION.—The Secretary shall seek to en-  
25          sure that grants awarded under this section are equitably

1 distributed among States with varying levels of urbaniza-  
2 tion.

3 “(e) PRIORITY.—The Secretary shall prioritize  
4 awarding grants under this section that will serve the fol-  
5 lowing areas:

6 “(1) Areas with a critical shortage of county or  
7 tribal veterans service officers.

8 “(2) Areas with high rates of—

9 “(A) suicide among veterans; or

10 “(B) referrals to the Veterans Crisis Line.

11 “(f) USE OF COUNTY OR TRIBAL VETERANS SERV-  
12 ICE OFFICERS.—A State that receives a grant under this  
13 section to carry out an activity described in subsection  
14 (b)(1) shall carry out the activity through—

15 “(1) a county or tribal veterans service officer  
16 of the State; or

17 “(2) if the State does not have a county or trib-  
18 al veterans service officer, or if the county or tribal  
19 veterans service officers of the State cover only a  
20 portion of that State, an appropriate entity of a  
21 State, local, or tribal government, or another pub-  
22 licly funded entity, as determined by the Secretary.

23 “(g) REQUIRED ACTIVITIES.—Any grant awarded  
24 under this section shall be used—

1           “(1) to expand existing programs, activities,  
2           and services;

3           “(2) to hire new, additional county or tribal vet-  
4           erans service officers; or

5           “(3) for travel and transportation to facilitate  
6           carrying out paragraph (1) or (2).

7           “(h) AUTHORIZED ACTIVITIES.—A grant under this  
8           section may be used to provide education and training, in-  
9           cluding on-the-job training, for State, county, local, and  
10          tribal government employees who provide (or when trained  
11          will provide) veterans outreach services in order for those  
12          employees to obtain accreditation in accordance with pro-  
13          cedures approved by the Secretary.

14          “(i) OUTCOME MEASURES.—(1) The Secretary shall  
15          develop and provide to each State that receives a grant  
16          under this section written guidance on the following:

17                  “(A) Outcome measures.

18                  “(B) Policies of the Department.

19          “(2) In developing outcome measures under para-  
20          graph (1), the Secretary shall consider the following goals:

21                  “(A) Increasing the use of veterans and vet-  
22                  erans-related benefits, particularly among vulnerable  
23                  populations.

24                  “(B) Increasing the number of county and trib-  
25                  al veterans service officers recognized by the Sec-

1       retary for the representation of veterans under chap-  
2       ter 59 of this title.

3       “(j) TRACKING REQUIREMENTS.—(1) With respect  
4 to each grant awarded under this section, the Secretary  
5 shall track the use of veterans and veterans-related bene-  
6 fits among the population served by the grant, including  
7 the average period of time between the date on which a  
8 veteran applies for such a benefit and the date on which  
9 the veteran receives the benefit, disaggregated by type of  
10 benefit.

11       “(2) Not less frequently than annually, the Secretary  
12 shall submit to Congress a report on the information  
13 tracked under paragraph (1).

14       “(k) PERFORMANCE REVIEW.—(1) The Secretary  
15 shall—

16               “(A) review the performance of each State that  
17 receives a grant under this section; and

18               “(B) make information regarding such perform-  
19 ance publicly available.

20       “(l) REMEDIATION PLAN.—(1) In the case of a State  
21 that receives a grant under this section and does not meet  
22 the outcome measures developed by the Secretary under  
23 subsection (i), the Secretary shall require the State to sub-  
24 mit a remediation plan under which the State shall de-

1 scribe how and when it plans to meet such outcome meas-  
2 ures.

3 “(2) The Secretary may not award a subsequent  
4 grant under this section to a State described in paragraph  
5 (1) unless the Secretary approves the remediation plan  
6 submitted by the State.

7 “(m) MAXIMUM AMOUNT.—The amount of a grant  
8 awarded under this section may not exceed 10 percent of  
9 amounts made available for grants under this section for  
10 the fiscal year in which the grant is awarded.

11 “(n) SUPPLEMENT, NOT SUPPLANT.—Any grant  
12 awarded under this section shall be used to supplement  
13 and not supplant State and local funding that is otherwise  
14 available.

15 “(o) DEFINITIONS.—In this section:

16 “(1) The term ‘county or tribal veterans service  
17 officer’ includes a local equivalent veterans service  
18 officer.

19 “(2) The term ‘Veterans Crisis Line’ means the  
20 toll-free hotline for veterans established under sec-  
21 tion 1720F(h) of this title.

22 “(p) FUNDING.—(1) Amounts for the activities of the  
23 Department under this section shall be budgeted and ap-  
24 propriated through a separate appropriation account.

1       “(2) In the budget justification materials submitted  
2 to Congress in support of the Department budget for any  
3 fiscal year (as submitted with the budget of the President  
4 under section 1105(a) of title 31), the Secretary shall in-  
5 clude a separate statement of the amount requested to be  
6 appropriated for that fiscal year for the account specified  
7 in paragraph (1).

8       “(q) AUTHORIZATION OF APPROPRIATIONS.—There  
9 is authorized to be appropriated to the Secretary for each  
10 of fiscal years 2022 through 2026, \$50,000,000 to carry  
11 out this section.”.

12       (b) CLERICAL AMENDMENT.—The table of sections  
13 at the beginning of chapter 63 of such title is amended  
14 by striking the items relating to sections 6307 and 6308  
15 and inserting the following new items:

“6307. Grants to States to improve outreach to veterans.

“6308. Outreach for eligible dependents.

“6309. Biennial report to Congress.”.
