## A BILL

To direct the Secretary of Veterans Affairs to establish a centralized portal within the Department of Veterans Affairs for the storage of information with respect to the unclaimed remains of veterans, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Locating Our Un-  
5        claimed Veterans Act”.

1 **SEC. 2. DEPARTMENT OF VETERANS AFFAIRS SYSTEM FOR**  
2 **STORAGE OF INFORMATION WITH RESPECT**  
3 **TO UNCLAIMED REMAINS OF VETERANS.**

4 (a) PROCESS FOR STORAGE AND EVALUATION OF  
5 UNCLAIMED REMAINS RECEIVED BY THE SECRETARY.—

6 (1) IN GENERAL.—The Secretary of Veterans  
7 Affairs, acting through the Under Secretary of Vet-  
8 erans Affairs for Benefits, shall establish in the De-  
9 partment of Veterans Affairs a centralized system to  
10 store information with respect to the unclaimed re-  
11 mains of veterans. Such system shall include—

12 (A) information with respect to unclaimed  
13 human remains suspected to be the remains of  
14 a veteran transmitted to the Department  
15 from—

- 16 (i) coroners;  
17 (ii) State governments; and  
18 (iii) funeral homes; and

19 (B) with respect to unclaimed remains of  
20 a veteran in the possession of the Secretary—

- 21 (i) the name of the veteran, if avail-  
22 able;  
23 (ii) fingerprints of the veteran, if  
24 available;  
25 (iii) the estimated age of the veteran  
26 at death, if determinable; and

1 (iv) such identifiers as the Secretary  
2 determines necessary to make reasonable  
3 efforts to confirm veteran status of such  
4 unclaimed remains and identify suitable  
5 next-of-kin, to the extent practicable.

6 (2) MEMORANDA OF UNDERSTANDING.—

7 (A) EXISTING MEMORANDA.—In devel-  
8 oping the system required under subsection (a),  
9 the Secretary of Veterans Affairs shall, pursu-  
10 ant to applicable memoranda of understanding  
11 with respect to data sharing in effect as of the  
12 date of the enactment of this Act, request such  
13 other information from the following Federal  
14 agencies as the Secretary determines relevant to  
15 efforts to identify unclaimed remains of vet-  
16 erans:

17 (i) The Social Security Administra-  
18 tion.

19 (ii) The Federal Bureau of Investiga-  
20 tion.

21 (iii) The Department of Defense.

22 (B) SUPPLEMENTAL MEMORANDA.—The  
23 Secretary may seek to enter into such memo-  
24 randa of understanding with the heads of Fed-  
25 eral agencies, or seek to modify the memoranda

1 of understanding described in subparagraph  
2 (A), as the Secretary determines necessary for  
3 identifying whether unclaimed remains in the  
4 possession of the Secretary are the remains of  
5 a veteran.

6 (C) CONSIDERATION.—In making a re-  
7 quest for information from the Federal Bureau  
8 of Investigation pursuant to a memorandum of  
9 understanding described in subparagraph (A)  
10 or (B), the Secretary shall consider information  
11 collected and maintained under the National  
12 Missing and Unidentified Persons System.

13 (b) TERMINATION DATE.—This section shall expire  
14 on the last day of the third fiscal year beginning after  
15 the date of the enactment of this Act.

16 (c) REPORT.—Not later than one year after the date  
17 of the enactment of this Act, and on an annual basis there-  
18 after for three years, the Secretary shall submit to the  
19 Committees on Veterans' Affairs of the House of Rep-  
20 resentatives and the Senate a report on the system re-  
21 quired under subsection (a) that includes—

22 (1) a summary of the implementation of such  
23 system;

24 (2) a description of outreach activities carried  
25 out pursuant to such implementation; and

1           (3) the total number of unclaimed remains of  
2 veterans successfully identified using such system  
3 during the period covered by the report.
