- Matthew Brown has a sad story about TBI and trying to gain access to the Selfemployment track.
- BeBe Niña and William Swanson discuss experiences where VRCs do not know VRE regulations.

Now, the VRC are the employees of VR....they know what services are provided under the "Employment through long term services" track, one of the services included is a "None paid work experience" component, therefore if the veteran was approved for the "Employment through long term services" track, he/she should remain in the track until all features of that track has been exhausted or he/she becomes gainfully employed. That's my current situation....I've given my VRC 6 months of job logs, in the section of the job logs that says "Status" the response is "lack of experience," so my VRC has six months of job logs that highlights my job barrier and have not made an effort to enroll me in the "None Paid Work Experienc" component of the "Employment through long term services" track. That's

inefficient use of Federal resources and should be evaluated and corrected so the VRC don't have any choice but go through the most logical path....From School/Degree to Work Experience then to the Work Force, is the logical path. Currently, computer science degrees are the only option, but those are far more expensive, take much longer, and are much less effective at getting veterans employment. I WOULD LOVE to see something like that set up. It would make for much kinder conversations if people knew we could report them and get them a smack on the hand. Like I.C.E reports. Also not being able to be turned away. I went 16 days without epilepsy medicine and broke down and had to call the crisis line and almost 911 to get help with my medication. Proof doesn't mean squat if the doctor turns you away. Also a system or something for caregiver status. They told me I need combat injuries to get my wife a caregiver class and get her a stipend as I need her daily. If I need a caregiver how my injuries occurred does not and should not dictate that I need a caregiver. My situation should. Also a better system to keep up with compensation trials. More in depth like how M.E.B does it would be amazing. That's about it. Hope I didn't talk too much and hope our voices are heard.

Dominic Davila I've been blown up lost a limb and the VA refuses to believe I have a TBI from it because I wasn't unconscious, so I have a 0 rating for that. I also was lowered from 50% PTSD rating to 30% after them reevaluating me for maybe 30 min. Which has dropped \$1000 from my monthly checks. My calls to anyone in the VA system go unanswered pretty much daily. They give me appointments for dates that I can't make and when I miss or try and reschedule I get talked down too. My last voc rehab rep was so terrible that every time I registered for class early they payments would never get to the school on time and I would get dropped from my classes

and have to re register and my schedule would be all over the place. It took 2 years and 5 times of submitting the SAME paperwork to get my refund for the car and clothing allowances they give every year. I have had mental health appointments canceled on me without any warning and found out when I showed up for the appointments. When I go to check in for appointments the receptionist is usually on a personal call and has me wait while they talk about who knows what, then have an attitude with me! To get prosthetics it is usually a month or so wait just to get an appointment that I don't get to schedule the date and then it's another 3-5 months from there to get a prosthetic. I have plenty more issues with the VA I can share but I don't have all day June 21 at $8:53am \cdot Like$

Jean Telfort VR&E counselors do not know how to communicate with Veterans (despite the fact that many claim to have been service members themselves). I had a terrible experience with Christopher Holder that was witnessed by the gentleman in charge there in NYC during which Mr. Holder yelled and swore at me "...I don't give a fuck about what you think..." which prompted a reassignment.
