

**AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 3981
OFFERED BY MR Van Orden**

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “Isakson-Roe Education
3 Oversight Expansion Act”.

**4 SEC. 2. EXPANSION OF DEPARTMENT OF VETERANS AF-
5 FAIRS OVERSIGHT OF CERTAIN EDU-
6 CATIONAL INSTITUTIONS.**

7 (a) ADDITIONAL REQUIREMENT FOR APPROVAL.—
8 Section 3675(b) of title 38, United States Code, is amend-
9 ed by adding at the end the following new paragraph:

10 “(5) The educational institution agrees to, not
11 later than 30 days after any date on which such
12 educational institution becomes subject to an action
13 or event described in section 3673(e)(3) of this title,
14 submit to the State approving agency, or the Sec-
15 retary when acting in the role of a State approving
16 agency, a notification of such action or event in such
17 form and containing such information as the Sec-
18 retary determines appropriate.”.

1 (b) ADDITIONAL REQUIREMENT FOR APPROVAL OF
2 NONACCREDITED COURSES.—

3 (1) IN GENERAL.—Section 3676(c) of such title
4 is amended—

5 (A) by redesignating paragraphs (14)
6 through (16) as paragraphs (15) through (17),
7 respectively; and

8 (B) by inserting after paragraph (13) the
9 following new paragraph:

10 “(14) The institution agrees to, not later than
11 30 days after any date on which such institution be-
12 comes subject to an action or event described in sec-
13 tion 3673(e)(3) of this title, submit to the State ap-
14 proving agency, or the Secretary when acting in the
15 role of a State approving agency, a notification of
16 such action or event in such form and containing
17 such information as the Secretary determines appro-
18 priate.”.

19 (2) CONFORMING AMENDMENTS.—Such title is
20 further amended—

21 (A) in section 3672(b)(2)(C), by striking
22 “paragraph (14) or (15)” and inserting “para-
23 graph (15) or (16)”;

1 (B) in section 3675(b)(3), by striking
2 “(14), (15), and (16)” and inserting “(15),
3 (16), and (17)”;

4 (C) in section 3679(d), by striking “de-
5 scribed in paragraph (14) or (15)” and insert-
6 ing “described in paragraph (15) or (16)”;

7 (D) in section 3680A(a)(4)(C)(iii), by
8 striking “section 3676(c)(14) and (15)” and in-
9 serting “section 3676(c)(15) and (16)”.

10 (c) ADDITIONAL GROUNDS FOR SUSPENSION OF AP-
11 PROVAL.—Section 3679(f)(1) of such title is amended by
12 adding at the end the following new subparagraph:

13 “(J) Comply with the notification requirements
14 under sections 3675(b)(5) and 3676(c)(14) of this
15 title, when applicable.”.

16 (d) DEADLINE FOR RISK-BASED SURVEYS DATA-
17 BASE.—The Secretary of Veterans Affairs shall establish
18 the database required under section 3673A(c) of title 38,
19 United States Code, by not later than 180 days after the
20 date of the enactment of this Act.
