

AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 1527
OFFERED BY MR. VAN ORDEN OF WISCONSIN

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “Reforming Education
3 for Veterans Act”.

4 SEC. 2. ABSENCE FROM CERTAIN EDUCATION DUE TO CER-
5 TAIN SERVICE.

6 (a) OPTIONS.—Section 3691A of title 38, United
7 States Code, is amended by striking paragraph (1) of sub-
8 section (a) and inserting the following:

9 “(1) A covered member may, after receiving orders
10 to enter a period of covered service—

11 “(A) withdraw from covered education;

12 “(B) take a leave of absence from covered edu-
13 cation; or

14 “(C) subject to subsection (d), enter into an
15 agreement with the institution concerned to complete
16 a course of covered education to the satisfaction of
17 such institution concerned.”.

1 (b) CONFORMING AMENDMENT.—Such subsection is
2 further amended, in paragraph (2)(A), by striking “or
3 takes a leave of absence” and inserting “, takes a leave
4 of absence, or enters into an agreement”.

5 (c) AGREEMENT.—Such section is further amended
6 by—

7 (1) redesignating subsection (d) as subsection
8 (e); and

9 (2) by inserting, after subsection (c), the fol-
10 lowing new subsection (d):

11 “(d) AGREEMENT WITH INSTITUTION CON-
12 CERNED.—A covered member may enter into an agree-
13 ment under subsection (a) only if the covered member has
14 completed at least half of a course of covered education.”.

15 (d) SECTION HEADING.—Such section is further
16 amended by striking the heading and inserting “**Ab-**
17 **sence from certain education due to certain**
18 **service**”.

19 (e) TABLE OF SECTIONS.—The table of sections at
20 the beginning of chapter 36 of such title is amended by
21 striking the item relating to section 3691A and inserting
22 the following new item:

“3691A. Absence from certain education due to certain service.”.

1 **SEC. 3. DEPARTMENT OF VETERANS AFFAIRS COMPLIANCE**
2 **SURVEYS.**

3 Section 3693 of title 38, United States Code, is
4 amended—

5 (1) in subsection (c)—

6 (A) by striking “not more than 10 busi-
7 ness days of notice”;

8 (B) by striking “this section.” and insert-
9 ing “this section—”; and

10 (C) by adding at the end the following new
11 paragraphs:

12 “(1) in the case of an educational institution or
13 training establishment with a time stamp database
14 collection feature, not fewer than 10, and not more
15 than 15, business days of notice; and

16 “(2) in the case of any other educational insti-
17 tution or training establishment, not more than 10
18 business days of notice.”; and

19 (2) by striking subsection (d) and inserting the
20 following new subsection (d):

21 “(d) DEFINITIONS.—In this section:

22 “(1) The terms ‘educational institution’ and
23 ‘training establishment’ have the meanings given
24 such terms in section 3452 of this title.

25 “(2) The term ‘school certifying official’ means
26 an employee of an educational institution with pri-

1 mary responsibility for certifying veteran enrollment
2 at the educational institution.”.

3 **SEC. 4. NOTIFICATION OF SCHOOL CERTIFYING OFFICIALS**
4 **OF HANDBOOK UPDATES.**

5 (a) IN GENERAL.—Not later than 14 business days
6 after updating the school certifying official handbook of
7 the Department of Veterans Affairs, the Secretary of Vet-
8 erans Affairs shall provide notice to all school certifying
9 officials of such update.

10 (b) SCHOOL CERTIFYING OFFICIAL DEFINED.—The
11 term “school certifying official” means an employee of an
12 educational institution with primary responsibility for cer-
13 tifying veteran enrollment at the educational institution.
