#### MAJOR ADMINISTRATIVE ACCOMPLISHMENTS

2016 through 2019 Developed and deployed the Community Care Operating Model based on 5 major principles: clear roles and responsibilities, consistent processes, active partnerships, standardized care coordination, and responsive customer service. This model transformed the way in which 170 VA Medical Centers identified eligible Veterans for community care, offered that care, ordered and authorized the care, coordinated the care and completed the episode of care all the way through the administrative claims payment.

2017 to 2022 Led the national identification and rollout of the Referral Document (RefDoc) tool that was locally developed at the Atlanta VA. The tool helped all 170 local community care offices compile medical documentation in a standardized way to send to outside saving the staff hours per day.

2017 to 2022 Led the development of the Community Care components of the Consult Toolbox (CTB), its national deployment and roll out of the subsequent versions. CTB is an information technology tool within the VA's existing health record that places standard text and codes on consults allowing for local workflow management and allows VA to track the timeliness of care delivery nationwide.

2018 Designed the configuration of VA's national referral and authorization system; HealthShare Referral Manager (HSRM), to meet all of the multiple business needs of the community care program while also developing the rollout plan commensurate with the 5 regional deployments of the Community Care Clinical Network (CCN) contract. The CCN contract provides access to clinical services

throughout the country which includes approximately 1 million community providers that Veterans have access to when care is needed and authorized.

Designed the method that allows VA's Office of Community Care to identify a clinical request for care (a consult) to be provided in the community under the Veteran Community Care Program (VCCP) and track that request through the eligibility, referral and authorization and claims payment processes by developing a unique ID number that is used and tracked in multiple Information Technology (IT) systems. VA is now able to determine the exact cost of every request for care and its entire episode when provided within the VA Community Care Program. This allows for more accurate budgeting and planning.

2017 – 2019 Designed and developed the new Community Care Program under the MISSION Act of 2018 which includes over 15 specific work flows regarding eligibility for community care determinations, the creation of specific consult requests for care, referrals and authorizations, the creation of the database for Standardized Episodes of Care (SEOCs) that define the exact care and their respective CPT/HPCPS codes that are authorized, the identification of specific providers within the VA's community network and how that information gets passed on to the key stakeholders. These stakeholders include the providers in the community, third-party administrators with whom VA has contracts, our reimbursement systems, and our claims processing systems. This work has enabled over 3 million Veterans to be referred to the community for care.

Designed, developed, and deployed the Decision Support Tool (DST); an IT tool used by VA providers and staff to systematically and consistently determine MISSION Act eligibility (there are six different criteria) for community care. This allows staff to visualize and document community care eligibility of veterans, their choice to opt in or out of the community care program and report the outcomes to VHA leadership and Congress. The MISSION Act went live on June 6, 2019 and the DST was used greater than 60,000 times on day 1.

2018-2020 Supported the October 2020 go live of VA's Initial Operating Capability (IOC) of the Cerner Millennium Electronic Health Record (EHR) platform by designing the work flows, processes, system connections as well as the reporting and metrics needed for the community care program to be executed using the new platform. This new EHR is designed to create efficiencies for staff and enhance interoperability with external stakeholders notably the Department of Defense (DoD). Ongoing work is being performed to enhance the capabilities of the Cerner Platform to support the dynamic nature of the community care program.

2019-2021 Designed and led the national deployment of VA Online Scheduling (VAOS) for community care allowing community care eligible veterans (the system automatically checks community care eligibility in the background) to request 5 simple services including initial primary care visit, routine optometry, routine audiology, nutrition and podiatry. VAOS allows Veterans to identify their preferred provider in the community care network triggering the local VA medical centers to immediately make appointments with those community providers informing the veterans of those appointments through online communication. Conceived of in 2018 and fully deployed in all VA Medical Centers (VAMCs) by April 2021. VAOS is modernizing and streamlining the empowerment of veterans scheduling community care appointments.

Designed, developed, and deployed a methodology for identifying, capturing, and writing into the VA electronic medical record when veterans receive vaccines in the community. The capturing administration of vaccine encounters (CAVE) project focused the initial capability on flu vaccination in preparation for the inevitable development and deployment of COVID-19 vaccines. Conceived of in June 2020 and deployed in September 2020, within the first two months over 130,000 flu vaccines administered in the community were identified and posted to the electronic medical record. This new capability gives VA providers a more comprehensive view of a Veteran's medical history inside the VA and in the community.

Designed, developed, and deployed the Community Care Clinical Coordination Contact Center (C6) which was designed to be a learning laboratory run by VA Central Office of Community Care provides direct care coordination services for a population of veterans who are MISSION Act eligible to receive all of their care in the community and are receiving primary care in the community. This initiative supported the first VA site to use Cerner Millennium in Spokane, Washington by reducing their workload while learning a new EHR. C6 is helping to mitigate productivity challenges there while enhancing care coordination efficiencies. C6 now manages approximately 67 percent of Spokane's C6 eligible veterans or 2000 Veterans and is planned to care for approximately 35,000 veterans nationwide over the next 2 fiscal years

Designed and initiated a project that automates the requesting of prior authorization approvals by community providers caring for Veterans through the Veteran Community Care Program. Providers will log into a VA portal, provide the key information including medical documentation of need while the system automatically checks prior authorization criteria and if approved, immediately delivers the provider an authorization number. That number will be used to bill VA Third Party Administrator (TPA) partners who pay the providers by contract and then bill VA. With the approved number available, VA will contact the Veteran's outside insurers and request prior authorization from them as VA will have already approved it from a VA perspective. This will allow VA to bill the outside insurance companies for those services VA and the Veteran's insurer approved and collect nearly 25 million dollars currently being uncollected. This additional revenue will support the local budgets of VAMCs to improve local care of Veterans.
