Mr. PASCRELL (for himself and Mr. CROWLEY) submitted the following resolution; which was referred to the Committee on Ways and Means

RESOLUTION

Of inquiry directing the Secretary of the Treasury to provide to the House of Representatives the tax return information of President Donald J. Trump as well as the tax returns of each business entity disclosed by Donald J. Trump on his Office of Government Ethics Form 278e.

1 *Resolved*, That the Secretary of the Treasury is di-
2 rected to furnish to the House of Representatives, not
3 later than 14 days after the adoption of this resolution,
4 the full tax returns of Donald J. Trump for tax years
5 2006 through 2016, if available, as well as the tax returns
6 for such taxable years of each business entity disclosed
7 by Donald J. Trump on his Office of Government Ethics

1 Form 278e, specifically each business entity specified in
2 section 2 of this resolution; and any supplemental infor-
3 mation in the possession of the President relating to—

4 (1) the amount of taxes paid by Mr. Trump
5 and each such business entity with respect to such
6 taxable years;

7 (2) the debts of Mr. Trump and such business
8 entities which are held by foreign governments or
9 foreign companies;

10 (3) the investments of Mr. Trump and such
11 business entities which are in foreign countries or
12 foreign enterprises;

13 (4) Mr. Trump's personal and business profits
14 received from foreign enterprises;

15 (5) the amount of charitable giving claimed by
16 Mr. Trump with respect to such taxable years; and

17 (6) any use of tax shelters or other loopholes to
18 reduce the amount of taxes owed.
